NOTIFICATION

No. G.11013/6/95-FIN(PRU), the 17th April, 2001. The applicability or otherwise of FR 23 read with FR 22(1)(a)(ii) for fixing the pay in respect of Under-Matriculate trained Teachers of Primary Schools who have rendered eighteen(18) years of regular continuous service as on 1.1.1986 has since been under active consideration of the Govt. of Mizoram. The Governor of Mizoram is pleased to decide that the pay of such teachers shall be fixed as under :—

- (i) On 1.1.1986 the pay of above mentioned category of teachers shall be fixed in the Revised scale of pay of Rs. 1400-2600/- under the Central Civil Service (Revised Pay) Rules, 1986. Thereafter their pay should be fixed on the same date in the Selection Grade scale of pay, i.e 1640-2900/- with reference to their pay, in the scale of Rs.1400-2600/- under the provisions of FR 22(1)(a)(ii) since promotion of teachers from lower to a higher grade does not involve assumption of duties and responsibilities of greater importance.
- (ii) Pay of Under-Matriculate Trained teachers promoted from a lower to a higher grade after 1.1.1986 should also be fixed as at (i) above
- (iii) Refixation of pay in respect of above mentioned category of teachers (Primary School) as above shall not bestow any financial benefit in the shape of arrears of pay and allowances as re-fixation shall be done on notional basis only.
