Subject: Reservation of posts for persons with disabilities.

In supercession of this Department's O.M. of even No. dt. 27.1.1998 on the subject cited above, the Government has decided that in line with the provisions of Section 33 of the Persons With Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, 3% of all vacancies in Group 'C' and 'D' posts would be kept reserved for the category of persons with disabilities as there is no reservation for the disabled persons in Group 'A' and 'B' posts as per Government of India's O.M. except certain amount of preferences for them.

The above reservation may not, however, be applicable to the recruitment of executive staff of Excise, Police and Forest Department as nature of these posts may not be suitable for disabled persons.

Now, therefore, in exercise of the powers conferred by Section 7 (4)(b) of the Central Sales Tax Act, 1956, the certificate of registration granted to said dealer is hereby cancelled with effect from the date of issue of this Notification.
