No B.12015/136/90-RCOOP/Pt, the 7th June, 2002. Whereas Cancellation order of the Vaisam Vawkvulh Coop. Society Ltd. registration No.L-172/89-90 of dt. 21.6.1990 was issued vide this Office order conveyed under No.B. 12015/136/90-RCOOP/73 of dt.13.11.1998 as the result of Inspection U/S 66 touching the business, working, management and financial condition of the society.

Whereas an appeal submitted by Pu J.Rammawia, newly elected Chairman on behalf of the society for its revitilization by revoking the cancellation order due to non-receipt of the order in time on the pretext of bad communication in such remoted rural area is found reasonable for consideration.

I, Smt. L.Tochhong, IAS, Registrar of Cooperative Societies, Mizoram as per powers conferred in me by section 85 of the Mizoram Cooperative Soceities Act, 1991, therefore, do hereby revoked the cancellation order for its revitalisation for the interest of the Cooperative Movement and upliftment of the members.

In pursuance of this revocation order, the ARCS, Lunglei has to submit Revitalization scheme of the society within 60 sixty days of issue of this order for consideration as required by the sub-rule (13) Rules 108 of the Mizoram Cooperative Societies Rules, 1996.
