Whereas aggrieved persons namely Pute P.C. Hmarthuama and Vanlalnghaka who stood at S1 No. 7 & 8 respectively in the inter se-seniority list of Assistant Divisional Accounts approached the Hon'ble Gauhati High Court Aizawl Bench praying for setting aside the aforesaid promotions and further praying for their own promotion w. e. f. 11. 8. 2000 and for protection of their respective position in the inter-se-seniority of Assistant Divisional Accounts and the right application of prescribed procedure to be observed by Departmental Promotion Committee vide O.M. issued under No. A. 32012/1/81-APT(B)/Loose dt. 3. 9. 1998;

Whereas the Hon'ble Gauhati High Court Aizawl Bench was pleased to admit the writ petition and registered it as WP(C) No. 123 of 2000;

Whereas the Hon'ble Gauhati High Court Aizawl Bench after hearing all the parties held that as per para 3.5(i) of the said prescribed procedure the bench mark prescribed for promotion of Assistant Divisional Accountant to Divisional Accountant would be 'Good' and all Officers whose overall grading is equal to or better than the Bench mark should be included in the panel for promotion to the extent of the number of vacancies; that they should be arranged in the order of their inter-se seniority in the lower Category without reference to the overall grading obtained by each of them which imply that all those candidates who obtained the bench mark of 'Good' should be arranged according to their inter-se seniority without reference to their overall grading; and further held that the Mizoram Public Service Commission had no power to introduce a new method of selection other than what was prescribed in the Office Memorandum;

Whereas the Hon'ble High Court directed that the petitioners should be given promotion from the date Pute Lalduhawma and Lalmuansanga Hnamte were promoted and should be entitled to all the benefits in accordance with the rules. The Hon'ble High Court, however, hinted that the services of the respondents No. 5 and 6 might be retained by the State Government according to their wisdom and their seniority shall be in accordance with the inter se seniority list;

Whereas the State Government felt that retention of the services of Pute Lalduhawma and Lalmuansanga Hnamte would not be proper in the light of the judgement and order passed by the Hon'ble Gauhati High Court since there are 7 (seven) Assistant Divisional Accountants senior to them who were all graded 'Good':

Whereas there is no sufficient number of vacancies of Divisional Accountants for promoting all the incumbents of Assistant Divisional Accountant from S1. No. 7 to 15 of inter-se-seniority list so as to retain them in service as Divisional Accountant;

And whereas the State Government is duly bound to comply with the judgement and order of the Hon'ble Gauhati High Court in the interest of justice;

Now, therefore, the Governor of Mizoram is pleased to revert Pu Lalduhawma, Divisional Accountant and Pu Lalmuansanga Hnamte, Divisional Accountant to the posts as Assistant Divisional Accountant in the scale of pay of Rs 5500-175-9000/-p.m. with effect from the date of their relinguishing the respective charges.

On their reversion to Assitant Divisional Accountant, they are directed to report to Director, Accounts & Treasuries for their posting.

They are directed to hand over charge to respective senior most Assistant Divisional Accountants immediately.

The Governor is further pleased to order that pay and allowances already drawn by them against the posts reverted from shall not be re-imbursed by them.
