The above powers are delegated subject to the following conditions :-

- a) For any work exceeding Rs.6.00 lakhs and above and upto Rs.20.00 lakhs, the technical estimates should be scrutinised and countersigned by Chief Engineer.
- b) Prior concurrence of Finance Department shall have to be obtained in respect of each work prior to execution.
- c) Splitting of estimates to bring the amounts within the ceiling limit is not permissible and should be avoided.
- *d) Provision of Rules 141 & 142 of General Financial Rules, 1963 and all other codal formalities should be observed.
- e) Deviation from the delegation of powers without concurrence of Finance Department will entail rejection of the bills in the Treasuries.
