OFFICE MEMORUNDUM No. A. 32012/2/2002-EDN/Pt, the 23rd Marh, 2004. The issue as to whether M.Ed. degree should be treated at par with & equivalent to M.A., M.Sc., M.Com degree for the purpose of recruiting the and promotion to teaching and executive possion the School Education Department has been under conside-ration of the Government for quite some time. So far M. Ed. degree has not been accepted/treated equivalent to M.A. etc. degree on the plea that M.Ed. is a cite sear Course dilly ublike M.A. etc. course. As a result, M.Ed. degree is excluded from the Recruitment Rules where M.A. etc. degree is prescribed as essential educational qualifications for recruitment & promotion to teaching and executive posts in the School Education Department.

On careful consideration of the pros and cons pertaining to the content and duration of the M. Ed. course, it is considered necessary to have a fresh look into the whole issue. A university graduate at present has to obtain a one year B.Ed. degree before he becomes eligible for admission to a one year M.Ed. course. It, therefore, becomes evident that like M.A. etc. degree, it takes two years after university graduation to obtain M. Ed. degree. Secondly, the University Grants Commission has recognized and accepted M.Ed. degree for appointment and promotion to teaching facilities in colleges and universities. An M.Ed. degree holder like M.A. etc. degree holder is eligible for M.Phil & Ph.D. studies. Thirdly, the M.Ed. studies concentrate mostly on the subjects pertaining to education only unlike M.A. course etc. It, therefore, becomes all the more necessary and apt to treat M.I.d degree equivalent to M.A. etc. degree in all respects and for all purposes at least in the matter of recruitment and promotion in the School Education Department.

After taking all these factors into consideration, it has been decided that henceforth M.Ed. degree shall be treated and accepted at par with and equivalent to M.A., M.Sc., M,Com. degree for all intent and purposes and in all respects in the School Education Department, Government of Mizoram.
