- (c) PLANNING CELL : Subject to approval of concerned Departments, Planning Cell, to be headed by Rural Planning Officer, may be created in the Directorate of R.D.

#### 2. DISTRICT RURAL DEVELOPMENT AGENCIES :

Without prejudice to the powers and functions vested in the Central Guidelines, the DRDAs will function under the administrative control of the Directorate of R.D, Budgetary control on state-matching share and re-allocation of funds to DRDAs, compilation of reports, proposals, etc, hitherto done by the office of SLMC & IAC, will also be transferred to the Directorate.

#### 3. STATE-LEVEL MONITORING CELL AND INTERNAL AUDIT CELL:

Subject to approval of the concerned Departments and Council of Ministers, the office of SLMC & IAC will function as part of Secretariat for internal audit, monitoring, supervision and evaluation of works implemented under R.D Department. Till such time, the office of SLMC & IAC will function as non-Secretariat Office (NSO) and a single file system will be introduced at the appropriate level. The minimum requirement of staff will be worked out and the surplus staff if any, will be attached/transferred to the Directorate.

### 4. STATE INSTITUTE OF RURAL DEVELOPMENT (SIRD):

Without prejudice to the powers and functions vested in its Memorandum of Association and Rules & Regulations, the budgetary control of SIRD, hitherto done by the SLMC & IAC, will be brought under the Control of the Direc-

The administrative control of this state-level Institution will remain with torate. the Government, as at present. In matters of imparting of training and rela-ted matters, the Institute will maintain close liaison with the Directorate of Rural Development.

#### **MONITORING CELL BADP:** 5.

The Monitoring Cell of BADP may be transferred to the Directorate of RD and will be looked after by the Joint Director (Admn). For administrative convenience the cell will be declared as a Non-Secretariat Office (NSO) and single file system introduced at the appropriate level. Directorate R. D will assign the functions to be performed by this Cell, but this function will not in any way supplant, replace or supercede the role and functions of the SLMC&IAC at the Secretariat level. Further, subject to approval of DP & AR, the Director, RD & Joint Director, R.D may be allowed to function as ex-officio Joint Secretary and Deputy Secretary for the implementation of BADP.

The Rural Development Department, Government of Mizoram, reserves the power to review and revise the provisions contained in this Notification from time to time.

- v) No proposal for grant of incentive for acquiring higher/fresh qualification should be submitted to Finance Department unless the employees to whom the incentive is proposed to be granted fulfil(s) the eligibility criteria mentioned in sub-para(i) and (ii) above.
