With reference to your proposal vide letter no. 'quoted above, I am directed to convey sanction of the Government of Mizoram to the creation of the following 150 temporary posts of various categories for setting up of 6(six) new

Telescopic DIETs (District Institute of Education and Training/ DRCs (District Resource Centres) in the Districts of Champhai, Lawngtlai, Kolasib, Serchhip, Saiha and Mamit under the Centrally Sponsored Scheme of Restructuring and Reorganisation of Teacher Education with the condition that the incumbents recruited against each post will be on temporary basis for a period of 3(three) years or till validity of the project and that the appointment orders should clearly indicate this condition since it may not be possible for the state Government to take over the liabilities when the funding is discontinued by the Central Government.
