Whereas the existing president of SuIZaw W' Village Council has given a written representation for disqualification of two Village Council members, namely 1) Pu. Sanlianma wia VCM (Elected) and 2), Pu Rualkhupthanga VCM (nominated) being failure of attending five consecutive Village Council meetings neither had reported the causes of their absence from the meetings to the VCP.

To this effect, the Executive Committee of Chakma Autonomous District Council had conducted an inquiry and found that the above two Village Council members failed to discharge their duties and responsibilities as a member of the said Village Council by intentionally avoiding five important Village Council meetings called upon by the VCP. This had hampared in taking important decession relating to the Village Council Administration, developmental programmes and other matters related to the Village. Further, the above Village Council members often failed to carry out direction/orders/notification of the authorities.

As such, clearly indicates the violation of Rule 5 and Sub-rule 4 of Rule 17 of Chakma Autonomous District Council (Village Councils) Act, 2003 and resulting disqualification from membership for being member of the Village Council.

Therefore, in exercise of power conferred under Rule 5 of chapter-II of Chakma Autonomous District Council (Village Councils) Aci,2003, the Executive Committee of Chakma Autonomous District Council is pleased to disquality Pu. Sanlianmawia VCM(Eleceted) and Pu. Rualkhupthanga VCM(Nominated) from n.embership of the Saizaw 'W' Village Council with effect from 23rd June'04. Further, as provided by the above said Rule, the Executive Committee of Chakma Autonomous District Council is pleased to declare the above two seats as vacant till further order.
