The undersigned is directed to refer to Para XXXI of Scheduled 'A' to Government Notification No. 12011/3/87-F.Est. dated 19.12.1988 which laid down procedure for fixation of initial pay for employees holding posts specified in the notification, the pay scales of which are revised.

The procedure have been reviewed and the Governor of Mizoram, in exercise of the powers conferred under proviso to Article 309 of the Constitution of India, is pleased to amend the said para and it has now been decided that the initial pay of employees shall be fixed in the revised pay scales with reference to pay scales of 1973 as laid down in the Government of India's Notification No. F. 15(1) IC/86 dated 13.9.1986 in statement prescribed and incorporated at pages 44-45 of the Central Civil Service (Revised Pay) Rules, 1986. However, no Government employees shall be eligible for payment of arrear or no employees shall be liable to recovery on account of fixation of pay in the revised pay scales during the period from 1.1.1986 to 31.12.1988. Increments will be regulated as laid down by the Central Service (Revised Pay) Rules, 1986 notionally and the pay thus arrived at will be drawn from 1.1.1986 onwards.

- 1) The initial pay statement shall replace the earlier initial pay statement 1986. Two copies of the new initial pay statements Accounts & Treasuries with service books for scrutiny and approval.
- 2) Though there are changes in classification of posts in respect the employees, the duties and responsibilities attached to the posts remain the same. Therefore the benefit as a result of change in status laid down in Government of India, Ministry of Finance O.M. No. 1(40)-E. In the earlier pay scale of Rs. 1400-2300/- the initial pay of the employees was fixed on 1.1.1986 at Rs. 1720/- which was the stage next above in the scale. No.A.12018/1/93-DWCRA(RD), the 8th November, 2004. The service condition of 3 (three) Assistant Project Officers (Women Development), 20 (twenty) Mukhiya Sevikas and 16 (sixteen) Gram Sevikas appointed under the DWCRA sponsored under CSS (UNICEF) has engaged the attention of the Government for quite some time. As per terms of appointment the duration was for 5 years or till discontinuation of DWCRA scheme, unless otherwise decided by the Central Govt. The Central Govt. decided subsequently that the salary of the employees would be borne by the State Govt. since UNICEF has withdrawn its assistance for DWCRA programme wef 1.4.1996. In pursuance, the State Govt also formally created posts under the State normal fund and the employees have been in receipt of their salary from the State fund wef 1.4.1996 till date.

In view of the above position, the Governor of Mizoram is pleased to declare that all the employees listed in the Annexure are deemed to be regular State Govt employees wef 1.4.1996. Services rendered by the employees under the DWCRA programme prior to the date of 1.4.1996 also will be treated as qualifying services for all purposes provided that there is no gap or interruption during the period.

Henceforth, it is further decided the services of APO(WD) rendered under Rural Development Department will however be treated as separate cadre independently from other Services. And the services of Mukhiya Sevika & Gram Sevika under Rural Development Department will be amalgamated and treated as common cadre with the existing Gram Sevika already appointed against the regular sanctioned posts under (erstwhile C.D) Rural Development Department.
