In exercise of the powers conferred by section 18 of the Mizoram Value Added Tax Act, 2005 (Act No. 1 of 2005), the Governor of Mizoram is pleased to allow payment of presumptive tax by registered retail dealers including those engaging in works contract whose gross turnover of sales or contractual transfer price do not exceed Rs 10 lakhs in a year at the rate of 1 per centum of their annual taxable turnover of sales during a tax period subject to the condition that:

- a) the burden of proving that the gross turnover of sales during the year is within the specified limit shall be on the dealer.
- b) no input tax credit shall be available to such dealers.
- c) the dealer paying presumptive tax shall pay the tax based on his returns of turnover of sales in Form 5 quarterly as prescribed in rule.
- d) the payment of presumptive tax shall not apply to a Registered Dealer who imports goods from outside the State for the purpose of carrying out of his business.
- e) no dealer who is paying presumptive tax shall collect any sum by way of tax on the sale of goods during the period to which such payment relates.
- f) nothing in schedule-III shall apply in the case of those person engaged in works contract paying presumptive tax.

Further, a registered retail dealer may, by exercising option, elect to pay tax as specified under section 8 of the Act in lieu of payment of presumptive tax.
