OFFICE MEMORANDUM

With the enforcement of the Mizoram Juvenile Justice (Care and Protection of Children) Rules, 2003 with effect from 1.8.2003, some doubt has arisen about the legal status of a child adopted prior to 1.8.2003 which may affect or deprive of pensionary benefits and other legal status to a child from adoptive parents. It may even be considered adoption taken place prior to 1.8.03 to the extent of illegal adoption. The matter has been examined in the Law & Judicial Department at length. It is clarified that "all in-country and inter-country adoption take place or taking place on or after 1st August, 2003 have to conform to statutory formalities prescribed in the Juvenile Justice (Care and Protections of Children) Rules, 2003, while all such adoptions prior to 1st August, 2003 also have to conform to the guidelines framed by the Hon'ble Supreme Court in Lakshmikant Pandey's case".

Whereas a result of Inspection Under Section 66 of the Mizoram Cooperative Societies Act of 1991 into the compliance of Act, Rules, Bye-Laws, financial condition and working of the Lungpher Women Pig Producer Cooperative Societies Ltd., bearing registration No. AE-158/92-93 of dated 26.5.1992. I am of opinion that the society is to be cancelled.

Whereas Notice calling on the authority of the society to submit representation to me if any within the specified 30 days was served vide this office letter No. B. 14027/15/04-RCOOP/134 Dt. 9.3.2005 but no representation was submitted/representation was found unsatisfactory.

Now therefore, the undersigned, in exercise of the powers conferred in me by section 71(2) and section 72(1) of the Mizoram Coop Societies Act, 1991 do hereby Cancelled the Registration of this society and appoint Pu R. S. Vanlalthanga SICS, Aizawl East District, Mizoram as a Liquidator of the Society with immediate effect for winding up of this dissolved society.

All claims against this dissolved shall be submitted to the Liquidator within 2 months of publication of this order as per Section 71(3) of the Mizoram Coop. Societies Act, 1991.
