### **N O T I F I C A T I O N S**

No. H. 11020/1/91-DCA (L), the 7th July, 2005. Whereas the administration in the Lai Autonomous District Council cannot be carried out in accordance with the provisions of the Sixth Schedule to the Constitution in the prevailing circumstances;

Now, therefore, after due consideration of all the materials including the report of the Deputy Commissioner, Lawngtlai, placed before him, and after consultation with the Chief Minister on the matter, the Governor of Mizoram is pleased to invoke his discretionary powers under paragraph 20BB of the Sixth Schedule in respect of application of the provisions of paragraph 16 of the said Schedule, to the Lai Autonomous District Council stands dissolved with immediate effect.

The Governor of Mizoram is further pleased to order that pending reconstitution of the said council on a fresh general election for which a separate notification will be issued shortly, the administration of the area under the authority of the said Council shall stand assumed to himself and then vested in the Deputy Commissioner, Lawngtlai for a period not exceeding four months or the said Council is reconstituted, whichever is earlier, and the Deputy Commissioner, Lawngtlai shall function as the administrator for the said council subject to directions of the Governor from time to time.

The Governor is also pleased to direct that a fresh general election shall be held by the end of October, 2005 for the reconstitution of the Lai Autonomous District Council.
