No. Z. 11011/5/ 2002-HFW, the 3rd November, 2005. In compliance of the directions of the Supreme Court dated 1st March, 2005 in writ petition (C) No. 209/2003, it has been decided by the Govt. of Mizoram that until the Govt. of India formulates specific norms for compensation, the scheme followed by Govt. of Andhra Pradesh (Abstract copy enclosed) is hereby adopted for the purposes of payment of compensation in cases of death of any patient sterilized, or in cases of incurring developing incapacity or in cases of post operative complications as the case may be. The enclosed scheme shall come into force with effect from the date of concurrence of the Finance Department, Govt. of Mizoram.

ABSTRACT

HEALTH MEDICAL & FAMILY WELFARE (DI) DEPARTMENT

ORDER

Government of India in their letter second read above, while

i) To pay Rs. 1.00 lakh in case of death due to sterilization directly attributable to sterilization operation, of which Rs. 10,000/- will be paid immediately in cash to the next of the kin of the deceased, if the death occurred within 30 days of sterilization and the remaining Rs. 90,000/- is to be deposited in equal shares in the name of the surviving children in National Savings Certificate and the interest accrued on monthly basis shall be paid to the respective children every month, for their maintenance. The original amount deposited shall be payable to the children after attaining the age of eighteen. Govt. of India will reimburse Rs. 50,000/- (Rupees fifty thousand only) and the remaining Rs. 50,000 (Rupees fifty thousand only) shall be paid by the State Government.

ii) TO PAY AN AMOUNT UPTO RS. 30,000/- PER CASE FOR IN CAPACITATION DEPENDING ON THE LEVEL of incapacitation. The expenditure on this item shall be met from cash compensation funds released by the Government of India.

iii) To pay the actual cost of treatment of serious post operation and actual cost of treatment of serious post-operation complications limited to Rs. 20,000/-, The expenditure on this item shall be met from cash compensation funds released by Government of India.

3. The expenditure shall be met from the Head of Account '2211'-FW 105 Compensation Schemes Included in the Plan U. Centrally Sponsored Schemes SH (04) Ex-gratia assistance in cases of fertility complication due to Vasectomy/Tubectomy and IUD insertions-340-Other charges-342. Other expenditure.

4. The Commissioner & Director, Family Welfare is requested to take necessary action accordingly.

5. This order issues with the concurrence of Finance & Planning (FW FBS IX) Department vide their U. O. No. 1628 251/A1/EBS-IX/98, dated 9. 10. 98.

The Male Sterilization procedure either by conventional or no scalpel vasectomy can be performed by a trained MBBS doctor".

AMENDMENT OF THE BYE-LAWS OF THE MIZORAM COOPERATIVE APEX BANK LTD.

Bye-Law No.	Existing Provision in the Bye-Law	Amendment
--------------------	--	------------------

4(a) The Authorised Share Capital of the Bank shall

(20 crores made up of 20,00,000 shares of Rs. 100/- per share). The value of a share shall be paid in full at the time of admission, every Primary Cooperative Society shall be subscribe 25 share, out of which it shall be subscribed 10 shares initially and the balance 15 shares shall be subscribed in such a manner as may be decided by the Executive Committee.

The School Cooperative shall subscribe at least 2 shares each every State Level Society shall subscribe at least 250 shares each out of which 100 shares shall be subscribe initially and the balance in such a manner as may be decided by the Executive Committee.

4(b) A nominal member shall pay a nominal membership fee of Rs. 100/- (Rupees one hundred only) and shall pay admission of Rs. 20/- (Rupees twenty) only.

15(c) Deposits in the form of current, Savings, Fixed Deposits etc., as per rules that may be framed from time to time.

16(a) The General Assembly, which stands for the General Meeting of the Bank shall consist of one representative from each affiliated Society and the ex-officio members of the Board of Directors of the Bank.

The Authorised Share Capital of the Bank shall be Rs. 20 crores (20 crores made up of 20,00,000 shares of Rs. 100/- per share). The value of a share shall be paid in full at the time of admission, every Primary Cooperative Society shall subscribe at least 50 shares each and every State Level Society shall subscribe at least 300 shares each.

Those Societies, primary, State level who do not subscribe the minimum share may attend General Assembly but shall not have the right to vote.

A nominal member shall pay a nominal membership fee of Rs. 500/- (Rupees five hundred) only and shall pay admission fee of Rs. 20/- (Rupees twenty) only.

Deposits in the form of Current, Savings, Fixed Deposits etc., as per rules that may be framed from time to time.

The Deposits of Mizoram Cooperative Apex Bank Ltd. will be insured under the scheme of Deposit Insurance & Credit Guarantee Corporation (DICGC) according to rules, Norms and Guidelines to protect the interest of the depositors.

The General Assembly, which stands for the General Meeting of the Bank shall consist of one representative from each affiliated Society and the Sitting members of the Board.

16(a) (i) Each representative and ex-officio member shall have one vote only. No member under suspension is entitled to take part or vote in the meeting of the General Assembly as a representative.

24(a) The Board of Director shall be elected and shall hold office for one year but shall be eligible for re-election. Provided that except with the prior permission of the Registrar, Coop. Societies, no member shall hold Office for more than four years in succession or having already office for four years be re-elected within a shorter than two years from the date on which he/she ceased to be a Director.

25(b) Any vacancy occurring in the Board of Directors shall be filled up by the Board from amongst the qualified members of the affiliated societies for the remaining period of the term. Any vacancy amongst nominated members shall be filled up by the Govt. of Mizoram.

In respect of Vice Chairman, the vacancy will be filled in by the Board from amongst the elected members for such interim period if the Board considers necessary.

Each representative and Sitting members of the Board shall have one vote only. No member under suspension is entitled to take part or vote in the meeting of the General Assembly as a representative.

The Board of Directors shall be elected and shall hold office for two years, provided that no member shall hold office for more than four years in succession or having already hold office for four years whether in succession or not, be re-elected within a shorter interval than two years from the date on which he/she ceased to be a member of such Council or Body.

Provided further that, if the election cannot be held for any reason, the gap period so occasioned shall not be counted to form part of the interval of two years.

Any vacancy occurring in the Board of Directors shall be filled up by the Board from amongst the qualified members of the affiliated societies for the remaining period of the term. Any vacancy amongst nominated members shall be filled up by the Govt. of Mizoram.

In respect of Vice Chairman, the vacancy will be filled in by the Board from amongst the elected members for such interim period if the Board considers necessary.

In case of Chairman, the vacancy will be fill-up by Vice Chairman of the Bank for the remaining period of the term.

CANCELLATION ORDERS

No. B. 14016/227/04-RCOOP/78, the 2nd November, 2005. Whereas a result of Inspection Under Section 66 of the Mizoram Cooperative Societies Act of 1991 into the compliance of Act., Rules, Bye-Laws, financial condition and working of the Phairuang Teak Planter Cooperative Societies Ltd., bearing registration No.L-320/95-96 of dated 16. 8. 1995. I am of opinion that the society is to be cancelled.
