Such departments shall submit ex-post facto proposal for bifurcation/trifurcation etc., within November, 2005, positively.

It is reiterated that in future all Departments shall obtain approval of GAD in the event of any such necessity for re-organization (bifurcation/trifurcation) and amalgamation of Departments.
