NOTIFICATION

No. C. 18015/96-LJC/139, the 9th January, 2006. Pursuant to the Hon'ble Supreme Court's Judgement dated 2nd August, 2005 in the Writ Petition (civil) No. 496 of 2002 (Salem Advocates Bar Association, Tamil Nadu-Vs-Union of India & Ors.) read with Writ Petition (civil) No. 570 of 2002, requiring application of sections 79-82 (both inclusive) of the Code of Civil Procedure, 1908 as amended from time to time in Mizoram for the purposes of due compliance of the direction of the Hon'ble Supreme Court contained in the said judgement, the Governor of Mizoram, in exercise of the power conferred under the Proviso to sub-section (3) of section 1 of the Code is pleased to order that

sections 79-82 (both inclusive) of the Code of Civil Procedures, 1908 shall apply in letters in respect of all civil suits in the State of Mizoram excluding the autonomous districts of Lai, Mara and Chakma, with immediate effect.

The Governor of Mizoram is further pleased to order that for the purposes of due compliance of the said directions of the Hon'ble Supreme court, all administrative departments shall designate one officer each in their respective department to be responsible for proper and timely reply to any notice under section 80 of as the said Code, may be received at their end from time to time.
