1. ACCOMMODATION:

1) Deluxe — Officers drawing pay in the scale of Rs. 18400-22,400/- or above and all sitting members of Legislative Assembly.

- 2) Private ward Officers drawing pay in the scale of Rs. 10,000-18,300/-
- 3) Semi Private Ward Officers drawing pay in the scale of Rs. 5,500-9,000
- 4) General Ward. All categories of Govt. servant not mentioned above.

B. HOSPITAL WITHIN MIZORAM:

All officers drawing pay in the scale of Rs. 10,000-15,200/- and above are entitled to claim reimbursement of accommodation charges. The pay scale of Rs. 10,000-15,200/- may not be taken as gradation of Govt. servants for entitlement of rooms, but only for the purpose of reimbursement of accommodation charges in these Hospitals.

2. DIET CHARGES:

All categories of Govt. servants under Govt. of Mizoram referred to outside Mizoram for treatment are entitle to reimbursement of Diet charges at an uniform rate of Rs. 40/-per day or actual charges realised by the Hospital which ever is less.

Reimbursement of actual diet charges is also permissible for all categories of Govt. servant under Govt. of Mizoram for treatment within the recognised Hospital in Mizoram.

Incase the Hospitals within Mizoram and outside Mizoram do not have any separate charge for diet, Govt. servant are allowed to get reimbursement as per the provisions of Rule 37 of CS (MA) Rules, 1944.
