Reimbursement of actual diet charges is also permissible for all categories of Govt. servant under the Govt. of Mizoram for treatment within the recognised Hospital in Mizoram.

In case the Hospitals within Mizoram and outside Mizoram do not have any separate charge for diet, Govt. servant are allowed to get reimbursement as per the Govt. of India Decision No. 27 below Rule 2 of CS (MA) Rules, 1944.
