#### Duties and Responsibilities

The main duty and responsibility of an Honorary Wildlife Warden is to assist whole heartedly the State organization responsible for wildlife conservation work, especially with regard to the following matters:

- (a) control of poaching and clandestine trade in wild animals and products/articles thereof.
- (b) Detection and prosecution of offences under Wildlife (Protection) Act and the Rules made thereunder.
- (c) Preventing damage to the habitat of wildlife.
- (d) Identification and selection of areas suitable to be declared as sanctuaries, national park, closed areas, etc; as well as measures for their proper protection.
- (e) Measures for dealing with the problem of damage by wild animals to life and property, including the assessment and payment of compensation, etc.
- (f) Carrying the message of conservation to the people and enlisting public support for nature and wildlife conservation. The effort should be specially directed towards the communities living in or near the declared wildlife reserves.
- (g) Any other matter connected with the protection of wildlife, which may be entrusted by the State Board for Wildlife or the Chief Wildlife Warden of the State, from time to time.

In accordance with sub-section (3) of section 4 of the Wildlife (Protection) Act, 1972 an Honorary Wildlife Warden appointed under sub-section (2) (c) of section 4 shall be subordinate to the Chief Wildlife Warden of the State and under section 59 of aforesaid Act, he shall be deemed to be a public servant within the meaning of section 21 of the Indian Penal Code.

Protection for action taken in good faith is provided under section 60 of the Wildlife (Protection) Act, 1972.

#### ORDER

Whereas Shri R.Lalrinawma had submitted a petition dated 19th April, 2006 for the disqualification of Shri Rasik Mohan Chakma, a sitting member (as he was then) of the Mizoram Legislative Assembly, for being a member of that Assembly under sub-clause (a) of clause (1) of article 191 of the Constitution of India.

And whereas the Governor of Mizoram sought the opinion of the Election Commission of India under clause (2) of article 192 of the Constitution of India on the question whether Shri Rasik Mohan Chakma had become subject to such disqualification as alleged by said Shri Lalrinawma.

And whereas the Election Commission of India has tendered its opinion (vide Annexure-A) that in view of the well settled constitutional position, the question of the alleged disqualification of Shri Rasik Mohan Chakma, being a case of pre-election disqualification, if at all, cannot be raised before, or decided by, the Governor under clause (1) of article 192 of the Constitution and that the present petition is, therefore, non-maintainable before the Governor under said article of the Constitution, in so far as it relates to Shri Rasik Mohan Chakma.

Now, therefore, I, Amolak Rattan Kohli, Governor of Mizoram do hereby decided that the petition of Shri R.Lalrinawma is not main therefore, rejected.

In re: Alleged disqualification of Shri Rashik Mohan Chakma, Member of Mizoram Legislative Assembly, under Article 191(1)(a) of the Constitution of India.

#### **OPINION**

This is a reference dated 28th April, 2006, from the Governor, Mizoram seeking the opinion of the Election Commission under Article 192(2) of the Gonstitution of India, on the question of alleged disqualification of Shri Mr. K. Vanlalauva and 11 other members of the Mizoram Legislative Assembly, including Shri Rashik Mohan Chakma, under Article 191(1)(a) of the Constitution of India.

- 2. The above question arose on the petition dated 17th April, 2006, submitted by Shri R. Lalrinawma to the Governor of Mizoram, under Article 192(1) of the Constitution of India, raising the question of alleged disqualification of Shri K. Vanlaluva and 11 other members of the Mizoram Legislative Assembly including Sh. Rashik Mohan Chakma, under sub-clause (a) of clause (1) of Article 191 of the Constitution of India, on the ground that they are holding offices of profit and are, hence, liable to be disqualified under the said Article 191 (1)(a). While the question of alleged disqualification of the other MLAs is being considered by the Commission separately, this opinion deals with the question of disqualification of Shri Rashik Mohan Chakma.
- 3. The allegation in the petition with regard to Shri Rashik Mohan Chakma is that he has been holding the office of Chief Executive Member of Chakma Autonomous District Council from February, 2003. The petitioner has stated that Shri Rashik Mohan Chakma was holding the office of Chief Executive Member of the Council at the time of his election to the Mizoram Legislative Assembly and that he continued to hold the said office even after his election as MLA. On this ground, the petitioner contends that Shri Rashik Mohan Chakma should be disqualified from being a member of the Legislative Assembly under Article 191(1)(a) of the Constitution of India.
- 4. It is well settled that under Article 192(1) of the Constitution of India, the jurisdiction of the Governor to decide question of disqualification of a sitting Member of Legislative Assembly arises only in disqualifications incurred after election as a member of the House. The jurisdiction of the Election Commission to inquire into such question of the alleged disqualification, on being referred to it by the Governor under Article 192(2) of the Constitution, also arises only in case of post-election disqualification. Any question of pre-election disqualification, i.e. disqualification from which a person was suffering at the time of, or prior to his election, can be raised only by means of an election petition presented in accordance with the provision of Art. 329(b) of the Constitution read with Part-VI of the Representation of the People Act, 1951, and not under Art. 192(1). Reference is invited, in this connection, to the Supreme Court's catena of decisions in Election Commission Vs. Saka Venkata Rao (AIR 1953 SC 201); Brundaban Naik Vs. Election Commission (AIR 1965 SC 1892); Election Commission Vs. N.G. Ranga AIR 1978 SC 1609); etc. In a very large number of other similar cases in the past, the Commission has given similar opinion, on the references made to it by the President and Governor of States.
- 5. Shri Rashik Mohan Chakma was elected to the Mizoram Legislative Assembly in December, 2003. The contention of the petitioner is that Shri Rashik

Mohan Chakma was holding the offlice of Chief Executive Member of Council since February 2003, when he contested and won the election to the Legislative Assembly. In other words, Shri Rashik Mohan Chakma was holding the said office prior to his election as MLA. In view of the well-settled constitutional position referred to above, the question of alleged disqualification of Shri Rashik Mohan Chakma, being a case of pre-election disqualification, if at all any disqualification is attracted, cannot be raised under Article 192(1) of the Constitution. The Election Commission also has no jurisdiction to express any opinion on the question of such alleged pre-election disqualification. The present petition is, therefore, not maintainable before the Governor in terms of Article 192(1) of the Constitution.

6. The reference received from the Governor, Mizoram, in the present case, is accordingly, returned with the opinion of the Election Commission of India, under Article 192(2) of the Constitution, to the above effect that it is not maintainable under Article 192(1) of the Constitution in so far it relates to Sh. Rashik Mohan Chakma. The question of alleged disqualification of the other MLAs raised in the petition is being considered separately and opinion in thoses cases will be sent in due course.
