6. State Police Intelligence and Security organisations or formations dealing with subjects concerning negotiations/ settlements of militants, insurgents, extremists and antisocial elements and all matters relating to covert and overt operation against them.

3. Filling up of posts, recruitment procedures, pay scales, etc. should be done in conformity with the norms of ICAR.
4. The service of Krishi Vigyan Kendras (KVKs) should be compartmentalized and not inter-transferable with the posts of Host Department i.e. Agriculture Department.
5. An Undertaking should be taken from those appointed to the posts that they should not claim continuation after the posts are abolished.
