No. A. 43016/1/2007-DCA (L), the 03rd April, 2007. Whereas within a day or two of reported formation of MNF Legislature Party under the leadership of Pu C. Thanghluna on 28/03/2007, four independent elected MDCs viz. (1) Pu F. Manghnuna, (2) Pu U. Zathang, (3) Pu N. Zangura and (4) Pu A. Vandailova withdraw their support as well as denied their participation in the election of said Pu C. Thanghluna as the leader of the said Legislature Party, by their declaration dated 30/03/2007;

Whereas the same four independent MDCs, namely (1) PurF. Manghauna; (2) Pu U. Zathang, (3) Pu N.Zangura, and (4) Pu A. Vandailova again submitted a declaration on 31st March, 2007 stating that they together with other nine elected MDCs had formed a new legislature party, namely United Legislature Party but did not mention anything as to the election of their leader;

Whereas the United Legislature Party members including the same four independent MDCs only on 1st April, 2007 communicated to the Governor of Mizoram that they had elected Pu J. B. Rualchninga as their leader and as the Chief Executive Member of the LADC in a meeting held on 1st April, 2007;

been frequently changing their support to either this group of that group for reasons best known to them, as: a result of which during last 4-5 days there were frequent changes of LADC-leadership;

Whereas even after discussions with various leaders from the L A D C, the Governor of Mizoram failed to find any convincing reason that even if the claim of Pu J. B. Rualchings or Pu C. Thanghlung were entertained, there would be no more horse-trading or instability, and it further appears to his satisfaction that the administration of the Lai Autonomous District cannot be carried on in accordance with the provisions of the Sixth Schedule to the Constitution in such circumstances;

And whereas, after consultation with the Hon'ble Chief Minister, it appears to the Governor of Mizoram that it would be more prudent and reasonable to refuse the claim of either of the parties at this juncture, and to place the administration of the Lai Autonomaus District under the authority of the Deputy Commissioner, Lawngtlai, for the time being, in larger public interest, initially for one month, subject to further extension, if required;

Now, therefore, in exercise of the powers conferred by sub-paragraph (2) of paragraph 16 read with paragraph 20BB of the Sixth Schedule to the Constitution, the Governor of Mizoram is pleased to keep constitution of a new Executive Committee for the Lai Autonomous District Council in abeyance initially for a period of one month, subject to further extension, if required, and to assume to himself all of the functions or powers vested in or exercisable by the Executive Committee of the said District Council with immediate effect. The Governor of Mizeram is further pleased to declare and order that all such functions or powers of the Executive Committee of the Lai Autonomous Disrict Council snall be exercised by the Deputy Commissioner, Lawngtlai District, Lawngtlai, in his behalf, as an administrator of the said District Council initially for a period of one month, subject to extension, if required. The administrator so appointed shall take over the administration of the said District Council immediately and shall keep the Governor apprised without delay all developments as may arise from time to time in respect of the said District Council.
