**Autonomous District Council Orders, Notifications, Resolutions etc.,
given by Autonomous District Councils.**

NOTIFICATIONS

No. H. 14011/2/2007-DCA(M), the 4th May, 2007. Whereas the Deputy Commissioner, Saiha in his capacity as Returning Officer for the General Elections to the Mara Autonomous District Council has reported under his Memo No. H. 13014/1/2007-DEO(S) Dated 4th May, 2007 that the polled ballot boxes and all documents connected to 1/5-Lungdar polling station were taken from the custody of the concerned Presiding Officer by Village Council President, Tongkolong and others enroute to Saiha and somewhere between Lawngban and Maisa and were destroyed by them;

Whereas the said Returning Officer and Deputy Commissioner, Saiha has proposed that polled ballot papers of that particular polling station be declared to be void and a repoll be conducted on 5th May, 2007 as provided under Rule 162 of the MADC(CCB) etc. Rules, 2002 as amended from time to time;

Now, therefore, after due consideration of the entire matter, the Governor of Mizoram is pleased to accept the report of the Returning and Deputy Commissioner, Saiha and to approve the proposal of the Returning Officer and De-

puty Commissioner. Saiha to hold a fresh poll in respect of the said polling station as required under Rule 162(2) of the MADC(CCB etc.) Rules, 2002 as amended from time to time, after cancellation of the poll held on 03/5/07 in the said polling station.

No.A.43016/1/2007-DCA(L), the 3rd May, 2007. Whereas by notification dt. 3rd April, 2007 issued by this Department, Administration of the Lai Autonomous District was placed under the authority of the Deputy Commissioner, Lawngtlai initially for one month and subject to further extension, if required;

Whereas the Governor of Mizoram has viewed that in the incase, the claim of the United Legislature Party (ULP) had been kept on hold, since names of some Elected Members had figured in the claims of both sides i.e. MNF and ULP, that too in a short period of about 48 hours and hence, he was not certain whether the various Elected Members of LADC would remain firm with any group;

Whereas on the face of the continuing claim of the ULP to allow them to form the Executive Committee, the Govt. recommended for keeping placed the administration of the LADC under the authority of the Deputy Commissioner, Lawngtlai for another one month, in view of the tense political situation therein and for other relevant considerations;

Whereas the Governor of Mizoram had first consulted the Chief Minister, representing the Council of Ministers, on 2nd May, 2007, before taking any decision on the matter, and subsequently, he received on 3rd May, 2007, a note No. PB/MIN/HOME/PHE/DP&AR/1 dt. 2.5.2007 signed by the Acting Chief Minister with an advice not to take any decision contrary to the advice for further extension of the suspens receipt of the said note, again discussed the issue with the Chief Minister on 3rd May, 2007, who has desired that since at present, the Chief Minister is away to New Delhi and unable to consult his Council of Ministers, so he may be given time to have due consultation with his Ministers on his return to Aizawl on the claim of the ULP to form the Executive Committee in the LADC and on the proposed exercise of his discretionery powers by the Governor;

And whereas the above mentioned circumstances along with the fact that the Governor also would be out of station for sometime, demand that, to meet all Constitutional obligations, it would be fair and safe, under the circumstances to extend the placement of LADC under the administration of Deputy Commissioner, Lawngtlai till 15th May, 2007 and not beyond that;

Now, therefore, the Governor of Mizoram in exercise of his powers available under the Sixth Schedule to the Constitution read with the LADC (CCB etc.) Rules, 2002 as amended from time to time is pleased to extend the placement of the said District Council under the administration of Deputy Commissioner, Lawngtlai till 15th May, 2007.
