Whereas election of Chief Executive Member is necessary for formation of a new Executive Committe of the Mara Autonomous District Council, and whereas after following all necessary formalities under the provisions of Rules 22 of the Mara Autonomous District

Council (CCB etc.) Rules, 2002, as amended from time to time, Pu S.Khipo, an elected MDC, has been duly elected as leader of the United Legislatures Party on 8th May, 2007 and thereafter as Chief Executive Member of the said Council.

Whereas on due consideration of the developments in the political scenario relating to LADC, the Governor of Mizoram has found that some elected MDCs have changed side four times in a matter of about 37 days and his apprehension of instability in the administration of LADC to continue, in case either of the group is called upon to form the Executive Committee, appears to be true to a large extent;

Now, therefore, in consultation with the Chief Minister and in larger public interest with the sole aim to ensure stability in the governance of LADC, the Governor of Mizoram in exercise of his powers conferred by Sub Paragraph (2) of Para 16 read with Paragraph 20 BB to the Sixth Schedule to the Constitution, is pleased to extend the period of placement of the said District Council under the administration of Deputy Commissioner, Lawngtlai till 5th June, in partial modification of this Department's earlier Notification dated 3rd May, 2007. The Governor of Mizoram is further pleased to direct that the Deputy Commissioner, Lawngtlai as the Administrator of the said Council shall submit a

report or reports on any new developments as and when they may occur or at the latest by 1st June, 2007 to enable the Governor to arrive at a conclusive decision in respect of administration of the said Autonomous District.
