(State of Mizoram-Vs. Lalziki & Ors.) and also read with Section 10 of the Mizoram Civil Courts Act, 2005, the Governor of Mizoram is pleased to order that for the time being and pending setting - up of Civil Courts under the Act, the present Additional District Magistrate (Judicial), Aizawl, who is senior amongst the two shall function as the District Judge in charge of Aizawl District and the other ADM (J), Aizawl shall function as Additional District Judge in charge. Further, as it was not the intention of the legislature in the Mizoram Civil Courts Act, 2005, to repeal the Lushai Hills Autonomous District (Administration of Justice) Rules, 1953 as evident from Section 31 of the said Act, the Court established under the Administration of Justice Rules, 1953 shall also continue to function, therefore, the Governor of Mizoram is further pleased to order in public interest that while the present two Judicial Officers of the Mizo District Council Court at Aizawl shall function as Senior Civil Judge and Additional Senior Civil Judge, the Senior of the two Judicial Officers shall also act as President incharge of District Council Court, and the Judicial Officers of the Sub-District Council Courts at Aizawl and Lunglei and Additional Sub-District Council Courts at Lunglei, Champhai and Kolasib shall also function as Junior Civil Judge and Additional Junior Civil Judge. This is purely a transitional arrangement till the establishment of courts under the Mizoram Civil Courts Act, 2005 is finalized by the Hon'ble Gauhati High Court or till any further order is issued by the High Court in their administrative side under section 32 or the said Act. This order applies to the whole of the State of Mizoram except the areas of Autonomous District Councils.
