No. K. 53011/1/99-REV, the 4th October, 2007. It is hereby notified that the farmers who have been allotted land for undertaking farming, specially of turmeric crop, by the Village Council either through issue of Land Pass' or through verbal agreement, anytime on or before the date of this notification, would have the exclusive usufruct right to undertake farming activities preparation of land for sowing of turmeric or other agriculture produce and any other attendant activity for next five consecutive years.

That the notified usufruct right is restricted to the land use for carrying on agricultural activity only, that is, sowing of turmeric and other crops, over which the farmer to whom the land has been allocated by the Village Council have rights only on the agricultural produce sown by him and will not in anyway confer any ownership rights of the said land and at no time will he/she have any claim,

be considered a temporary or permanent tenant and may be required to vacate the said land on completion of five years of consecutive date of this notification, unless renewed by another notification.

Further, notified that the farmer to whom the land has been allotted by the Village Council for undertaking farming activities will not cut or remove any green tree which is located and growing in the allotted land space.

The allotted land will not bestow on the allottee the right to sell, transfer, mortgage or hypothecate the said land under any circumstances.
