NOTIFICATION

- G.S.R ——In exercise of the powers conferred by sub-section (1) of section 13 of the Central Sales Tax Act, 1956 (74 of 1956) the Central Government hereby makes the following rules further to amend the Central Sales Tax (Registration and Turnover) Rules 1957, namely:—
- 1. These rules may be called the Central Sales Tax (Registration and Turnover) (Amendment) Rules, 1974.
- 2. In the Central Sales Tax, (Registration and Turnover) Rules, 1957 (hereinafter referred to as the said rules), in rule 2, after clause (an), the following clause shall be inserted, namely:
 - "(aaa) 'company' means a company as defined in section 3 of the Companies Act, 1956 (1 of 1956) and includes a foreign company within the meaning of section 591 of that Act."
- 3. In rule 3 of the said rules, in clause (a) of sub-rule (1) the words and figures "Incorporated under the Companies Act, 1956" shall be omitted.
- 4. In rule 12 of the said rules :--
 - (a) in sub-rule (1) in the first proviso, for the figures "1973," in the two places where they occur, the figures "1974" shall be substituted;
 - (b) In sub-rule (6), the following explanation shall be inserted at the end, namely:—
 - "Explanation.—Where, by reason of the purchasing dealer not being registered under section 7 in the State in which the goods covered by Form 'C' referred to in sub-rule (1) are delivered, he is not able to obtain the said Form in that State, Form 'C' may be the one obtained by him in the State in which he is registered under the said section.";
 - (c) in clause (a) or sub-rule (8)-
 - (i) for the first proviso, the following proviso shall be substituted, namely:
 "Provided that where such person is a proprietor of any business or
 a partner of a firm of a karta or manager of a Hindu Undivided
 Family, any other person authorised by him in writing may also sign
 such declaration or certificate:";

- (ii) In the second proviso, for the words, figures, brackets and letters "a company incorporate under the Companies Act, 1956 (1 of 1956), the declaration in form 'C' or form 'F' the words 'A' company, such declaration or certificate" shall be substituted.
- 5. In form 'A' appended to the said rules, in the food-note relating to the filling in of the particulars specified in item 11 of the said Form, the words, figures ond brackets "incorporated under the Companies Act, 1956 (1 of 1956) or under any other Law" shall be omitted.
- 6. In form 'C' appended to the said rules, in each of the three parts marked as "Counterfoil," "Duplicate" and "Original," after the portion beginning with the words "Certified that the goods" and ending with the words and figures "under the Central Sales Tax Act, 1956," the following shall be inserted, namely:—
 - "** It is further certified that I/we am/are not registered under section 7 of the said Act in the State of in which the goods covered by this Form are/will be delivered."

ADVERTISEMENT

No. HMP. 72/73/19, the 1st. May, 1974. Applications are invited from the citizens of India (as defined in Article 5 to 7 of the Constitution of India) for 6 (six) posts of Deputy Superintendent of Police (Class II gazetted) in the scale of pay of Rs. 300-25-450-EB-30-600-EB-30-900/- plus other allowances as admissible under the rules from time to time in Mizoram.

- 2. Applications will be received by the Chief Secretary to the Govt. of Mizoram, Aizawl upto 3rd. June, 1974.
- 3. (i) Applications should be made in the prescribed form which is obtainable from the Superintendent, Home Department, Mizoram Secretariat, Aizawl, on payment of Rs. 100 each through Treasury Receipt only. Candidates who want to obtain Application Form by post must send a self-addressed un-stamped en-

velope of the size of at least 23 x 10 cms, along with the Treasury Challan of Rs. 1:00.

- (ii) Each application should be accompanied by a Treasury Receipt for Rs. 5'00 (Rupees five) being the application fee and attested copies of the Certificates and two copies of passport Size photograph of the candidate.
- (iii) Candidates if allowed to sit for the examination must pay and admission fee of Rs. 15:00 cach when called for.
- (iv) Candidates belonging to the Scheduled Caste, Scheduled Tribes, Political Sufferers, Persons migrated from Pakistan on or after 1. 1. 1964 but before 25th. March, 1971 and persons repatriated from Shri Lanka (formerly known as Ceylon) on or after the 1st. November, 1964, will pay the application fee of Rs. 2.50 and Admission Fee of Rs. 8.00 each respectively as mentioned in (ii) and (iii) above. Ex-Servicement of whatever category are exempted from the payment of fees mentioned in (i), (ii) and (iii) above.
- (v) No candidate even though otherwise eligible will be admitted to the examination unless he/she has paid all the fees stated in (i) and (ii) above on or before the date fixed for the purpose.
- (vi) Payment of fees etc., will not be accepted in any other form except through the Government Treasury the receipt of which should invariably be attached to the applications. All payments called for in (i), (ii) and (iii) above should be made into a Treasury under the Central Head of Account 055 POLICE RECEIPT-EXAMINATION FEES-MIZORAM (CENTRAL).
- 4. Out of the total of 6 (six) posts: 2 (two) posts will be filled up from amongst Ex-Service, Emergency Commissioned Officers and ex-Short Service Commissioned Officers and the remaining 4 (four) posts from amongst other applicants.
- 5. FOR EX-EMERGENCY COMMISSIONED OFFICER AND SHORT SER-VICE COMMISSIONED OFFICER'S ONLY.
- (i) Age: Below 40 years on 1.1.'74 relaxable by 5 years for Scheduled Castes and Scheduled Tribes and displaced persons so migrated from East Pakistan on or after 1.1. 1964 repatriated from Burma and Shri Lanka who migrated on or after 1.1. 1963 and 1.11. 1964 respectively.
- (ii) Educational Qualifications: Intermidiate/B.A. Part I pass or equivavalent. Knowledge of local language will be desirable.
- (iii) The recruitment will be made through interview by Mizoram Selection Board. There will be no written exam.

6. FOR OTHER CANDIDATES:

- (1) Age: Below 25 years and above 20 years on 1.1. '74 Upper age limit is relaxable by 5 years for Members Scheduled Castes/Scheduled Tribes and upto forty five years for displaced persons migrated from East Pakistan on or after 1.1. 1964 repatriated from Burma on Shri Lanka who migrated on or after 1.1. 1963 and 1.1. 1964 respectively and upto 35 years for those who are Government servants under Government of Mizoram.
- (n) Educational Qualifications: Gradua in Arts or Science or Commerce of a Recognized University. Knowledge of local language will be desirable.
- (iii) Physical Measurement: Height (without shoes) 5' 4'' chest measurement (Minimum) 30'' normal 31 1/2'' expanded.
- (iv) The recruitment will be made through a competition examination consisting of 3 parts viz.
- PART A: PHYSICAL EFFICIENCY TEST: (50 marks). The test will comprise of high jump, long jump, spint (100 metres) and race (1 mile). Those who fail to achieve the prescribed minimum standards will be disqualified.
- PART B: WRITTEN EXAMINATION, (175 marks) The written examination will comprise 3 paper viz. (1) English Essay and General English (100 marks) (2) General Knowledge (50 marks) (3) Simple Arithmetic (25 marks)
- PART C: VIVA VOCE (100). Those who qualify in the written examination will be interviewed by Mizoram Selection Board.
- 7. The Physical Efficiency Test, written examination and/or interview will be held only at Aizawl. Date, venue of the same will be notified in due course. Candidate will have to defray their own travelling and other expenses for appearing for the examination and in viva voce.
- 8. Candidates who are already in Govt. service must submit their applications through proper channel. Applications which are not complete in all respects will be summarily rejected and no application will be received after 3rd. June, 1974.
