Subject: Constitution of a World Population Year Committe for Mizeram.

No. MFP./46/73/107, the 11th July, 1974. This year 1974 has been designated as World Population Year by U.N.O. The Joint Meeting of the Central Council of Health and Central Family Council held in April, 1974 resolved that the Centre and the States should jointly and sererally take advantage of the observance of this World Population Year to highlight the importance of Family Planning.
