#### OFFICE MEMORANDUM

Subject: Recommendation of the Third Pay Commission relating to grant of advance increments to stenographers (Ordinary grade) in Subordinate offices for a quiring higher speed in short hand.

The undersigned is directed to say that the Third Pay Commission has recommended in para 50 in Chapter 10 of its Report (Vol. I) That Stenegraphers (Ordinary Grade) in Subordinate Offices in the pay scale of Rs. 330-560 may be granted one and two advance increments respectively on their qualifying at 100 or 120 w.p.m. in short hand both at the recruitment stage and while in service. This recommendation of the Pay Commission has been accepted by the Government.

The President is pleased to decide that Administrative Ministries Departments may grant such advance increments to Stenographers (Ordinary Grade) in accordance with the following guidelines:—

- The recommendation of the Pay Commission would be applicable to Subordinate Offices having Stenographers (O.G.) in the revised scale of Rs. 330—560 irrespective of whether the miniemum recruitment speed is 80 words per minute or 100 word per minute. In Offices where the minimum recruitment speed is itself 100 words per minute, one advance increment will be admissible on qualifying in the test at the time of recruitment.
- (ii) The benefit of advance increments will be admissible to the existing stenographers (O.G) in the scale of Rs. 330—560 as well as future recruits to the grade.
- (iii) In respect of existing stenographers, the Administrative Deptt, will hold special tests and grant one or two advance increments according to whether they qualify at OG/120 words per minute. They will be given three advances to qualify at a higher speed. Stenographers who were recruited on the basis of minimum speed of 120 words per minute, will have to pass the test at this speed again for the purpose of getting the benefit of advance increment. But only one chance will be given to them for passing the test at this speed again.

(iv) In respect of future recruits, tests at the time of ecruitment should be held at the speeds of 80/100/120 words per minute and advance increments (s) granted at the recruitment stage according to the maximum speed at which they qualify. After they seen enter service, they will have three chances to qualify at a higher speed for purpose of earning advance increments (s) at 100 or 120 words per minute, as the case may be.

(v) The advance increments are not to be absorbed in future incre-

ment.

(vi) The date of next increment after the grant of advance incremets should remain the same.

3. These orders would take effect from 1. 1. 73 but cases which have already been decided otherwise will not be reopened.

These orders will also apply to the stonographers in the India Audit and Accounts Department. In so far as they are concerned, these orders issue after consultation with the Cr & A.G. of India.
