- COMMENCEMENT
- 1. SMORT ATLEAND : (1) Those Rules may be called the Mizoram District Chart (Inclaid Deptt) Group 'D' posts. Regulting 1

Rilles, 1977

- (2) They shall came into force on the date of them publication in the official Gazettle
- 2. APPLICATION

These Rules shall apply to the posts specified in Cotumn 1 of the schedule hereto annexed.

3. NUMBER OF POST: CLASSIFICATION AND SCALE OF PAY

The number of the said posts, their classification and the scales of pay attached thereto shall be as specified in Column 2 to 4 of the Scheduled, aforesaid.

4. METHOD OF RECTT: AGE LIMIT AND OTHER **OUALIFICATION** 

The age limit, qualifications and other matters relating to the said posts shall be as specified in

Column 5 to 13 of the said scheduled.

Provided that the upper age limit prescribed for direct rectt. May be relaxe in the case of candidates belonging to the Scheduled Castes. Scheduled Tribes and other Special categories of persons in accordance with the orders issued by the Central Govt. or. Covt. of Mizoram from time to time.

#### 5 DISQUALIFICATION: No person:

(a) who has entered into or contract a marriage with a person having a spouse living,

OR

(b) who, having a spouse living has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

Provided that the Administrator may, if satisfied that such marriage is parmissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for doing, exempt any person from the operation of this rule.

6. TRAINING AND DE-PARTMENTAL EXAMINA-TION. Every Govt. servant shall under go such training or pass such departmental examination as may be prescribed from to time.

#### 7. POWER TO RELAX:

Where the Administrator is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writting, relax any of the provisions of these rules with respect to any class or category of persons.

8. RESERVATION OTHER C●NCES-SIONS

Nothing in these rules shall affect reservation and other concessions required to be provided for the Scheduled Cases, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.

9. REPEAL AND SAVING

All Rules pertaining to these posts, framed by the Governor of Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District, and

continued to be in existence in persuance of Govt. of India, Ministry of Home Affairs, Notification No. 14/21/71-HMT (ii) dated 21.1.72 are hereby repealed.

Provided that any order made or anything done or any action under the rules so repealed or under the any general orders ancillary thereto, shall be deemed to have been made, done or taken the corresponding provisions of these rules.

Applications in the standard form are invited from bonafide citizens of India for a temporary post of Technical Officer (Mechanical) for the Consultancy Bureau attached to the Directorate of Industries under the Government of Mizoram in the scale of pay Rs. 700-40-900 EB-40-1100-50-1300/- p.m. (Revised Scale) plus other allowances as admissible under the rules from time to time.

The candidate must be a Graduate in Mechanical Engineering with at least 3 years' experience in responsible position.

Age must not be more than 30 years on 1. 1. 1977 but is relaxable by 5 years for Scheduled Caste/Scheduled Tribes candidates.

Application with certificates and a Treasury Challan of Rs. 5/- (Rs. 2.50 for Scheduled Caste/Scheduled Tribes, Political sufferers and War Service Personnel) deposited under the Head "065-Other Administrative Service Advertisement Fee etc." should reach the undersigned on or before the 10th Feb. 1977.

Application from Government servant must be submitted through Proper Channel and need not be accompanied by Treasury Challan.

There is no age limit for those who are already in Government Service.

Candidate should be ready to come to Aizawl for interview/test at their own expenses, if and when called for.

Convassing directly or indirectly will disqualify a candidate.
