AND WHEREAS under the provisions of clause (1) of Article 239 of the Constitution of India, the President, by Notification No. U-11011/2/72-UTL (iii) dated the 20th March, 1974 (S.O. 185 (E)) authorised the Administrator of the Union Territory of Mizoram to exercise the powers of the State Government under section 21 of the said Code ;

In continuation of this Ministry's letter No. 14025/7/75-MZ dated the 17th November, 1975 on the above subject I am directed to convey the sanction of the President to the prescription of Central Scales of pay for the posts of Matriculate Teachers under the Education Department of the Government of Mizoram as indicated in Col. 4 below with effect from 1.1.1973.

Matriculate Teachers (untrained) in the existing scale of Rs. 125-4-145-EB-4-165-EB-5-200/- will also be entitled to the revised scale of pay of Rs. 330-10-350-EB-10-380-15-500-EB-15-560/- if they have completed eight years of service. The revised scale in their case would be effective from the date of issue of this letter or from the date on which an incumbent completes eight years of service, whichever date is later.

3. This sanction is subject to the conditions mentioned in paras 2,3,4 and 5 of this Ministry's letter No. 14025/7/75-MZ dated the 17th November, 1975 under reference.

### A D V E R T I S E M E N T

Applications are invited from citizens of INDIA UNION for two Mizoram Stipendiary probationers to undergo training in Two Year's Diploma Course in Forestry (Batch 1977-79) at the State Forest Service College-cum-Research Centre, Burnihat (Assam-Meghalaya Border) commencing from 1.5.1977 for subsequent appointment of temporary posts of Assistant Conservator of Forests (Gazetted Class II) in the Forest Department of the Government of Mizoram in the scale of pay of Rs. 650-1200/- p.m. plus admissible allowances on successful completion of training. Other things being equal, bonafide residents of Mizoram possessing knowledge of Mizo language will be given preference. Application should reach the undersigned by 20th March, 1977.

Candidate must not be less than 19 years or more than 25 years on 1.3.1977, upper age limit relaxable in case of Scheduled Caste/Tribe by not more than 5 years. In case of Departmental candidate the age should not exceed 35 years on 1.3.1977, upper age limit for the Departmental candidates to Scheduled Caste/Tribe relaxable by 5 years.

Scheduled Tribe/Caste candidates should attached copy of certificate from the Deputy Commissioner or District Magistrate in support of their claim.

Candidate must be at least a second class graduate in Natural Science, Geology, Agriculture & Mechanical Engineering of a recognised Indian University or holding equivalent foreign qualifications. In case of a University which does not award classes, the candidates must have secured at least 45% aggregate marks. In case of graduates with pure Mathematics or Statistics, he must have taken one of the following subjects in higher secondary/Matriculation or equivalent examination.

(1) Biology (2) Physics (3) Chemistry. Science graduate with Economic and Mathematics will also be eligible.

Candidates must have the following minimum standard of physical fitness:--

Chest girth fully expanded	—	84 cm.
Chest expansion	—	5 cm.
Height	—	163 cm.

Minimum height limit in case of Gorkha, Mizo, Naga, Assamese, Meghalayan, Nepalese candidate is relaxable upto 152.5 cm.

The application should contain the following in a tabular form:—

1. Full Name (In Block letter) with present address.
2. Father's Name.
3. Age on 1. 3. 1977 as calculated from the Matriculation Certificate
4. Educational Qualification with name of the Institution last attended (subject taken to be stated).
5. Home District with post & telegraph office, P.S. & Village.
6. Community.
7. Present occupation, if any.

The application should be accompanied with attested copies of the following:

- (a) Matriculation Certificate of Higher Secondary Passed Certificate.
- (b) University Degree or Post-Graduate Degree Certificate. Certificate of respectability and good character from two or more persons of acknowledged Social or official persons.

(Copies of all certificates should be attested by a Gazetted Officer. The candidates will be required to produce their original certificates/degree at the time of interview).

The candidates must submit his application through the Deputy Commissioner or the Divisional Forest Officer of his District.

Candidates should possess good physique with sound bearing and general physical fitness for rough outdoor works in the Forest Department.

The candidates whose applications are accepted will be required to pass a physical test consisting of a walk over 25 km. to be covered in 4 hours followed by a medical examination.

The selected candidates will have to execute bond with 2 (two) sureties of means on a non-Judicial Stamp paper of Rs. 5.00 (cost to be borne by the selected candidates).

The term and condition of the bond to be executed may be had from the Forest Department, Government of Mizoram.

During the training period, a stipend of Rs. 300/-p.m. actual travelling allowances and Tuition fees of Trainees will be borne by the Forest Department, Govt. of Mizoram.

A Treasury Challan of Rs. 5/-(Rs. 2.50 for Scheduled Tribe/Scheduled Caste) as application fees to be deposited under the head of "113-Forest-10-Misc. Examination fees etc" must accompany each application. Fees are not refundable and no postal M.O. or stamp will be accepted in lieu of Treasury Challan.
