In partial modification of the Rules of "Advisory Committees for Government Hospitals, Dispensaries and Primary Health Centres", notified vide Health & Family Planning Department, Government of Mizoram's No. MFP, 72/74/6 dated 27.6.1974, the Lt. Governor of Mizoram is pleased to make the following amendments to the said Rules :-

- (1) The word "Sub-Health Centres" shall be added after the word "Primary Health Centre" appearing in Rule 1, 3 & 11.
- (2) Rule 6 shall be substituted with the following :-

Rule 6 The function of the Committee shall be--

- (a) For District Advisory Committees for District Hospitals the Chairman will be the Deputy Commissioner & the Civil Surgeon--Member-Secretary

tary : Executive Engineer, P.W.D. (R & B)—Member ; three prominent non-officials such as M.Ps., M.L.As., C.E.Ms of the District Council Administrative Officers, Private medical practitioners residing in the locality.

- (b) For Sub-Divisional Advisory Committees for Sub-Divisional Hospitals the Chairman will be the S.D.O., S.D.M.O. Member-Secretary; Members: S.D.O., P.W.D., (R&B); three prominent non officials such as M.Ps., M.L.As, C.E.Ms., of the Sub-Division, Administrative Officers and Private medical practitioners residing in the locality.
- (c) For P.H.C/Dispensaries/Advisory Committee, the Chairman will be appointed by the Deputy Commissioner from amongst the following members :-

M.O. i/c Secretary; Members-B.D.O. residing in the locality. The V/C President; three prominent public men residing in the locality such as local M.L.As. M.D.Cs., etc.

- (d) For Sub-Health Centre Advisory Committee, the Chairman will be appointed by the D.C. from amongst the following Members :-

The A.O. V/C President; M.O. i/c of the Sub-Centre-Secretary; three prominent leaders of the public.

3) Rule 9 shall be substituted with the following :-

6. Four members shall form a quorum for meeting of the Committee for Hospitals and three members for meeting of the Committee for Dispensaries, Primary Health Centres and Sub-Health Centres.
