DECLARATION

No. LRR. 45/73/77/Pt/66, the 15th April, 1977. Whereas it appears to the Government of Mizoram that land required to be taken by the Government at the expense of the Animal Husbandry & Vety. Department for a public purpose viz. for location of Modern Slaughter House which is situated at NEW BAZAR, Below the M.E. School in the Aizawi/Lungler District of Mizoram; it is hereby declared that, for the above purpose, land belonging to Smt. Panmati Karkini of Chhinga Veng measuring more or less 9,038 sqft/ of standard measurement bounded on the:—

Eastern Side of pillar No. 4--5 = 125 ft/metres

Southern ,, ,, No. 3-4 = 21 ft/metres

Western ,, ,, No. 1-2 = 88 ft/metres

South ,, ,, No. 2-3 = 58 fr.
