The Committee on Land Tenure System in Mizoram constituted under Notification No. LRR. 115/76/4 of 24.4.1976 having expired on the 30th September, 1976, the Lt. Governor (Administrator) of Mizoram is pleased to reconstitute the said Committee in supersession of all previous orders in this respect with the following members under the Chairmanship of Pu J.
