- (a) to advise the Mizoram Administration from time to time on legislative and administrative measures necessary for removing, as far as possible the economic & social injustice, disabilities and discriminations to which women are subjected;

c) to enable women to assert their inherent right to equality so that every woman is enabled to develop her gifts/ capabilities and make her contribution to the nation; and

(d) to review the progress of implementation of programmes designed in pursuance thereof.

Steering Committee will be set up on the recommendation of this Committee.

The term of membership will be for a period of one year.

Non-official members will be entitled to TA/DA as admissible to Class/Grade I officers of Mizoram Administration.
