Applications in the standard formare invited from bonafide citizens of India for the post of Stenographer Grade I in Civil Secretariat, Govt. of Mizoram in the scale of pay of Rs. 650-30-770-35-880-EB-40-960/- (Revised) plus other allowances as are admissible under Rules from time to time.
