#### II. Terms of Reference

The State Advisory Committee of National Cadet Corps shall ordinarily meet at least twice a year and may in relation to those portions of the National Cadet Corps which are located within the State:—

- (a) Make recommendations and tender advice to the Central Government and to the State Government upon the following matters:—
  - (i) The formation of new units and disbandment of existing units.
  - (ii) The selection of the Colleges and Schools which should raise units or Sub. Units;
  - (iii) The selection of persons for appointment as Officers in the Senior and Junior Divisions;
  - (iv) Any other matter which may be referred to it by the Central Government or the State Government or the Director General National Cadet Corps, as the case may be and
  - (b) Issue directions and tender advice to Officers Commanding Units of the Senior Division and to the Director of Education of the following matters:-
  - (i) Improvement of Training facilities for cadets;
  - (ii) Improvement of discipline in the Units; and
  - (iii) The general Welfare of Officers and Cadets.
