TERMS AND CONDITIONS

- (a) The Deputy Commissioner of the District concerned will act as sanctioning authority and the District Industries Officer as drawing and disbursing Officer for the loan money.
- (b) The terms of Office for the members shall be normally two years with effect from the date on which the Board is reconstituted. The members shall hold office during the pleasure of the Lt. Governor of Mizoram.
- (c) The Board shall ordinarily meet once every three months.
- (d) The notice for the Board's meeting shall be issued at least 15 days before the date of the meeting by the Secretary with prior approval of the Chairman.
- (e) A member shall cease to hold Office, if he is absent from three consecutive sittings of the Board without permission of the Chairman of the Board.
- (f) Six members shall form a quorum. If there be no quorum, the meeting shall be adjourned to a subsequent date. No quorum will be necessary for adjourning meeting.
- (g) In absence of the Chairman, the member present shall elect one of the members present to preside over that particular meeting.
- (h) Non-official members will be entitled to T.A/D.A. as admissible to Grade I Govt. Officers and M.L.As as admissible under Rule 3 of the Mizoram Salaries & Allowances of Members of the Legislative Assembly Act, 1973.
