ANNEXTURE — I

Terms, conditions and duties of wild Life Advisory Board" under the Govt. of Mizoram will be as follows:-

The Board shall meet at least twice in a year,

The Board shall regulate its own procedure (including the quatum),

No act or proceeding of the Board shall be invalid merely by reason of the existence at and vacancy therin or any defect in the constitution thereof or any irregulatity in the procedure of the Board, not effecting the merits of the case.

- 4. Duty of the Board is to advise the Govt, of Mizoram in the following matters:-
 - (a) in the selection of areas to be declared as sanctuaries, National Parks, game reserves and closed areas and the administration thereof.
 - (b) in formulation of the policy in granting licenses and permits under the wild Life (protection) Act, 1972.
 - (c) in any matter relatting to the amendment of any Schedule and
 - (d) in any other matter connected wite the protection of will life, which may be referred to it by the State Government.

The Non-official members of the Board are entitled to DA/TA at the rate admissible to Grade 1 Officers to performance of the above duties

No. LDC 6/LEG/78-79:10, the 9th Aug, '78. In exercise of the power conferred under rule 124 of the Mizoram Autonomous District (constitution and Conduct of Business) Rules, 1974, I, Shri Roma, the Chairman of the Lakher District Council regulate the following rules to be observed by the Lakher District Council for the smooth and batter Conduct of Business.

It will come into force at one till further orders or amendment, made for the Mizoram Autoremous District Council (Constitution and Conduct of Business) Ruiss 1974, by the Governmert of Mizoram.

1. SITTING HOURS OF THE DISTRICT COUNCIL

(a) ON SUMMER SESSIONS

The Council shall ordinarily sit from 10 A,M to 12 Noon and from 1 Pm to 3:30 Pm on all week-days except on Saturday, and on Saturday from 10 A.M to 12 Noon,

(b) ON WINTER SESSION:

During winter (i.e.Oct, to Feb.) the sitting hours will be from 10 A.M. to 12 Noon and from 1.Pm to 3 Pm on all week days, and from 10 A.M. to 12 Noon on Saturday

Provided further that according to the exigencies of the business, the Chairman may adjourn earlier or extend the hours of Sitting.

- 2. The Chairman shall have the power to adjourn and suspend the house, but the adjournment/ Suspension of the house for a particular time should not exceed a period of one week.
- The addition to the Rule 51 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business) Rules, 1974 there shall be two types of Question.

(a) STARRED and (b) UNSTARRED:

Any Member, wishing to ask Guestion Questions has to give separate notice of his Question, by clearly stating such type of his question belonged to unstarred, or starred, respectively.

(a) STARRED QUESTION:

Shall be answered orally by the concerned Department. Any member may put supplementary Questions to a starred Question after called by the Chairman. But the supplementary Questions to each Question should not exceed normally 5 in numbers.

(b) UNSTARRED QUESTION:

Shall be answered with the support of printed or typed copy along with the question

Such printed or typed copies of the answers to the unstarred Questions shall be laid on the tables half an hour before the Chairmay takes his seat.

Any Member may put any supplementary Question or Questions on the ordinarry unstarred Questions with the prior permission of the Chairman, presiding the Session.

- 4. While sitting is conducting in the House a member:—
 - (a) shall not read any book, Newspaper or letter except articles in connecting with the business of the House.

(b) shall bow to the Chair while taking or leaving his/her seat.

(c) shall not pass between the chair and any member speaking on the subject.

(d) snall maintiain silence when not speaking the house.
(e) The Executive Member concerned, when a matter relating to his/her port follio is under discussion in the house, shall not leave the house without the previous permission of the Chairman.
