(2) The fact of this unfortunate suffering of the villagers in the mentioned villages had been informed by me to the Government of Mizoram, recently, the Government of Mizoram sent one Joint Director and a Civil Surgeon to Bungtlang P. However, the need of the villagers had not been met since they did neither visit the above mentioned villages nor investigate what the case may be;

(3) No preventive measures and proper treatment had been taken at the time of their visit and even upto now.

Hence, it is my imperative duty to put this serious happenings in that area before this August House to discuss the said matter on the date appointed by your respectable decision.
