PU NIRUPAM CHAKMA : Pu Deputy Speaker, According to
MINISTER MVI Act, Section 17 the parking
pleasure halting station is fixed
by State Government. But in our State, we have not consti-
tuted or authorised anybody, although the Act permit us and
now the matter is deeply on consideration and we are hoping
to entrust either State Transport Authority or the matter
may be taken up in the road septic Council. This incident

will take place until and unless we make or we entrust an authority to fix the stoppage, the stands. So, that inconveniences does not arise. In regard took by vacant some incidents has taken place that the Bus Owner Association has put us some fine Bus stoppage further the fare is increased to Rs.2/- But according to previous arrangement that fare was only Re 1/- So, the government has taken step and we have instructed the Association to charge Re 1/- Meanwhile, we have also detailed one MST Bus, for a temporary arrangement and the matter is being actively under consideration.

Regarding Lunglei Bus stoppage, I had told earlier it happened everywhere. So, the Lunglei incidents also it is under this context, and will take care of this. Regarding meter Box the government is considering it and any convenience has happened to Deluxe Buses well see to it.

Regarding Kolasib it is not given and the question is throughout the State People prefer State Buses instead of these private Buses whose fare are a bit high. So, the government is taking some measure on it. Regarding Vaivakawn an Hon'ble Member of the House Pu Zosiama has pointed out, If the Association fails to comply with, we have already taken an immediate measure to stop such incidents, which is just causes inconvenience to the people and lots of complaints was there. The Government has already taken steps and we have already detailed one MST Bus. Further action will be taken.
