I am embarrassing, on my part also, that in some news papers and also one of the political party have issue the Press released in which it is alleged that Pu N.P. Chakma, Hon'ble Minister of Mizoram and some of his colleagues like Pu Hari Singh the District Council C.E.M. and some. Other leaders have gone to Delhi sometime in August and demand the U.T. Infact I am very happy today that, I have got the chance to clarify myself and mystand. Mr. Speaker Sir, since I have been alleged that I have met the Prime Minister and the Home-Minister to demand U.T. I would clarify my standard I have not done anything as such which goes to the suppression of Mizoram No, why I will do ? I will put in this way, Mr Speaker Sir, yes, I have visited Delhi and met the Prime Minister and I have spoken about the Chakmas of the Chittagong Hill tract and other Tribes in which our memorandum to be submitted to the Prime Minister clearly state.

This is our memorandum and one can see it. We have got the sufficient copy also I have not brought here. It is clearly written here and it was in the all National, almost the National News Papers. If anything as document our Hon'ble member have with them which I have submitted to the Prime Minister and Home Minister I can say that, If I have demanded the U.T. for the Chakma of Mizoram. Yes I am ready as the Hon'ble member state today, I am ready to resign myself. Yes; if you can approved this then I'll resigned. I have state sincerely, If I have done anything as such if they have document let them produced in the House and on my sincere promise I'll resign from this Ministry.

And also Mr Speaker Sir, its not only embarrass me and also my party, we have not done that I hope our honourable member and the people of Mizoram will understand this. And I hope that this kind of issue should not be just exaggerated on such reports. It should be based on some concrete documents. Without this, it is embarrassing for everybody also. If it is alleged on somebody, the name of somebody it impress everything. And to clarify on these, to make everybody mind clear, I'm here to avail whatever the sentiment the people may reach.

And also just one clarification regarding this. Mr Speaker Sir, I would sincerely say that this C.D.P. are advocating such issues. In fact, we have been trying to put them in the shadow, because if they creates us problem it will not hamper the relation between the Chakmas and other relation.

Now subject to their demand. I would like to say that, this is the party which has no political base. Just to make political atmosphere this are creating like this. I would very much sincerely say that this party was born in 1987 office the Government was took over by the M.N.F. Ministry.
