The accident appeared to have been due to drunken driving unfortunately both the Driver Pu Sangzika and the conductor Pu H.C.Lalhluna died on the spot of the accident.

PU NIRUPAM CHAKMA : Pu Speaker, Hon'ble Member Pu Tlanghmingthanga has asked about how many drunken driver are here who are driving buses. Now, it is known to everybody that there is danger when the drivers are not disciplined. And whoever is driving on a drunken mood it is a risk not for him and it is a risk not for him and it is a risk for all the passengers also who are travelling within a Bus. Now, at this circumstances, it is our duty of course to see that such irresponsible drivers should not drive such responsible buses where passengers safety is not there. Now, Department has constituted those screening committee to identify those drivers who are still acting with such behaviour. In fact, we had been advising them if they are not medically fit let them take rest. We'll allowed them to take Leave and let them go for medical check-up and Department will help them as far as possible.

Now, since the screening committee has been constituted already, I think will come to know very shortly. It is very difficult to identify because at our workshop they may drink, we cannot control them. That is why, confidentially we are looking into this and appropriate action will be taken very shortly.

In case of Kolasib buses, I have not ready reference, of course disciplinary action might have taken since I have not reference paper here, I shall be very pleased it, if the Hon'ble Members take it from my office if they desires. If appropriate action is not taken, will certainly do it.

Now we are very sorry because we are not in a position to deploy so many buses because of certain technical difficulties in a sense of certain spare parts, the buses could not be made fit. Because we only deployed those buses which are certified that the buses are wasthy for travelling it is not deployed. The TELCO Agents cannot supply us spare parts in time, then we have to make emergency purchase. We purchased only face by face. That is why, we have some difficulties with the spare parts in absence of which the buses were not fit. Very sorry for this thing happen, We will see it, next time it will not happen.

We are also very much ensure that the passengers donot feel uneasy because of this thing happening I do, request Hon'ble Members to bear with us because these are the mechanical work we cannot just see. In the evening the buses will reach Aizawl and it will be check up by the mechanic whether it is fit for running the next time. Unless this is made fit, the buses are not deployed.

I, would therefore, requested the Hon'ble Members to bear to us.

Pu Tawnluia has brought out the issue about the Lengpui Airport. There has been much talk about the Lengpui Airport now inside the Assembly. Outside the Assembly also, Among the Public also among various sections of people in Mizoram, we all want an Airport in Mizoram. Now it is our sincere desire that there should be an Airport within Mizoram. The previous Ministries have been trying all these things, but although the proposal was there, no concrete survey has been conducted till we did it very recently. That Hon'ble Member had said that the land has been earmark for the proposed Airport which is about 4 Kms away from Lengpui Village. That land which was earmark for the proposed Airfield has been surveyed by the Technical team of National Airport Authority. The representatives were taken from Mizoram Government and also representative from Border road organisation. Between 29th to 31st May 1991 that was the last survey which was conducted. According to that survey report which we received from the National Airport Authority, the Copies were given to the Ministry of Civil Aviation Union Government and also the Department of Civil Aviation Government of Mizoram. These are the report where it is indicated that shortly the land is not suitable for construction of aerodrome fit for Boeing 737 and Air Bus 320.

Now, on the 29th to 31st May 1991 when the Technical Team visited, when they had found the land was not suitable for bigger Aircraft, they were coming back with very disheartened feeling on the way. Knowing the attitude, the minds of the Technical Teams our officers have indicated some other lands because once they are not convinced that land is not suitable they may abandoned the whole proposal also.

Under that circumstances what our Governmental Officer can do, they can only suggest an alternative plot of land to kindly make a survey for the second time. That land was shown to them and the National Authority has finally asked the Border of Organisation to make a clear survey on the second proposed land. That land was surveyed and the report was sent to the National Airport Authority has finally asked the Border of Organisation to make a clear survey on the Second proposed land. That land was surveyed and the report was sent to the National Airport Authority with a copy to the Government of Mizoram and also the Civil Aviation Ministry of Central Government. According to that report, it was found that the Airport can be constructed but they want some more additional land about 500 feet. And that land is being under survey now. It is not yet completed and it is being surveyed at present. After which the report will be sent to the National Airport Authority. For their examination. Once that additional survey report is sent to the National Airport Authority, the National Airport Authority Technical team again come for Physical inspection to see physically that is spot verification.

Now, we are in a State that the additional plot of land is being under Survey, the report will be sent again. Then the National Airport Authority Technical Team once again will come to Lengpui and make a spot verification. After that only, they can say that only, they can say that whether this is fit for construction of Airport.

Now the Government of Mizoram agreed to give land free of course, Permanent electricity and also water Supply. These are the things which Mizoram Government can do. It is not our power to say that you construct Airport here, or this place, that place. That we cannot do because it is solely the responsibility of National Airport Authority to find out a land and ask Mizoram Government whether we can give it or not.

Supposing new land is found suitable, they asked the Mizoram Government to consider whether we can give that land or not. Now, we have not received any letter asking the Mizoram Government of course on the report before checking up the project, preparation of Project reports and everything, Government of Mizoram should clearly clarify whether it can provide the land or not. It is our position now.
