11:47 AM : OFFICIAL RESOLUTION

Pu LALTHANSANGA, Minister moved an Official Resolution in the following form:

WHEREAS the Parliament had enacted the Water (Prevention and Control of Pollution) Amendment Act, 2024 (No.5 of 2024) notified on 15.2.2024;

AND WHEREAS, the Amendment Act shall apply, in the first instance, to the whole of the States of Himachal Pradesh and Rajasthan and the Union Territories and it shall apply to such other States which will adopt this Act by passing a resolution in their legislative assemblies and legislative councils (if any) under clause (1) of article 252 of the Constitution read with clause (2) thereof, with effect from the date of such adoption;

AND WHEREAS, the aim of this Amendment Act is to decriminalise the provisions of the original Act “Water (Prevention and Control of Pollution) Act, 1974” [6 of 1974] to facilitate ease of doing business in the country and to streamline the process of nomination of Chairman of State Pollution Control Boards;

AND WHEREAS, it appears to this Legislative Assembly be desirable that the aforesaid Amendment Act should be adopted in the State of Mizoram by passing a resolution in this house;

NOW, THEREFORE, in exercise of the powers conferred by Article 252 of the Constitution of India, this House hereby resolves that the amendments with respect to the Water (Prevention and Control of Pollution) Amendment Act, 2024 (No.5 of 2024) should be adopted in the State of Mizoram as enacted by the Parliament.
