THE MIZORAM (REGISTRATION OF TOURIST TRADE)(AMENDMENT) BILL 2026
A BILL

to amend the Mizoram(Registration of Tourist Trade)Act,2020(Act No.2 of 2020).
Be it enacted by the Mizoram Legislative Assembly of Mizoram in the seventy-seven year of the Republic of India as follows :-

1. Short title, extent and commencement. -

- a) This Act may be called the Mizoram Registration of Tourist Trade (Amendment) Act, 2026;
- b) They shall extend to the whole of Mizoram;
- c) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of section 2. - In clause (i) of section 2 of the Mizoram (Registration of Tourist Trade) Act 2020,(herein after referred to as the principal Act). After the words “monetary consideration” the words “and may also include parks, picnic spots and other recreational centres for the purpose of this Act” may be inserted.

3. Amendment of section 55. - In the Principal Act, a new section 55 A may be inserted after section 55 as follows, namely :-
55A“Power to make Regulations. The Government may by notification in the Official Gazette, make regulations for accommodation units and restaurants which may provide for:
1. Standards to be maintained;
2. Monitoring and Evaluation; and
3. Incentives and Concessions.”

STATEMENT OF OBJECTS AND REASONS

1. *The Mizoram Registration of Tourist Trade Act 2020* : Amendment of the Forty First Schedule of the principal rules of the Government of Mizoram (Allocation of Business) Rules 2019 vide its notification No. A.46012/1/2022-GAD Dt.16th January, 2025 inserted an entry as Sl.No. 12. 'Registration and regulation of parks, picnic spots and other recreation centres outside municipal areas' under the schedule of Tourism Department, in this regard it is necessary that uniform guidelines and regulations for the said business is notified by the Government. Hence, amendment of the Mizoram Registration of Tourist Trade Act 2020 is required in order to formulate the guidelines along with the Power to make Regulations.
2. In view of the above statement, it is requested that the proposed amendment may kindly be considered.
