Zawhna & Chhanna-ah kan kal ang a. Starred Question No. 21 - Zawt turin Member zahawm tak Pu Lalduhoma i lo sawm ang u.

PU LALDUHOMA : Pu Speaker, Higher & Technical Education changtu Minister chhan atan ka zawhna -

- a) Serchhip bial bye-election neih dawn April 2021-a Chief Minister-in Govt. Serchhip College-a tlawh tuma administrative building sak thatna tur cheng nuai 1000 a tiam, NEC-a concept note leh DPR thehluh, priority list-a telh tura ruahman kha engnge a chanchin ni ta zel?
- b) Ni 14.4.2022-a Govt. Serchhip College-in A-Grade an hmuh lawm nia Chief Minister-in hemi atan veka nuai 650 a tiam leh kha tihhlawhtlin a ni ta em?

SPEAKER : Chhang turin Minister zahawmtak Dr. R. Lalthangliana ka sawm e.

DR. R. LALTHANGLIANA, MINISTER: Pu Speaker, a chhanna chu –

- a) Serchhip bial bye-election neih dawn April 2021-a Chief Minister-in Govt. Serchhip College a tlawh tuma administrative building sak thatna tur 1000 lakh NEC-a concept note leh Detailed Project Report thehluh hi NEC-in a tihhlawhtling lo.
- b) Ni 14.04.2022-a Govt. Serchhip College- in A-Grade an hmuh lawm ni-a Chief Minister-in hemi atan veka 650 lakh a tiam leh chu SASCI hnuiah kaltir niin Govt. of India approval hmuh tawh a ni a, State Govt-ah administrative approval leh expenditure sanction buaipui mek a ni. A pawisa hi Higher & Technical Education kutah awm lovin PWD kutah transfer a ni a, a hna a len avangin tender te la tih tur a beisei a ni.

SPEAKER : Awle, hemi chungchangah hian ka han sawi duh a chu, department kalphung ni lovin Chief Minister thusawi zawhna a ni a. Amaherawhchu, ram tana thawk ho kan nih avangin ka admit lui a ni a. Chief Minister thusawi ngau ngau aiah helai chhunga kan chen kha a tha zawk awm e.

Awle, *Zawhbelhna* zawt turin Member zahawm tak Pu Lalchhuanthanga ka sawm e.

PU LALCHHUANTHANGA: Pu Speaker, ka lawm e.

Govt. Aizawl College hi Sikulpuikawn atangin Mualpui Salem-ah an insawn thla mek a. Hetah hian zirlaite hian kalkawng velah harsatna namen-lo an tawk a, bus hi

pakhat chiah an nei a, bus eng emaw zat hire a ngai thin a, chuvangin, sum tam tak hi sen a ni a. Chuvang chuan, ‘Aizawl College tan bus hi a ngaihtuah sak thei ang em’ tih a ni a.

Tin, a hmun khu a zuk fianrial deuh avangin hostel an mamawh em em a. Hostel building hi pahnih - Boys leh Girls tan an nei a, mahse an in-accommodate thei lo hle mai a, building-te khu tihlen sak a, la furnish loh a ni a. Theih ang angin ka fund atang pawhin kan tuam hlawm ve a, mahse an la indaih lo hle a. ‘Hengte hi tihsak theih an ni ang em’ tih ka zawt e.

SPEAKER : Zawhna neitu Member zahawm tak Pu Lalduhoma ka sawm e.

PU LALDUHOMA : Pu Speaker, Serchhip Govt. College Administrative Building khi a far tluah-tluah mai a, awmnngaihna a awm tawh lova, chuti chung chuan A-Grade te kan han ni thei a. Amaherawhchu, tunah khian minimum faculty pawh kan nei zo lova, teaching staff-ah khian; endik leh anih hunah A-Grade hi kan chan mai ang tih kan hlau khawp mai a. Chuvang chuan, kan minimum requirement ang-ang te khi chu, Science-ah pawh tunah khian zirtirtu kan nei lova. ‘A- Grade kan nih hi a bo mai lohna turin kan Minister zahawm tak hian min rawn hriatsak thei ang em’ tih hi ka zawhna *pakhatna* a ni a.

A *pahnihna*-ah chuan, Pu Speaker, hei hi bye-election campaign lai a ni a, kan Chief Minister-in Serchhip College hi a va tlawh a, cheng nuai 1000 pek annih tur thu kha a va puang a, awm tawh saa ngaih a ni. Tichuan, an College Girls hostel kha video siam tirin college building background-a hmangin, ‘hetianga kan college min tihsaktu tur hi i vote theuh ang u,’ tiin campaign nan pawh an hmang nghe-nghe a ni.

Amaherawh chu hei, ka zawhna hmasaah khan ‘a kum lehah priority list-ah kan dah ang’ tih kha a la ni cheuva, tunah erawh chuan ‘NEC-ah a hlawhchham ta’ tih kha a ni ta a. A-Grade lawm niah kan Chief Minister zahawm tak nen kan thu tlang reng a, chutah chuan cheng nuai 650 pek tur a nih thu a puang leh a, kut kan beng leh a, ‘kumin kumtawp lamah chuan in thawk thei nghal tawh ang,’ a ti nghe nghe a ni. Tunah hian a dinhmun heti chauh hi a ni si a, kan bial hi engati nge ni *beiseina-thlawn* hi min pek reng mai ka ti a. He sum SASCI atanga lo kal hi engtik chiah atangin nge hna thawh theih tan a nih ang? Tin, ‘restricted tender ni lovin, a pangngaiin tih a ni thei ang em’ tih kha kan zawhbelh a ni.

SPEAKER : Ruling hi in phar na a, Member zahawm tak Pu BD Chakma hi ka han sawm teh ang. Ruling chu *nil* mai teh u.

PU B.D. CHAKMA : Pu Speaker, ka lawm e.

Ka Zawhbelhna chu – “Govt. Kamalanagar College hian NAAC Accreditation a nei tawh em” tih a ni e, Pu Speaker.

SPEAKER : A theih ang-ang chhang turin a changtu Minister Dr. R. Lalthangliana ka sawm e.

DR. R. LALTHANGLIANA, MINISTER: A hnuhnung ber kha a bial a hla bawk a, ka han duhsak ang a, kan chhang hmasa ber ang e.

Member zahawm tak Pu BD Chakma zaghna kha - hei hi kan buaipui nasa mai a. Tin, tunhnaia NAAC lama hnufual leh la tihloh ho hi chak takin hma kan han la tan a. A buaithlakna lai deuh hlek ka han sawi duh chu, network harsatnain nasa takin tlema hmun hla deuh hleka kan college neihte hi a effect deuh bik a, tunah erawh chuan kawng dang deuh hlek te pawhin hma kan han la chho a, improvement a awm chhoh ka ring a. ‘NAAC-ah hian kaltlang ve thei turin theihtawp kan chhuah mek a ni’ tih kha ka chhanna ni se.

Tin, Pu Chhuana zaghna, Aizawl College Mualpui-a kan han sawn chungchangah hian, a dik khawp mai a. Aizawl Govt. College building dinna saw ‘a safe tawh lo a ni’ tih kha Disaster, Management & Rehabilitation atanga kan dawn anih avangin, rang taka sawn a ngai a, sawti sawn kan han kal chho tan a. A lehlamah chuan sum, Govt. of India-in a rawn pek, NLCPR atanga kan hmuhte a ni hlawm a, a then hi chu.

Tin, transport chungchangah hian tello kha a tam em-em a, furnishing te, chulaiah chuan tlema duhthawhnaa a rawn sawi transport lam kha a dik khawp a. Amaherawhchu, sorkar anga *motor-lei* tih lampang ai mahin Aizawl City Bus Owner Association te pawh inbe tlangin, hei ZMC-ah te pawh bus vawi 8 nitin kan service tir ta a, a sawt phah khawp mai a. University-ah te pawh khatiang hawi zawng te pawh khan rang deuha ngaiantuahna lo siam te pawh kan tum dawn nia.

Tin, hostel pahnih bak han tihbelh laia kha chu kan hria ang a, a hmunhma hi enfel a la ngai bawk a, tin, project lian ve deuh hlek te pawh la siam turah kan ngai a, chutiang chuan ruahmanna la kalpui turah ngai ta ila. Tin, Serchhip, Pu Duha bial hi dik tak chuan kan duhsak ve deuh bawkin ka hria. NEC pawh hi ka sawi tel lova, tunah hian *kan hlawhchham hul-hual* tihna lampang zawng pawh a ni lova. Anni pawh hian ‘thil hi heti zawng hian han ti leh teh u a,’ tih te pawh a nei fova, tun dinhmunah zaghna hmunah erawh chuan kan la hmu lo a ni mai a. Tun dinhmunah erawh chuan kan Chief Minister-in ngaipawimawh em emin cheng nuaih 650 an dah fel a, chu chu tih tan ran te pawh kan tum turah chuan ka ngai a. Amaherawhchu works-a kha PWD-ah hian transfer anih avangin, ‘engtikah nge ni ang’ tih kha ka tan chhan a buaithlak deuh hlek a ni tih kha min hrethiam sela. A far tih laia kha, ni e, ka lo hre chiah lova heng hi chu

rang taka endik kan tum turah kan ngai a, building far te a lo awm anih chuan kan lo enfel turah ngai ila.

Tin, Faculty indaihloh chungchanga Pu Duha zawhna pawh kha, tunah hian college data – ‘zirtirtu engzat nge awm; department hrang hrangah zirlai engzat nge awm’ tih te hi kan chhut nasa mai a, hei niminah pawh kan hon. Chief Minister-in ‘a loh-theih-loh anih hi’ tiin eng emaw zat chu post ruak kan neih, pension te, thi te leh thildang tam tak kha a awm a, eng emaw zat chu min pe thei dawn niin kan hria a, kan lawm hle a. Kumthar, financial year tharah chungte pawh chu kan lo hre tel turah ngai ta ila. A dang, non-teaching staff leh thildang hi chu kawng lehlamah hi chuan kan indaih lo reng dawn te pawh hian ka hre thova. Covid-in eng emaw chen min effect avangin post ruak fill-up tur 2019 bawr vela sorkarna kan chelh tirh atanga kan han ruahman kan kalpui theilo hi min khawih-buai niin ka hria a. Kan Chief Minister hian a duhsak hle a ni, Serchhip hi; kan thik ve lek lek maw le; kan bialah chuan hetiang pawisa hi a awm miah lo a nia. Chuvang chuan, ‘a chungah hian kan lawm khawp a ni, Higher & Technical chu’ tih kha ka chhanna hmawr bawkna a ni e. Ka lawm e.

PU ZORAMTHANGA, CHIEF MINISTER: Pu Speaker, thil pakhat ka han sawi lawk teh ang.

Member zahawm tak Pu Duha zawhna kha – Ni e, a tirah chuan hetia casual taka kan han tiha ‘kha engzat vel nge ngai ang,’ kan han ti a, ‘10 crore lai chu a ngai ang’, han ti maite an awm a, ‘chuti anih chuan a mamawh ang chu kan ti ang chu, ka ti mai ang chu,’ ka ti a. Mahsela anmahni, an principal te zawk khan ‘650 in a daihin kan hria, 650 min pek chuan a tha e,’ an ti a, kha vanga kha kha sawi leh ta ka ni a. Anmahniin, ‘a daih e,’ an tih ang tak khan project pawh an lo nei a, tichuan SASCI-ah kan dah a. Tunah hian PWD-ah an rawn transfer a, tin, PWD-in a contractor pawh a thlang fel vek tawh a, tichuan, Pathian-in rem atih chuan tun inrinni ni lo, inrinni lehah hian a foundation pawh *lay* turin programme kan siam vek tawh e. Ka lawm e.

PU ZORAMTHANGA, CHIEF MINISTER: Pu Speaker, Member zahawm tak, Pu Sawivunga zaghna chhanna chu –

- a) Tun dinhmunah SEDP beneficiary hi chhungkaw 59,996 hnenah *family-oriented* SEDP (Phase I) 1st installment hi sem a ni tawh a, chhungkaw 4 (pali) la pek lohle hi Tourism Department hnuia Tourist Guide trade thlang an ni a, Tourism Department-in training an buatsaih hun laia training ve hman lo te anni. Tranining hi buatsaih leh thuai beisei a ni.

PU C. LALSAWIVUNGA: Pu Speaker, ka lawm e.

Ka Zawhbelhna chu – ‘SEDP Bu’ ti mai ila, Planning & Programme Implementation Department ina a rawn siam SEDP-Delivery System B2-ah hian, ‘SEDP tanpuina chu hlawhtlinpui tham ngei turin kalpui a ni ang,’ tia tarlan a ni a. Heta

ziak anih ang hian “cheng 25,000/- emaw, cheng 50,000/- emaw hi beneficiaries tena an hlawhtlinpui tham ngei tur nia sorkarin a ngaih avanga pe a ni em” tih a ni a.

Tin, Phase-I la dawng ve lo, mithar pek tu an ni em?Phase-I dawng tawh chhungkua kha kan hria a, khangte khan emni Phase-II dawng dawn; nge, mithar hlak?

Tin, “Social Audit system te NASA zawka hman tangkai ani ang” tih a ni bawk a.Social Audit hi engtia kalpui tur nge anih?Tin, pilot projectah chhungkaw engzatnge thlan an niha, pawisa engzat theuh nge pek annih” tih te a ni e.

SPEAKER : Zawhbelhna zawt turin Member zahawm tak Pu Zothantluanga ka sawm e.

PU ZOTHANTLUANGA : Pu Speaker, ka lawm e.

SEDP hi kan hriat angin sorkar *flagship programme* ania, amaherawhchu harsatna chihrang hrangkan han sawi taka vang khan tum ang leh amount kha a tih hleih theih lova, tunah hian ₹50,000/- a sem a ni a, installment hnih a pek tur a ni a, tichuan ‘thingtlangah a tlem’ kan tiha kan sawisel lai khan, thingtlang miten 1st instalment an hmu ringawt pawh hi an lawmpuiawm khawp mai a.Tin, thingtlang mai ni lo, keini bial angah pawh local level committee-ten information an peka ‘dil theih’ an tih khan chhungkaw tam takin an dil a.Tunah hian bial khatah mi 1500 vel kan inthlang chauh a ni.Chutih lai chuan entirnan kan veng bikah chuan ‘SEDPdawng duhte a dil theih’ an han tih khan chhungkaw 400 dawn mai khan dilna an han thehlut a ni. Chuvang chuan, khami zing atang khan 100 vel pawh kan la pe mumal si lova, Pu Speaker, khawpui chhunga miretheite hlei-hlei hian an lo mamawh niin a lang a.

Chuvang chuan, vawiina kan pek ang aia chhungkaw tam zawk, khang a mamawhte, a dilte kan pek kim theihna tur leh mirethei tam berte kan khaichhuah theihna tur atan hian chhungkaw tam zawk pek theihna tur a tan hian tun kan budget-ah hian a tam zawk dah theih a ni ang em?

SPEAKER : Member zahawm tak Pu Vanlalhlana a phar hmasa zawk tlat mai. I lo sawm ang.

PU VANLALHLANA : Kan House leader-in zawnha a chhannaah khan implementing department-ten training an pe” tih a ni a. Implementing department-te hian training an pe lova, MNF party hian training an pe zawk a ni. A dawng tur te an ko khawm a, campaign nan an hmang a, a nihna takah chuan. Hei hi an certificate, training pass certificate a ni a, chutah a in ziah danah chuan, ‘Certificate Training on Socio-Economic Development’ tiin, hming a dah ta a, “Mizo National Front General Headquarter buatsaib - Socio-economic development programme training tha takin a zo

a ni tih a entir” a ti a. Tichuan, an address, training hun leh district hming sign-tu te chu - Chairman, Socio-Economic Development Programme leh Secretary, Mizo National Front President-te anni a, hei hi an certificate chu a ni. Party hian training chu a buatsaih a, SEDP-Implementing Agency te hian training an pe lo. (**Speaker:** Engnge i zawh? I zawh turah ah lut rawh le.) Chuvangin, ‘engatinge kan House Leader hian he House-ah hian thil diklo mi a hriattir’ tih kha (**Pu Lalrintluanga Sailo:** Tuna Member zahawm takin a rawn sawi kha, party ten he SEDP a kalpui dawna kan infuihna a ni; khalai ‘training’ tih kha a ni lo. Tihlawhtling ngei tura kan duh thawhna kan infuihna a ni). A ni lo hei hi, ‘training’ a ti a ni. (**Pu C. Lalsawivunga:** House Leader kan zawt a, a niin fel takin min rawn chhan kan beisei a ni.)

Mi khawlai lengte an ko a, ‘vawk-vulh tanpuina SEDP dawng rawh aw’ an ti a, an pe mai mai a ni.

SPEAKER : A theih ang anga chhang turin kan Chief Minister zahawm tak Planning Deptt. changtu ka sawm e.

PU ZORAMTHANGA, CHIEF MINISTER: Pu Speaker, a zawttu kha pali lai ni tawh a ni a, ‘CM kan zawt a, a manlo sawifiah...’tiin a zawttu kha an lo zawhpui ve bawk a, midang pawh khan. A in *quit tawk* viauin ka hria, kha lai kha chu.

Engpawhnise, *pakhatna*-ah chuan, Pu Sawivunga, zawhna neituin a zawhbelhna, ‘hlawhtlinpui tham a ni em’ tih kha - Rs. 25,000/- chu ni lo ve, hei hi chu financial year khata kan pekchhuah tur chanve a ni a, 1st instalment chauh a la ni a, hlawhtlinpui tham a la nih loh zia chu, ‘1st instalment a ni’ tina na na a, zawhbelh chi pawh a ni em maw ni le ka ti hial a. Chuvangin, tun financial year-ah 2nd instalment, Rs. 25,000/- dang kan pe leh ang a, 50,000/- a ni ang. Chu pawh chu hlawhtlinpui thamah kan ngai lo a, pek belh zel kan tum a ni.

Tin, “*phase 2*-na an dawng leh dawn em’ tih kha - Dawng leh dawn e, a sanction pawh kan ti fel vek tawh a, a cash an lak chhuah hunah an account-a dahin *phase 2*-na hi pek turin financial sanction pawh pek vek tawh a ni.

Tin, ‘mithar pek tum a ni em’ tih hi - heta mi ‘sing ruk’ ti mai ang, (pali-in an tling lova,) mi sing ruk-te nilo hi chu financial year than atan a ni ang. Tun, financial year-ah hian, ka sawi ang khan mi sing ruk a cover a; financial year a tawp a, a than sanction-na hman pawh a awm tawh lova. Amaherawh chu, financial year than a intan mai dawn a, mi sing ruk-te eng emaw zat pek belh kan tum bakah, a tharin sing eng emaw zat chu kan la leh dawn a ni.

Tin, ‘Social Audit engtia kalpui tur nge’ tih kha – nakinah Social Audit titu ten an la rawn ti anga 1st instalment kan pe a, second pawh a lalut hman lova, Audit-na

hman pawh a la awm lova, training-na hman pawh a la ni lova, an dawng deuh chauh a ni a. Chuvangin, 2nd instalment an dawng ang a, tichuan anmahni trade thlanah a tul angin training pawh a department-ten an ti zel ang a. ‘Training pek’ tih kha chu, kan sorkar hmaa party-in kan lo in-training vena kha a ni a. Tunah pawh training chu a department-in an pek bakah midangin a inpuih theih ang ang chuan, inzirtirna chu tupawhin lo ti se, kha kha chu a welcome-awm tho e. Amaherawhchu, ‘tuna training kan sawi kha a ni lo e’ tih ka han sawiduh vea ni.

Tin, Member zahawm tak Pu Zothantluanga’n ‘a tam zawk dah theih a ni ang em’ a tih kha, sing ruk tuna kan pek pangngai bakah financial year tharah chuan (a zat chiah chu kan sawi thei lova) sing-bi chu dahbelh leh ngei kan tum tih kha ka chhannaanie.

Tin, Member zahawmtak Pu Hlana zawhna kha chu, ‘party training lo pekna kha a ni a, a hna tak tak an han tan chuan, a department ten an trade thlan theuhah khan a tul ang zel leh mamawh angin training pawh an pe zel dawn a ni.

SPEAKER : Starred Question No. 23 - zawt turin Member zahawm takPu ... (interruption)

PU L. THANGMAWIA : Pu Speaker, ka lawm e.

Higher & Technical Education Minister zahawmtak chhan atana ka zawhbelhna chu –

Pathianthu (Theology) lam zir ho hian scholarship hi an dil thei lovin ka hria a, hei hi eng eng emaw UDISE lama tihfel ngai awm ni tein ka lo hre deuh a. Tunah hian a then hi chu Kohhranin chawm mah sela, tunlai Pathianthu zir thenkhat hi chu chhungkaw harsa ve tak, ‘scholarship la ve se’ tia duh sak tak turte an lo ni chho tan tawh a. Baptist Kohhranin hetah a nei bawk a, tin, Presbyterian hnuaiyah ATC a lo awm bawk a. Henga zirlai tena scholarship an lak ve theihna tur hian ‘department lam atanga hmalakna a awm tawh em’ tih kha ka zawhbelhna a ni e.

Tin, Pu Speaker, a *pahnihna*-ah chuan, *by-election* kan sawi ta sa sa a, by-election lai khan, “MLA ka tlin chuan, Thenzawl-ah college ka din ang,” tih kha, kan din ta em le?

SPEAKER : Kha kha chu a chhan theihloh. Awle, a theih ang anga chhang turin Minister zahawm tak, Dr. R. Lalthangliana ka sawm e.

Tun tum kan session-ah hian Higher & Technical lama tui tur chi hi kan ngah riau a, a lawmawm a. Hemi ‘Theological College’ kan han tih, Pathianthu zir bik tana *provision* hi a la awm silova, an buai khawp mai a, anni kan MLA zahawm takte pawh khan theihtawp chhuahin tan min lak pui ve a, khawi lai source atang te emawin tihdan kan han dap ve a. Tum khat phei chu ka room-ah han inrawnkhawmna te pawh kha kan lo nei tawh nghe nghe a, nikum lam khan. Engpawh nisela, hei hi ‘ngaihtuahna kan seng ve mek a ni’ tih kha ka chhanna ni sela a tha awm e.

Kar kal ta maiah khan *posting order* kha tihchuah nghal a ngai a. Kan rilruah chuan, ‘principle nghet tak neia kan tih a ngai a ni’ tih vawi tam tak kan sawi tawh a, chutiang chuan posting order hi kan siam a. College tam tak Aizawl khaw pawn hla tak taka awm te’n kum 20 te, kum 15 te hrisellohma leh eng emaw chhan dang neite kha member zahawm tak tak ten an rawn sawi sak thin a, ‘Aizawl lam emawa lakluh ve theih ni se’ tih te, khatiang ngenna kha a tam khawp mai a. Tichuan, college hla tak taka lo thawk tawhte kha kan lalut a, a order a chhuak tawh a, chung zingah chuan Mamit a awm pawh kha a lo tel ve a, NGO te leh bialtu MLA te pawhin an rawn sawi a. Engpawh nisela thil pakhat kan tih chu an zawm phawt

ang a, helaiah hian eng emaw rationalize hlek ngaite kan nei a. Hei, nimin piah atangin Hrangbana College naupangte pawhin *sitting-demonstration* an han neihna chhan pawh kha, khangte pawh kha a ni tel ve a, engpawh nisela, helam phuhrukna tur atan hian harsatna *rationalization* hi tunah hian kan han ti chho leh mek a. Amaherawhchu, order chhuak tawh tihdanglam buai-buai ang chi hi chu a floodgate kan hawng thei a, tih a remin kan hre lova. Sorkar hi kan dinnaah hian kan la *stand rih* a, rei lutuk lovah eng emaw khatiang college ina harsatna a tawk bik ang chi kha, ‘kan hria e’ tih kha kan sawi duh a ni.

Amaherawhchu, han laka han tih mai dawn khan harsatna kawng hrang hrang kan la neih avangin kan inpui thei mai lo lai erawh chu hrehawm ka ti ve tho mai a. Engpawh nisela, hei hi official level-ah pawh hian kan sawi chamchi a, tin, rawtna te pawh kan han siam chang a awm a, kan la paltlang theih chiah lova. Pathian-in hun remchang tha zawk min siamsak ang a, chung hunah chuan kan tih theih te pawh beisei ta ila a tha awm e. Chuvang chuan, Mamit College a Science zirna hrim hrim neihna tur atan hian committee kan ko a, nikum August Ni 22 khan; chutah chuan, ‘College Development Council’ kan ti a, MZU-a kha lam bik enkawltu Professor pawh a rawn tel a, minute pawh fel takin a rawn ziak a. Hetah hian ‘aspirational district’ anih avanga ngaihpawimawh a tul thu te leh, sum mamawh tur hi a hautak khawp mai a. Chutah chuan kum khatah cheng nuai 88 bawr velin a rawn chhut a, tun dinhmunah hian chuan han kalpui kha a harsa deuh a ni tih kha ka sawi mai duh a ni. Ngaihtuahna chu college bil bikah pawh hian kan seng a ni. Hei, ‘a minute pawh min rawn pe e’ tih kha Pu Speaker, ka chhanna a ni e. Ka lawm e.

Kan sorkar chak tak leh a enkawltu minister zahawm takin thahnem ngai takin Reiek tlangah, (Aizawl-a mi tena kan in ang tho hi) khulai Dihmunzawl atang khuan min pump-chhoh sak a ni a, a lawmawm hle a. Chutih ruala ka zawh belh duh chu, Pu Speaker, he tui pump khawl kan dah hi duh angin department lam hian a tui sem tur mipui hnena tleng turin an pump tam tawklo niin a lang a, hei hi ‘a khawl thatloh vang nge nia, thawktu indaihloh vang’ tih ka zawt a. Tin, a khawla hian duh angin a pump theih hun tur, a tira an sawi ang hian an pump lo niin ka hria a. Hei hi endik theih nise a lawmawm khawp ang.

Tichuan, Dihmunzawl atangin Tlawng ralah gravitation-in Puankhai bawr vel (a hming chiah kan hre ta lova) atang khuan kan pump chho a. Reiek-ah kan pump chho a, chu chu Reiek-in an tlan a. Reiek-a tlingkhawm chu Ailawng-ah hian a luangthla leh ang a. Ailawng khu a lo sang deuh zawk a, Reiek ai hian. anih dawn chuan, Autonomous District Council hi Land Rights a hrana nei kan nih avangin, “it extends to the whole of Mizoram, (except Autonomous District Council area)” tia dah awm ve awm tak a ni a, Pu Speaker. Chuvangin heath hian Autonomous District Council pathumte hi exclude ni thei se ka duh a, he amendment-ah hian. A chhan chu, CADC area, Kamalangar-ah SSB in ram an lei a, an la in hand-over lo a. Tin, Autonomous Council Area hi exclude a nih loh chuan State Revenue Department nen contradiction a awm hlauhawm a. Chuvangin, hei hi chu khawngaihin chiang takin ‘except Autonomous District Council’ tih hi dah belh ni se tih kha ka ngen duh a ni. Pu Speaker, ka lawm e.

PU C. LALSAWIVUNGA: Pu Speaker, ka lawm e.

Lalzirliana; Pu C. Lalrinsanga leh Dr. Lalhangliana, kan Minister zahawm takte, Pu KT Rokhaw leh Pu Nihar Kanti Chakma leh, kei te kha vawiin nia ka hriat theih mai chu a ni a, sawi-hmaih te pawh ka nei mai thei a.
