Member zahawm tak, Pu Vanlalhlana zawhna LPG subsidy chungchangah khan department lam chuan thuchhuah te pawh kan nei tawh a. LPG subsidy an rawn pek let loh avanga harsatna nei chu department ah te, distributor te hnenah te hriattir thin tur tiin thuchhuah te kan siam tawh a.
