Aw le, vawiin ah Member zahawm takte - Pu Lalmuanpuia Punte, a zin avangin vawiinah kan zingah a awm thei dawn lova. Chutiang bawkin Pu Lalthansanga, Member zahawm tak hi damlohma avangin; House ka han hriattir e.

Vawiin chu business a tam riau mai a, memberte'n hun hman kan thiam deuh dawn nia.

Tunah chuan, *Zawhna & Chhanna* ah kan kal nghal ang a; *Starred Question No. 81* - zawt turin Member zahawm tak East Tuipui Bialtu Pu Ramthanmawia ilo sawm ang.

*Starred Question No. 81* - *Power siam chhuah chungchang.*

**PU RAMTHANMAWIA :** Pu Speaker, ka lawm e. Hon. Minister zahawm tak Power & Electricity Deptt. changtu chhan a tan ka zawhna –

“Tun Sawrkar-in power siam chhuah kawnga hma lak chhoh a tum dan min hrilh thei em?” tih a ni.

**HON. SPEAKER** : Chhang turin P&E Deptt. changtu Minister, Pu F. Rodingliana ilo sawm ang.

**PU F. RODINGLIANA, HON. MINISTER** : Pu Speaker, ka lawm e.

Mizoram sawrkar-in hydro-electric power policy tha tak a lo duan tawh zul-zuiin, hydro-electric project thawh tum te, power an thawhchhuah tur beisei zat te fel taka ruahmanna nen chak taka hma lak mek a ni. Hydel project bikah tunah hian small hydro-electric project, power pechhuak thei 15 kan nei mek a, a vaia an thar chhuahtheih chu 38.55 mW a ni. Amaherawh chu, power a siamchhuah theih zat hi khaw awmdan a zir zelin danglam reng thin a ni. Tin, heng small hydel project zinga thenkhatte chu a thuamthat hna thawh mek a ni. Power tharchhuah kawngah hydel project siam belh tuma hmalak mek a ni a, chung te chu –

1. Tlawng HEP (120 mW) Near Lungleng – Hei hi Survey & Investigation (S&I) tih mek a ni a, Detail Project Report hi 2024 chhungin zawh hman beisei a ni.
2. Tuivai HEP (150 mW) near Ngopa.
3. Tuirini SEP (24 mW) Near Sesawng, hengte hi S&I tih fel tawh a ni a, DPR pawh peih fel tawh sa a ni. A thawhna tur sum ngaiantuah mek a ni.

Solar power siamchhuah lamah pawh sawrkar chuan theih tawp a chhuah mek a. Tunah hian *Grid connected SPV Power Plant (Solar) 10 mW near Thenzawl Village* hi hna thawh tan mek a ni. Tunah hian sawrkarin power siamchhuah kawnga hma lak chhoh a tum dante chu: -

1. Thenzawl Solar Plant (20 mWP) - PPA sign tura hma lak tum mek a ni.
2. Sumsuih Solar Plant (5 mWP) - State plan atgangin thawh tum a ni a, administrative approval pek chhuah tawh a ni.
3. Keifang Solar Plant (10 mWP) - PPA Mizoram Energy Development Agency (MEDA) te nen sign tawh a ni a, hmalak mek a ni.

Pu Speaker, ka lawm e.

**HON. SPEAKER :** *Zawhbelhna* zaws turin a zawnha neit East Tuipui Bialtu zahawm tak Pu Ramthanmawia ilo sawm ang.

**PU RAMTHANMAWIA :** Kha, kan Minister zahawm takin hmalak a tum dan turte kan han hria a. Tin, a then kha chu sawrkar hmasa hmalakna lo kal chho zel chhunzawmna tur ni tein ka hria a, lawmawm hle a ni. Ka *Zawhbelhna* chu Pu Speaker, hei hi a ni –

- i) “Mizoram-in power-a intodelh turin mega-watt engzat nge tunah hian kan mamawh?” tih leh;
- ii) “State danga atanga lakluh nan hian sum thlakhatah engzat nge a sen thin?” tih te a ni e. Ka lawm e.

**HON. SPEAKER :** *Zawhbelhna* zaws turin Champhai North Bialtu zahawm tak Pu H. Ginzalala ilo sawm ang.

**PU H. GINZALALA :** Pu Speaker, ka lawm e.

Champhai khawpui hian power lamah harsatna kan nei ve thin a, a bik takin furah te. Chuvangin, Khawzawl 132 kV sub-station atangin 132 kV (alternate line) hi sawrkarin min ngaithuah sak thei em?

A dawt lehah chuan, Kawlbem hydel project-a power evacuation line hi Hnahlan tlangdung chawm turin 33 kV line in sawrkarin min ngaithuah sak thei ang em? Pu Speaker, ka lawm e.

**HON. SPEAKER :** *Zawhbelhna* dang zaws turin, Palak Bialtu zahawm tak Pu K. Hrahmo ilo sawm ang.

**PU K. HRAHMO** : Pu Speaker, ka lawm e. Ka *Supplementary Question* chu hei hi a ni e – “Tuipang Lui mini-hydel project hi hman theih loha a awmna a rei tawh a; kan sawrkar thar hian hman tlakin repair tumna a nei em?” tih a ni e.

**HON. SPEAKER** : A theih ang anga chhang turin kan Minister P&E Deptt. changtu Pu F. Rodingliana ilo sawm ang.

**PU F. RODINGLIANA, MINISTER** : Pu Speaker, ka lawm e.

Tuipui Bialtu Pu Ramthanmawia rawn zighthna – “Mizoram-in power a intodelh turin hmalakna a nei em?” tih kha, hmalakna a awm nual a, solar leh hydro te kan target bik a. Tin, *rooftop-solar* a kan budget-ah hian mega-watt eng emaw zat khawpui chhung bik atan kan nei a. Tin, hydel project ah hian theih tawp kan chhuah a lui target bik kan nei a, nichina ka rawn sawi tak ang khan heng pathumah te hian target kan nei leh zual a. Tlawng Lui hi tun kuma peih tura beisei a ni a, amaherawh chu Mizoram hi lirnghing zone 5-naa kan awm avang hian project hmasa kha tlema tihdanglam a ngai a, kan tum angin hma kan la chak theih lova. Amaherawh chu, hei tuikhuah mai nilovin Mizoram-a tuihna lo tlem telh telh tih ziaawmna tur Aizawl khawpui chawmna atan te pawh tih kan tum a. Khawpui chhungin tui a mamawh mai bakah sangha khawi nan leh tourism attract-na tur te pawh kan han ruahman a. Tin, Tuivai hi 210 mega-watt a ni a, sawrkar hmasa lo ruahmannaah chuan. Mahse, uluk zawkin kan han zir a, forest leh thil dang dangah 115-a tihhniam kan tum a. Hei hi tunah hian project report te pawh revise leh mek a ni.

Tin, Tuirini hi, Pu Speaker, tlem ka han sawi zau duh deuh a. Kan ram lui hi Tuirial anga kum 100 mi ram tana han pek kha kan ui deuh hlek a. Chuvang chuan, kan agreement han sign pui tur leh midang kan han biakah te pawh, State thenkhatin an lo tih angin ‘35 years hi ni se; kan agreement sign ni atanga chhiar tan ni se’ kan ti a. chung avang chuan, investor thenkhat kan han biakte pawh tlemin an lo zirchiang ve leh a. Tuna Tuirial ang khu chuan heng kan han sawi te pawh hi khuap turin investor te pawh kan hmu nual a. Amaherawhchu, Pu Speaker, policy kan lo neih tawh khan kan lo zirchiang a. Chuvangin, kan ram luite hi keimahni, a ram neitu, (son of the soil) te kan ta a nih ran theihna tur kawng kan duh avangin investor kan hmu thenkhat te hnenah pawh hian Tuirial te hi chu kan phal loh thu kan hrilh thin avangin 12% chauh nei a kum za chuang an neih hi kan phal lova. Chuvangin, investor te pawh an in-ennawn leh a, an offer hi sawrkar angin kan la pawm thei lova. Sawrkar angin kan offer ang te kan han pechhuak zawk a. Tunah pawh hian company 4-5 te pawhin inbe leh turin min rawn bia a. Kan duh dan kan thlen a, an duh dan an rawn thlen leh ang a, chuta tang chuan kan la insiam rem turah kan ngai a ni.

Kan sawi tak ang khan kan ramah hian solar siam duh an tam khawp mai a, chu chu tunah hian ngaihtuahna thar kan nei a. Kan solar hi chhunah chauh a hman theih a,

zanlam *peak-hour* laia kan hmana, kan electric chawkluh kan tihtlem theihna tura tan hmalakna kan nei a, chu chu battery system a ni a. Heng *battery system* te pawh a guarantee hi thla 6 vel a ni a, tuna company kan biak ho hi chu a lifetime kum hi 15 leh a guarantee kha kum 5 te a ni a. Chungte chu policy kan han duan thar leh technology-a hma kan lakna te a ni. Tin, a sawrkar ang pawh hian theih tawpa keimahni budget hmanga hmalak kan tum a ni.

Tin, Champhai Bialtu zahawm tak.... (*interruption*)

**PU RAMTHANMAWIA :** Pu Speaker, ka zawhbelhna kha pahnih a ni a, min chhang miah lova. “Mizoramin power intodelh turin megawatt engzat nge kan mamawh?” tih leh, “State dang atanga power lakluh nan hian thla khatah sum engzat nge kan sen thin?” tih te kha, min chhan theih chuan.

**PU F. RODINGLIANA, HON. MINISTER:** Power-a kan sen thin tlangpui chu, thla khatah ₹37,00,00,000 - ₹33,00,00,000 ang vel a ni a. Tin, power kan la mamawh zat hi tunah hian 156 mega-watts vel a ni a. Hei hi ‘peak hour’ kan tih a ni a. Kha kha kan han chhan theih dan ni ta se. Tunah hian hma a sawn zel a, hengte pawh hi la thang zel turah kan ngai a. Tuma kan mamawh chu kha kha niin ka hria.

Champhai Bialtu Pu Laltea zawhna, Kawlbem chungchang kha - Kawlbem hi 4 mega-watts chauh a ni a, a-chheh vel chawm tura ruahman a ni a. Tuna a rawn sawi ang kha chu, kan han en leh ang a, a theih chuan hmalak dan kawng a awm leh awm loh te kan lo inzawt chiang dawn nia.

Tin, 133 kV hi duh duhna laia han pawh mai theih a ni lova, a chhan chu -*norms* a awm a, norms zawm chunga hmalak tur a ni a. Khami norms kha kan zawm loh chuan, keimahni State-in thuneihna kan nei lova. Chuvang chuan, hmun hrang hranga tuna power indaihlohma te pawh hi RDSS scheme hmanga hmalak tum a ni. Chu chu tunah hian *Survey and Investigation* tih mek a ni.

Pu Hrahmo zawhna Tuipang hydel project chungchang kha - tunah hian *trial-run* tih leh a ni a. ‘Kum rei tak hlamchhiah’ a tih kha, a dik a, tunah hian tui awm velah *trial-run* tih leh tura hmalak mek a ni. Pu Speaker, ka lawm e.

**HON. SPEAKER :** Kan House Leader khan comment duh a nei em aw? Ilo sawm teh ang, khawngaihin.

**PU LALDUHOMA, HON. CHIEF MINISTER:** Pu Speaker, ka lawm e.

Kan luite hi khuah vek kan tum lova, kan ram environment a tihchhiat hi kan phal lova; amaherawhchu, kan mamawh bawk si a, eng emaw zat hi chu a tih loh theih loh a. Tin,

tuna kan project thenkhat hi compensation avang leh forest clearance avanga chhunzawm theih loh kan nei a, chung zingah chuan Chhimtuipui - Kolodyne project pawh a tel a ni.

Tin, Tuirini-Small hydel project chungchang hi han sawifiah deuh hlek ka duh a. 24 mW chhuak thei tur a ni a. Hei hi *externally-aided* project atangin New Development Bank-in a min finance tur a ni. Soft-loan a ni a, a pung pawh hi 1.25% chauh a ni a, a tha hle mai a; kum 19 chhunga neih tur a ni. A DPR hi March, 2007-ah daih tawh khan buatsaih a ni a. A kal zel, a kal zel a; tichuan, 2022-ah khan ₹584,00,00,000 ngai tura chhut chhuah a ni a. A consultancy service pawh hi ‘a thlawnin min rawn pe thei a ni’ tih kha an rawn hrilh a. Tichuan, kan inthlan hma lawk, November thla chho vel khan kan sawrkar hmasa khan a lo drop ta a ni.

Hei hi kan ui em em a, chuvang chuan, tunah hian tihnuh leh tumin hma kan la a, ‘kan revive leh thei ang em’ tih chu kan chiang chiah lova. Amaherawhchu, kan indawr leh tan mek tawh a; tih theih hram ni se kan duh a. Tin, a that em emna chu - a vaia power lo chhuak tur hi kan ta tur a ni. Chutiang chu a nih avangin, tih hmanhmawh kan duh hle a ni. Tin, India leh foreign atanga min rawn dawrtu ka nei neuh neuh a. kan Serlui te pawh khu min tihpun sak thei, ‘khuah belh ngai lova tipung thiam kan awm e’ te pawh an rawn ti a. Tin, kan project hluihlawn tawh te pawh ‘kan ti thar leh thiam a ni’ ti te pawh an awm a. Chung chu ngun takin kan exam mek a ni.

**HON. SPEAKER :** Tunah *Starred Question No. 82* - a zawt turin Hachhek Bialtu, Member zahawm tak Pu Robert Romawia Royte ilo sawm ang.

**Starred Question No. 82 - Autonomous District Council internal affairs chungchang.**

**PU ROBERT ROMAWIA ROYTE:** Pu Speaker, ka lawm e. District Council & Minority Affairs Department changtu zahawm tak chhana tan, ka zawhna chu - “Tun hnaia Sawrkar thar din hnuah Autonomous District Council pathumte internal affairs (an chhungkaw rorelna) chungchangah Governor thupek ni lovin DCMA Department a inrawh em?” tih a ni e.

**HON. SPEAKER :** A chhang turin District Council & Minority Affairs Department changtu Minister Pu C. Lalsawivunga i lo sawm ang.

**PU C. LALSAWIVUNGA, HON. MINISTER:** Pu Speaker, ka lawm e. Hachhek Bialtu MLA, Pu Robert Romawia Royte zawhna chhanna chu hetiang hi a ni - “Autonomous District Council pathumte internal affairs (an chhungkaw rorel) chungchangah Governor thupek ni lovin District Council & Minority Affairs Department a inrawlh hriat a ni lo” tih a ni e.

**HON. SPEAKER :** Zawhbelhna zaws turin a zawhna neitu Pu Robert Romawia ilo sawm ang.

**PU ROBERT ROMAWIA ROYTE:** Pu Speaker, ka lawm e.

Kan hriat theuh angin *Autonomous District Council* pathumte saw India Constitution *6<sup>th</sup> Schedule* hnuai thuneihna hrang nei an ni a. keini hi *7<sup>th</sup> Schedule* hnuai State-sorkar chuan thu kan nei a. Chutiang chuan, anmahnia inrelbawla rorelna fel tak te pawh nei an ni a. Tin, anmahni chhungkaw chungchanga an inrelbawlna tur ‘CCB Rules’ kan tih mai thin *Constitution & Conduct of Business Rules* te pawh kha an nei a.

Tichuan, tun hnaiah hian beisei loh takin (kan hre vek nge, kan hre vek lo ka hre lova) kan House te pawh hian Pu Speaker, kan hriat a tulin ka hria a. Kan member zahawm tak Pu Rasik Mohan Chakma hi CEM ni chunga MLA ni bawk laiah hian *office of profit* dan bawhchhia ang deuha puhin show-cause notice pek a ni a.

India Dan-pui kan en chuan, *office of profit* chungchang hi Article 191-ah disqualification dan phung a inziak a. Tin, a disqualify dan tur chu Article 192-ah chiang takin a inziak a. Pu Speaker, i remtihnain – ‘office of profit chungchanga in disqualify tur chuan, Governor-in a ti thei a. Mahse Governor khan ECI approval a lak a ngai a ni’ tih hi hi chiang deuha ka hriatna chu, keima chungchangah pawh kan ZPM unaute’n *office of profit* bawhchhia angin Governor-ah complain an thlen a; Governor-in ECI ah an thlen a; ECI-in ruling fel tak *judgement* a rawn siama thiam ka channa te chu kan hriat vek kha. Tin, kan Sawrkar chungah pawh hian dan angin Governor thuchhuak leh ECI thuchhuak gazette copy-a min chhuahsak te kha ‘ka lawm khawp mai’ tih te kan sawi tel duh a.

Chuvang chuan, Pu RM Chakma hnenah show-cause notice hi DCMA Department-in a pe tur a ni lo ang. ‘An lungawi lova, tihsual te a nei a nih chuan, a thlenna tur dik takah thlen tur a nih hmel e’ tih kha kan sawi duh a.

Chutiang tho chuan, tunhnaiah LADC CEM Pu V. Zirsanga chungchangah pawh show-cause notice nge ka hre chiah lova, hemi court decision bawhzuiin DCMA atangin hriattirna nge, (show cause notice tho maw?) Pu Speaker pek a ni a. Hei hi DCMA hian show-cause notice, eng emaw lungawilohna a nei anih pawhin an chairman ah zawk thlen tur niin a lang a; LADC Chairman-ah. Chutah Chairman chuan a rawn duh chuan, Governor-a rawn tur a ni. Chuvang chuan, heng show cause notice han inpeka, ‘DCMA inrawlh lo’ tih hi, ‘Governor inrawlhna ngeia tih a ni em?’ tih kha kan zaws nawn leh teh ang. Zawhna chhannaah kha chuan - ‘Governor-a inrawlh lo’ tih a ni a; ‘a hriatpu lova tih a awm ngai lo’ tih a ni a. Heng case pahnihah hian, ‘Governor hian ama thua tih a ni em?’ tih kha kan zaws nawn leh duh a ni. (*Member tu emaw, ‘A zaws dawn nge,*

*thu a sawi dawn?’ tiin a lo inrawlh a..) A thu zir hian han sawi ve deuh ngai te hi a awm ve a; hriathiam hram hram a ngai a nia. In minister bill-ah pawh i sawi ve tho kha ..*

**HON. SPEAKER :** Ngawi teh u; ‘Governor-in a hriatpui em?’ tih kha a ni maw, a zawhna ber chu? District Council chungchang a ni a, kan Assembly hian thui tak kan sawi theiloh te pawh a awm mai thei. Engpawh ni se, *Dan leh Dun* lampang kaihhnawih thil a ni a, hetah hi chuan thui tak kan sawi thei lo mai thei a. Zawhna chu a chiang e – “Governor-in a hriatpui em; DCMA-in show-cause notice a pe em?” tih a nih kha.

*Zawhbelhna - Pu V. Malsawmtluanga, Lunglei North Bialtu zahawm tak i lo sawm ang.*

**PU V. MALSAWMTLUANGA:** Pu Speaker, ka lawm e.

Ditrcit Council & Minorities Affairs Department changtu kan Minister duhawm tak Pu C. Lalsawivunga chhan atan a ka zawhbelhna chu –

“Mara Tribal Hostel Delhi a sak tur *Article 275* hnuiaia sum sanction tawh nuai 700 chuang, a hmun pawh MADC-in anmahni suma an lo lei tawh kha eng tika sak tan tur nge?” tih laia kha ka zawhna a ni e. Ka lawm e.

**HON. SPEAKER :** *Zawhbelhna - Lawnglai West Bialtu, Member zahawmtak Pu C. Ngunlianchunga ilo sawm ang.*

**PU C. NGUNLIANCHUNGA:** Pu Speaker, DC&MA Minister zahawm tak changtu hnena zawhbelhna chu –

“DC&MA Department hian ADC te hnenah aikal chhawr leh chhawr loh chungchang DC&MA-ah report turin a hriattirin, *zawhna* a zawt em? Zawt ta se, eng dan tlawh chhanin nge a zawh min hrilh thei em?” tih a ni a.

Pahnihnaah chuan, Dt. 7.2.2024 Pu Speaker, i phalnain - Deputy Secretary lehkha *Memo No.A.60011/1/2019/DC&MA* hi chhang lo ta se, DC&MA hian engtin nge a tih dawn; kha aikal report tura DC&MA-in District Council hnuiaia staff-te aikal awm leh awm loh zawhna kha?” tih kha ka zawhbelhna a ni e.

Nichina kan ngaihthlak kha, Pu Speaker, tlemte Ka han sawibelh lawk ang a - Sawlai Autonomous-te saw *dan* hran neia ding an ni a, ‘*subject* an nei ve a ni’ tih hi kan hriatsak a pawimawh khawp mai a. Chuti ni lova, helai atanga *department pakhat* ang maia kan ngai a nih chuan a fel lovin ka ring a. “Autonomous Council-te hi India Dan-pui hnuiaia rorelna hran nei an ni ve a ni” tih kan hriatsak fo a thain ka hria; khalai kha ka zawhbelhna a ni e.

**HON. SPEAKER :** A lawmawm e. Theih ang anga chhang turin District Council & Minority Affairs Department changtu Minister, Pu C. Lalsawivunga ilo sawm ang.

**PU C. LALSAWIVUNGA, HON. MINISTER:** Pu Speaker, ka lawm e.

A zighthna neitu Pu Robert Romawia Royte zighthbelhna kha chu helai kan chhanna atang khan a fiah felfai viau mai a. ‘Governor thupek ni lovin’ tih khan engkim a chhang fiahin ka hria a. Chuvang chuan, Governor hriatpuina ang zelin kal a ngai a.

Tin, Pu Rasik-a chungchangah pawh hian eng emaw clarification ‘Governor-in a mamawh angin kaltir a ni’ tih kha ka chhanna ni ta se la. Tin, Lunglei North Bialtu zahawm tak Pu V. Malsawmtluanga zighthna kha, Mara Autonomous District Council tan *Girls Hostel* Delhi-a sak tur chung chang kha a ni a, kha kha anmahni hmalakna liau liau a ni a. Hma an la a, amaherawhchu, hnathawh theih a lo nih khan harsatna a awm a, a thawktu tur chungchangah. Tichuan, thawh theih lovin a awm reng a; Sawrkar thar a lo piang a. Hemi hma kum 2001, March Ni 23 khan, khatih laia House member (tuna chatuan ram min pansan tawh) Pu C. Sangzuala khan "*Mizoram Internation Border Fencing siam turin Central Sorkar-ah thlen ni rawh se*" tih Private Member Resolution a lo putlut tawh bawk a, he House zahawm tak hian a lo passed tawh bawk a ni.

Engtizia emaw ni, hnam party-a invuah, party office-ah pawh '*Hnam Run*' tia chhal ngat te hian chhak leh tleng ramria kan unaute nena zalen taka kan inkalpawhna hi an lo ngaimawh em em a ni mai thei a. Hemi hma kum 1826 khan British-in Burma a run a, *Treaty of Yandabo* chu kum 1826, February Ni 24 ah ziah a ni a, hei hi British-in Burma ram a awp tan kum a ni. Burma rama chengte'n sapho awp nih chu an duh bik hauh lova. Kum 1852 leh 1885 ah *Anglo-Burmese War* vawihnih a awm a nih kha. He agreement hi Parliament lamah dan siam thaan delhkilh a ni lova, *gazetted notification* tihchhuah pawh a awm chuang lo; guideline erawh mumal taka siam a ni a, Ministry of Home Affairs hnuiaia *meeting minute*-ah te, ram-pahnih inbiak tawnna lehkhaah te chuan, '*Free Movement Regime*' tih tawngkam hi chu hman a ni thin. Free Movement Regime a nih khan zalen takin khawlai ang maia '*duh duha inkalpawh theih*' tihna a ni lova. Ni 5.11.2003-a siam tawh guidelines-a a landan chuan, ramri hnaia awm, Sawrkar hminga phalna siamsaktu ruat a ni a, ramri kan duhte chuan phalna an la tho thin a ni. Ngun taka ngaihtuahin, hengte hi chhuanlam tling niin a lang lova, National Security ngaihpawimawh ni se, Myanmar nen chauha FMR kan neih hi titawp lovin, Nepal leh Bhutan nen kan inkara passport leh Visa tel lova inkalpawhna pawh hi an titawp ve tur ni awm tak a ni. Chutiang bawkin, India in ramri a neihpui zawng zawngte - China, Pakistan, Bhutan leh tuifinriat vaukam a neih zawng zawng pawh hi hung vek tho tur ni awm tak a ni a. Hetia duh lai bik te chauh thur chhuaka selective-fencing tih hi, National Security vang lam ni lovin, India Sawrkar hian a khua leh tuite zingah 'rehawm taka hrem duh hnam bil a nei ta a ni mai awm mang e' tih palh awl a ni.

International border fencing hi zero-line atanga meter 137 huam chhungah hung tur a ni a, Myanmar nena kan inrina India ram rualrem loh zia a hmuna hmutu ka ni ve a. A rem lai laiah fencing tih a ni ang a, India ram zau tak kan chan ang. Kan ram lam chan - Tiau Lui kama zawl zau tak, buh leh thlai hmun chu hung pawnah a awm ngei ang a, ramri hnai khua ten ei leh bara an tawrh dan tur hi a rapthlak hle a ni. Khawthlang lamah Bangladesh nen kan inkar hung avangin khua, huan leh lo ram zau tak hmun hrang hrangah kan chan tawh a. Kan Chief Minister hian Union Home Minister hnenah FMR hi tihtawp a niha, Indo-Myanmar border fencing hi kalpui tum a nih pawhin, Mizoram bik hi chu huam tir ve lo turin a lo ngen tawh bawk a nih kha. Ni 21.1.2024 khan NGO - coordination committee huaihawtin MFR leh border fencing dodal lantir nan Aizawl-ah mipui punkhawmna huaihawt a ni tawh a. Mizoram sawrkar leh mipuite'n he thil pahnih duh lova kan dodal rual hian, "central sawrkarin Zofate ram pathuma thendarha awm tawhte

rorelna-pakhat hnuiaia kan awm tlan leh theih nan ngaihtuahna sengin kawng min zawn sak sela, a tul ang zelin *international forum*-ah te pawh hma min lakpui se” tih hi Mizoram sAWrkar leh mipui duh dan a ni a.

A resolution thlawp lo zawnga sawi tur kan awm chuan, kan la hmasa ang a; a thlawp zawnga sawi duh te pawh kan awm tho ang a. Amaherawhchu, a tira kan sawi ang khan, business kan ngah ang reng a, a thlawp zawng te chu tam tak kan la hman lo turah ngai ila. Mi pakhatin minute 5 a sawi kha a tawk kan ti mai em? (*Rem tih a ni a.*) Awle, member pakhatin minute 5 zel an sawi turah ngai ta ila. Sawi duh awmte ban i phar teh ang u.

Aw le, member pathumin an phar a; tichuan, Leader of Opposition-in sawi tur a neih chuan kan sawm bawk ang a, kan House Leader kan sawm bawk ang. Tichuan, a resolution neitu wind-up turin kan sawm mai dawn nia.

**PU RASIK MOHAN CHAKMA:** Pu Speaker, ka lawm e.

thlengin connectivity hi, PMGSY - pilot project atanga min pah takah chuan kan neih loh phah a, a ram chhunga mite hian kan chan nasa em em a ni.

BSF aiawhte pawh an awm a, an hnenah pawh a hrarin kan thlen thin a, mahse, awmzia a nei lo. Tin, Home Ministry-ah *Border Management* Secretary hnen thlengin kan ziak a, mahse, tun thlengin a chhanna a la awm lo.

Tin, he Myanmar lam border-fencing an tih dawn tak tak a nih chuan, kan hriata tana tha chu - Mizoram state tan, kan mipuite tan hlawkna pakhatmah hmuh tur a awm lo; tawrhna, hrehawmna, ram tam tak channa tih loh chu. Cultural lamah chuan thudang pawh ni se. Resolution mover in a rawn sawi - British hovin '*divide and rules*' hmanga kan tribal -te a bik takin Northeastern tribal-te hmun hran hranah min thendarh a, tun thleng hian political problem pawh, schedule tribe zawng zawngin kan neih phah a ni. Chittagong Hill pawh hi India rama awm awmtak, 90% non-muslim an ni a, khati chung pawh khan Pakistan-ah dah an ni a, khami hma dahi - 1894 khan Chittagong Hill leh a surrounding areas te kha Pakistan-ah an bet ringawt a ni. Chuvangin, political leh cultural problem kha a siam tam lutuk a. Tunah hian India Sawrkar hian tireh zawngin hma la mah sela, a harsa tawh a. Chuvangin, he thil hi a nawra nawr a tul takzetin ka hria.

Pu Speaker, he resolution hi thinlung takin ka thlawp e. Ka lawm e.

**HON. SPEAKER :** Serlui Bialtu zahawm tak Pu Lalrinsanga Ralte ilo sawm ang a; *minute-nga* kha maintain hram hram i tum ang u aw.

**PU LALRINSANGA RALTE:** Pu Speaker, ka lawm e.

Tin, kan inunauna thang duang tak mai hi Manipur CM hian a hmu thei lo hlein ka hria a, tin Manipur Zo-Kuki te buaina namen lo an tawh a hnawh chhuah an tum vanglai tak, nikum Ni 23 Sept., 2023 khan Imphal-a press mite hmaah Manipur CM hian Central Sawrkarah FMR hlih leh ramri hung na taka a nawr thu a lo sawi tawh a ni. Chuvang chuan, Manipur Sawrkar duh dan anga he kan ram leh Myanmar inrina rawn tih tel vel zel a hi, Central hian ‘Manipur Sawrkar thu hi a la mah mah em aw’ ka ti a. Sawrkar tan pawh hian a tha nat thlakin ka hria a, a zahthlak lek lekin ka hria. Chuvang chuan, na hrek hrawka kan Sawrkar hian a do a tul tak zetin ka hria a ni.

Chuvang chuan, tuna kan sawrkar thara kan CM zahawm tak kaihruai pawh hian *pa thek-thawk*, duap tel miah lova he sawrkar hi kan kala, Ram leh Hnam issue ah chuan huaisen taka kan kal hi a thain ka hria a, I veilama thute pawh hian ‘kan thlawp tlat dawn a ni’ tih kha ka sawi duh a ni.

Tichuan, Pu Speaker, he Government Resolution hi tha ka ti a, ka rawn thlawp e.

**HON. SPEAKER** : A lawmawm e. Aw le, sawi leh turin (Election Commission lam hian ‘Saiha’ tiin an la dah a, mahse, ‘Siaha’ tiin kan lam ang a) Siaha Bialtu zahawm tak, Dr. K. Beichhua ilo sawm ang.

**DR. K. BEICHHUA** : Pu Speaker, ka lawm e.

Hei, Sorkar Resolution a rawn lut a, ka chhiar a, ka chhiar nawn leh thin a, ngaiantuahna thui tak min pe a. He border fencing chungchang hi, ka hriatsual loh chuan vawithum Sawrkar resolution anga a luhna a ni tawh a ni. A vawikhatna ah khan ‘fencing tih ni se’ tih kha sawrkar tanchhan a ni a, fencing tih a ni chuang lova. A vawihnihna ah, ‘border fencing hi tih loh ni rawh se’ tih a ni a, eng a awm chuang lova. Vawiinah hian kan Home Minister zahawm takina a lo sawi tawh ang khan, he thu leh hla hi eng emaw atanga kan la hriat chauh a ni a, ‘official-a hriattir kan la ni lo’ tih kha a rawn sawi a.

Tin, kan CM zahawm tak pawh Delhi-ah vawihnih a zuk kal tawh a, Home Minister te pawh a zu sawipui thu kan hria a. Home Minister atangin positive taka *response* a dawng ni te pawhin kan hria a ni. Chuvang chuan, a thlamuanthlak rih maiin kei chuan

ka hria a. He thil hi ka ngaihtuah chet chetin, vawiinah hian kan u leh naute, kei, ka pa u ngei hi Myanmar sipaiah tanga a dam chhung khilai hmang zo a ni. A fate hi Myanmar lamah an la awm vek a, ka first cousin te an ni. Chutianga thisen zawmpui sawi tur tam tak kan member zahawm takte pawhin kan neiin ka ring a. Vawiinah hian ‘he thil hi he House a lo pass thut-thut chi a ni dawn nge, ni dawn lo’ tih te pawh hi ngaihdan sawi thiam har ka ti a.

Ka sawi tawh ang khan vawithumna, vawithumah vawihnih, Pathian zarah ka tel ve thei a ni. Chutah chuan kan kal chhoh zelna tur hi ka ngaihtuah a. Vawiina he rorelna sang taka thutlukna kan lo siam hi, ‘vawiina lo siam chi a ni nge, ni lo’ tih keimaah chuan zawhna lian tak a la awm a ni. Chutih lai chuan he dinhmun hi ka ngaihtuah a. Vawiinah hian u leh nau, nu-hmun, pa-hmunte pawhin khata awm reng thei kan nih loh hun a lo thleng thin a, tichuan in-hrang te kan chang ta a. Chutianga chuan inhmangaih takin, ‘in-hrang kan chan tak avang khan u leh nau kan nihna kha a bo ta a, kan thisen inzawmna a bo ta a’ tihna a ni miah lo a ni. Chutianga in-hrang, lo-hrang kan lo neih takah chuan pangngai takin, kawngka atanga inlen pawh mai ni lovin, kawngkapui atangin mawihni taka inlen pawhin, kan inhmangaihna kan tilang a ni.

Chuvang chuan, vawiina kan Zoram dinhmun leh Myanmar dinhmun ngaihtuah hian, ‘eng tianga kal hi nge tha ang; tha lo ang’ tih pawh sawi thiam a har ka ti a. He resolution hi ‘ka support e’ ti i la emaw, ‘ka support lo e’ pawh ti i la, “*Kela, be-be mah la, ka talk tho-tho ang che,*” tih ang deuh kha kan ni a. Kan pass dawn tho theo dawn tih chu a chiang mai a. Mahse Zoram-mipui hian vawiinah hian ‘kan ngaihtuahna i hmang zel teh ang u’ tih hi he House atangin, Pu Speaker, nangmah kaltlanga kan insawmna ni se. Vawiinah hian kan ram dinhmun chu kan hria a, a mipui-nawlpui ti-ti te leh social media-a kan thalaite thu leh hlate hi ngaihtuah ta i la - Vawiinah hian kan ram hi a dam em? Vawiin anga kan kal zel hian kan ram hi eng chen nge kan kal ang? He ram leh hnam, Zofate hi eng chen nge kan dam khaw chhuah ang? tih theih tur *khawp question lian-pui* a awm a ni. Chu chu ‘eng vang nge?’ kan tih chuan, vawiina he kan rama a mipui-mimir kan ti-ti leh social media-a kan hmuh leh thil dang dang atanga information kan dawnte ngaihtuah hian, kan thalaite hi ruihhlo avang hian kan pul phuk-phuk a ni tawh lo maw? Heng te hi ngun takin i ngaihtuah teh ang u.

Vawiinah hian ram hi developed tak, changkang tak, kawng engkimah thangduang tak ni mah ila, kan fate, kan thalaite an thih phuk-phuk si chuan eng nge sawt ang? Chumi piah lamah chuan, vawiinah hian kan ramah hian drugs vanga tuar mek ang zat hi ram dang mite’n kut an lo thlak avanga tuar ni ta se, vawiinah hian nang leh kei hi kan awm hle-hle hian ka ring lo a ni; ‘Khawnge’ tia kan chhuah ka ring a ni.

Chuvang chuan, he resolution hi ngun takin ka ngaihtuah a, ka chhiar tam poh leh ka ngaihtuahna a kal thui tulh-tulh thin a. A eng hi nge tha ber ang? Vawiinah hian ramri hi lo hung ta se tih member te’n an lo sawi a, a dik viau. Chutih lai chuan, side A leh

side B - merits leh demerits te pawh hi kan thlir a tulin ka hria a. A hung chungchang te pawh kan sawi a. Kan ram chu tlang ram a ni a. Contractor te'n hlawk an duha, eng emawa straight taka fencing a kal chuan, ram kan chan tur pawh tam tak a awm thei a. Chuvang chuan, he hungna te pawh hi lo awm ta se, ka hriat sual loh chuan km 3 danah gateway awm tura duan a ni a. Chuta gateway – luh-chhuahna dik tak, hawihhawm tak leh dan dik taka kan luh-chhuah chu kan himna tur a ni dawn lo em ni? Vawiinah hian duh duhnaa kan luha, mi hmuh lohna atanga kan luh ruk thin avang hian a ni lo em ni vawiinah hian kan ramah ruihhlo te, smuggling te, human trafficking te, arms and ammunitions tawlh rukna tam tak te a awm? Chuvangin, vawiinah hian Pu Speaker, he resolution hi a zahawm a. Kan Home Minister, a rawn puluttu pawh a zahawm ka ti a. **(Hon. Speaker:** Minute 3-in a pel ta; i zo thei tawh em?)

Pu Speaker, a lawmawm khawp mai. Group Leader hi, kan tam emaw kan tlem emaw *Group Leader* kan ni a. Chuvang chuan, term hmasaah te phei kha chuan minute 15 kan inpe thin a, chu chu i tih chhunzawm ve ka beisei tlat.

Chu chu kan dinhmun a ni a. Chuvang chuan, Pu Speaker, vawiinah hian he resolution hi House-a lo pass mai chi a la ni em? *A buana hmaa lo kherh* te pawh hi awm thei a ni a. Official-a engmah hmuh kan nei bawk si lova, ti-ti thuthang - social media leh chanchinbu vela kan hmuh hi a la ni rih mai a. Chuvang chuan, eng pawh ni se, hei hi chu, “tunah rih chuan a la hma deuh hlek lo maw” ti ta ila, nakinah hian “kan khawtlai ta, nangmah vangin” min tih leh si te pawh a hlauhawm ve tho bawk sia. Chuvang chuan, helaiah hian ‘ngaihtuahna uluk taka he House leh Zoram-mipui hian kan hman a va tha dawn em’ tih hi ka lo din chhuahpui a ni e. Ka lawm e.

**HON. SPEAKER :** A lawmawm e. Kan Group Leader a ni a, minute 10 dawn te a han sawi a. Kan sawi ang khan Group Leader te hi chu ‘an intithu deuh’ ti i la a tha mai awm e. Aw le, kan la sawi leh zel dawn em? *Against* zawnga sawi kan awm awm lem lova, *minute 5* erawh chu maintain hram hram i la. Thil pawimawh, thil sensitive a ni a, sawi kan duh tlangin a rinawm a.

Tu tu nge sawi leh ang le? Ban i han phar teh ang? Member pali atangin kan la leh ang a, tichuan kan duh tawk ang u aw. Hachhek Bialtu zahawm tak, Pu Robert Romawia Royte ilo sawm ang.

**PU ROBERT ROMAWIA ROYTE:** Pu Speaker, ka lawm e.

Vawiinah Sawrkar - official resolution kan Home Minister zahawm takin a rawn pulut a. Tin, a background te, he resolution a tulna te thiam tak leh chipchiar takin a sawi tawh bawk a, ‘pass a nih hmel deuh em aw’ tih chu rilruah chuan a awm deuh a. Mahse, he thil hi a pawimawh em avangin, ngaih pawimawh zawng tawi te han sawi ve ka han duh a ni.

Pakhatnaah chuan, *Free Movement Regime* hi Myanmar leh India inkar mai thil a ni lova, tun hma atang tawh khan hetianga ramrite inkalpawh duha *free movement* siam hi an tam mai tih kan hriain ka ring a. Europe-ah te, African countries-ah te, Asian ngei ah te pawh hian FMR system-a inhriathiamna nei ram hi an tam a, a chhan chu, a tawn tawnin an hlawkpu a ni. He FMR hi Mizo hnam anga kan unaute nena kan inzawmna a ni a, a pawimawh em em a, a area an tizim hret te hi a pawi a. Chuti laia thiah tum a, social media leh PIB press note-ah te pawh Home Ministry chuan a decide tawh thu kan hmu a, ‘tih an tum ngei a ni’ tih hi chu rin ngam a thani ka hria a. Chuvang chuan, vawiin ah hian kan rel hma lutuk lova. Ka hma chiah a sawi Siaha bialtu kha kan zingah chuan la awm se, khatiang khan a sawi ka ring lova. A awmna party a dang tawh avangin khatiang khan sawi mahse, a duh thovin ka hria a, sawi hmang khan.

Engpawh nise, he thil hi hnam thendarhna - hnam thenna a nih avangin FMR thiah hi sawrkarin duh lova official resolution a rawn tih hi, tih awm tak an ti a, a mimal tak pawhin ka thlawp thlap a; kan group lam pawh hian kan sawi hova, kan thlawp a ni. Tin, hei hi keimahniah te pawh ‘Private Member’s Resolution-ah te pawh ti ila’ tiin kan sawi hova; mahse, Government Resolution a lo luh tur thu te hriatna kan nei ru deuh a, chu chu chak zawk leh tha zawk turah te pawh kan ngai a. Hnam thil a ni a, party lampang ngaihtuah lovin; vawiinah hian Private Member’s Resolution ni lova official resolution-a a rawn lut hi a lawmawm hle a ni.

Tin, ‘Zoram leilung zau tak channa a ni’ tih an rawn sawi tliar-tliar tawh a, ka sawi nawn ve leh hrim hrim duh a. Khaw tam tak, keipawhin ka hriat leh a bul velah te pawh ka kal ve fona area khi a ni a. Kan balu lakna te, kan sangha manna te, lui dung hausakna tam tak Myanmar ramria kan khuate khian an eizawnna leh an ei bel te an chan dawn a, *legally* chuan chan lo mah ila, *practically-in* kan chan dawn tlat a ni. A chhan chu, luia sangha kan va man thin ang chite, khang ang zawng zawng kha a remchang dawn tawh lova, kan balu lakna tha tak tak te kha kan hmang theih tawh lo ang a, a leh lamin an hmang tangkai ang a. Khang kha chu kan thik lova, mahse, heti laia kan chan ve reng thin kan chang ta lo hi *economically* pawhin hlohnna nasa tak a ni dawn a, ram zau tak channa a ni dawn a ni.

Kan BJP lam member zahawm tak, group leader kha, *Act East Policy* Prime Minister zahawm tak Pu Modi-a ten an rawn ti chhuak a, *Act East Policy* bawhchhiatna a ni dawn a ni, khilai khi kan hung tlat chuan. Tin, Asian countries ten thuthlung an lo neih mek te pawh hi a bawhchhe deuhin ka hria a, ka zir chiang hman lutuk lova. Chuvang chuan, thenawm hro-hrang na deuh Chief Minister-in a nawr avanga he ramri hung mai tur hi Mizote tan a tha lova, kan hnam tan a tha lova, kan ram tan a tha lova, *Act East Policy* hlawhtlinna tur te pawh a dal theih ka ring a. Chu chu, hetia kan do tur hi a lawmawm hlein ka hria a ni.

Kan member zahawm tak Pu Lalrinsanga Ralte, Serlui Bialtu zahawm takin a rawn rawt ang deuh khan, a tawngkam erawh chu tlemin thlak hret ta ila, duap-aw deuh zul lo hian, ‘*ngen anni a*’ tih lampang lo khan, kan do thu hi kan resolution move-tu in a thiam zawk daih ang a, rawn siam rem te a rem em? Chu chu intlhahrung ang reng deuhin ka han rawt dek dek a ni. Tin, *biometric identification* kha chu hnam anga thil pawi tak anih avangin, he resolution-ah hian telh bawk ila, chutiang chuan kan thlawpna te pawh a chak leh zual deuh ang a, kan lawm leh zual dawn a ni.

Tin, he resolution hi umzuia, bawhzui ngei ngei ngai chi te pawh a nih hmel a. CAB chungchang te, UCC chungchang te he house-ah hian kan sawiho tawh thin a, a hun lai taka resolution siam chu a effective khawp mai a. Chuvang chuan, a hun taka official resolution-hi rawn lut ni te pawhin ka hria a; hei hi tih mawihna hreta pass ka thlawp a. Tin, resolution hi kan pass tawh rau rau chuan, sawrkar pawhin um zui se la, kan Chief Minister chak tak khu lama connection nei tha tak pawh hian personal level-ah pawh thil thui tak a ti theiin ka ring a. He resolution hi han siam thata, *biometric identification* kan duh lohna ti telin ka thlawp e.

**HON. SPEAKER :** A lawmawm e. Thorang Bialtu MLA zahawm tak Pu R. Rohmingliana ilo sawm ang.

**PU R. ROHMINGLIANA:** Pu Speaker, ka lawm e.

Pu Speaker, he resolution hi ka thlawp tlat a, ka hmaa member zahawm takte sawi ang khan, he resolution-a “*ti lo turin ka ngen a ni*” tih hi keipawh ka lo point out ve a. Hei aia *word* chak deuh zawk “*ti miah suh se*” tih emawin a move-tuin thlak thei phei se chuan, a duhthusamawm leh zual ngawtin ka ring.

Pu Speaker, kan sawi leh duh chu - a move-tu khan a han thai lang zawk a. Ni 1.2.2024 khan MNF thuneitu sang *National Core Committee* leh *Political Affairs Committee* te khan resolution kan siam tawh a; Pu Speaker, i phalnain helai point hnihte hi ka han chhiar chhuak duh lawk a – “Border fencing chungchangah India leh Myanmar ramri hung tura India Sawrkarin hma a lak mek hi MNF chuan tha a ti lova, a dodal zel dawn a ni” tih kha point khatah a dah a. Tin, a point dang lehah chuan – “*Free Movement Regime* India leh Myanmar inrina km 16 ve ve zalen taka inkalpawh theihna hlih chungchangah India sawrkar hmalakna hi kan dodal tlat a ni” tih kha kan lo passed tawh a ni.

Pu Speaker, Tuichawng Bialtu MLA zahawm takin a sawi ang khan, keini pawh ka bial chhungah khuan he border fencing hi a awm a, hmanni ah pawh ka sawi lang tawh a. “Hei hian min tihbuai zia khaw; pakhat phei chu an hung chhuak a” tih kha ka sawi tawh a. A sawi ang khan, kawng chungchangah te harsatna kan tawk a, inkalpawhna - khua leh khua inkalpawhna chungchangah te, kan ram tha zawng zawng leilet hmun

thatet kan thlai Mizoram-in kan lak luhna ang chite pawh hung chhuah vek a ni a. Tin, a duh tan chuan police ten misual um ta se, pawnah an tlan chhuak daih a, BSF-ten an lo dang leh si a; khatiang boruak te pawh kha thil awm thei a ni.

Chumi rual chuan, BSF-te awm reng chung khuan thil tha leh tha lo a lut ve thei tho mai a, a mak khawp mai. Hmanni ka biala ka kal pawhin zu bur pakhat ka hmu a, (khaw pakhat ah) India siam a lo ni lova, Bangladesh siam daih a lo ni a; gas bur te pawh India siam an hmang lova, Bangladesh a mi tho an lo la lut a, fencing anih avang khan ‘a lut lo ang’ tihna kha a awm chuang miah lova. Chuvang chuan, he fencing an kalpui tur hian kan ram eng emaw zat a lak hek dawn avangin kei chuan tha ka ti lo tawp mai a. Tichuan, 1948-ah khan border chungchangah Burma-in hma a rawn la tan a, helai kan inkalpawh theihna tur ang chi te pawh. Tichuan 2018-ah *Act East Policy* avangin India pawhin FMR pawh hi a rawn kal tan tir a ni a. Lo kal chho zelin, ti hian tun hunah tute emaw han sawi mai mai ang ni lo deuhin helaiah hian thil chiang deuh mai awm chu, “a thu mai; thil tak tak a la ni lo e” han tih laia kha han tarlan ve ka duh a chu a ni.

Ni 20<sup>th</sup> January khan Home Minister Pu Amit Shah khan “km 1643 Myanmar border hi hung thuai a ni ang” a tiha kha Assam Police Commando passing-out parade ah khan a sawi a ni. Chuvang chuan, hei hi thutling niin ka hria a. Vawiinah pawh hian he resolution hi kan pass ngei thani ka hria a, ka thlawp tlat a.

Amaherawhchu, Pu Speaker, ka sawi tawh ang khan, “*helai hi ti lo turin kan ngen a ni*” tih aiah hian, Pu Speaker, a move-tu hian phal se chuan, hei aia strong deuh zawk hian a rawn ti leh ka la duh fo a ni. Pu Speaker. Kha kha ka sawi theih ni se la. Ka lawm e.

**HON. SPEAKER :** A lawmawm e. Tunah Lawnglai ‘W’ Bialtu zahawm tak Pu C. Ngunlianchunga ilo sawm ang.

**PU C. NGUNLIANCHUNGA:** Pu Speaker, sawina hun min pek avangin ka lawm e.

Vawiinah official resolution - kan ram chhanna tur kan han sawiho thei hi a lawmawm ka ti a, he resolution hi kei pawhin ka thlawp a. A bik takin hei hi ka ngaihtuah a - lo fencing tak tak ta se, keini sawlai *Lai-ho* nen phei chuan inkalpawh leh hnai taka khawsa hote kan ni a. Tuna FMR te pawh hi kan tangkaipui a, a bik takin Sangau, Pang Khua leh a chhak piah lam zel Mara Autonomous District Council area-ah te pawh in-bazar tawna khatianga inpawh tlang taka khawsa ho, cheng ho kan ni a.

Tin, kan hriat angin, khilaiah khian kan unau-kan thisen zawmpui tak takte awmna a ni a. Heta kan hmuh ang hian, British sorkar khan *divide and rule policy* hmanga min thendarhna a ni a. Bangladesh lamah pawh khuan kan unaute tam tak an awm a, Zohnahthlak eng emaw zatin harsatna an tawk a, kum kal ta lamah te kan hmuh leh kan

hriat chu – “Zofate tan chuan Mizoram hi *Kan Jerusalem* a ni e” kan tih thin kha a takin kum 2-3 kal ta atang khan Zofate tan a nih zia a rawn lang a.

Myanmar sawrkar a buai a, helaiah mi tam tak an lo ral tlan a, vawiin niah pawh. Chutiang chuan Bangladesh-ah chi leh chi inkarah buaina a awm a, chungah pawh chuan kan unau zohnahthlakte, tunah pawh hian ka bial - Vathuampui, Tuithumhnar, Hmawngbu, Bungtlang South leh Hmunnuam leh hmun hrang hrangah sawn raltlan eng emaw zat, Chamdur project-ah te, Mautlang-ah te an awm a ni; chungte chuan harsatna NASA tak an tawk a. Chutiang chuan hei, (ka thenawm, ka bula thu, ka thianpa kha a chhuak ta daih a) ani khan ‘a enga mah hmaa lo tih’ a tih ngawt lai kha, ka hma chiah sawi Thorang bialtu zahawm tak khan a sawi chiang tawh a. Kan Home Minister te pawhin a order lehkha (black and white-in) hmu lo mah ila, he thil hi chu ‘a lo thleng dawn a ni’ tih an sawi chhuah tawh a nih avangin, kan lo invena, kan duhlohma kan lo lan tir kha kan tihmakmawh a ni a.

Ka hmaa mite pawhin an sawi ang khan, helaia ‘ti lo turin kan ngen’ tih laia hi, kan resolution neitu, khan kan hotupa khan han thlak deuh hlek sela, hei aia na (a ngen lam ni lo) in kan duh loh dan hi, zoram mipuite kan vai mai hian kan duh lo vek a ni. He border fencing hi tumah hian kan duhin ka ring lo. A political party ang zawnga hamthatna lo lakna chi emaw, lo tih chi pawh a ni lova, kan unaute nena kan inzawmna an sawi thin ‘ramin ri a nei a, thisen erawh chuan ri a nei lo; hnam pawhin a nei lo’ a ti a. Hei, a bikin MZP-ten nasa takin Zofest te an buatsaih thin a, ‘*Zofate inpumkhatna, inlungrualna*’ an ti a. Helai a tawpnaa kan han tih dan te pawh hi a mawi ka ti a, “*Zofate min thendarh hi rorelna pakhat hnuai a kan kun leh theihna turin hma min lakpui zawk rawh se*” han tih lai te hi a nghahhlelhawm ka ti a. Zofate hmun khata, rorelna pakhata kan awmho tur hi keini phei chu ZORO lam kan ni deuh leh nghal a, a ZORO ang zawng pawhin a nghahhlelhawm ka ti a.

Chuvang chuan, vawiinah hian he resolution hi lungrual takin pass ila, Helaia thu pawh kha, hetah ‘document chu mi, kha mi’ tih sawi vak kha, kan hotute’n an sawi tawh a. Kan resolution neitupa - kan Home Minister zahawm tak pawhin hetah British hun atangin a rawn sawi tawh a, a lawmawm ka ti a. Chutih rual chuan, vawiinah hian he resolution hi lungrual takin pass ila; helaia ‘ti lo turin kan ngen’ tih lai hi resolution neitu khan, kha aia na deuh hlek khan siamrem kha tha ti se chuan, ti tlang mai ila a va tha leh zual dawn em! Helai House-a kan pass mai ni lo hian, hmalam zelah pawh zofate kan tan tlana, hei hi chu ‘kan dodal tlat a, kan tan ho zel a ngai a ni’ tih lai kha Pu Speaker, ka han sawi duh a ni e. Ka lawm e.

**HON. SPEAKER** : Sawi leh turin Pu Lalnghinglova Hmar i lo sawm ang.

**PU LALNGHINGLOVA HMAR, HON. MINISTER:** Pu Speaker, ka lawm e.

Official Resolution tuna kan putluh mek hi tawitea sawi ve ka duh a. Kan Home Minister-in a sawi tawh ang khan, *official*-in Sawrkar-laipui atangin thu dawn la awm lo mahse press report hrang hrangah a awm a; PIB pawhin a tarlang tawh nghe nghe a ni. The Hindu Chanchinbu February Ni 8-ah khan chiang takin a inziak a, chumi leh document dangte behchhanin FMR chungchanga ramri hung kaihhnawih hi tawitea han sawi ve ka duh a.

Hung tura tih hi km 1643 a ni a, chung zingah chuan India leh Myanmar-ina an intawm ramri hi Arunachal Pradesh-in a nei thui ber a, km 520, Mizoram hi pahnihna niin km 510, Manipur hian km 398, Nagaland hian km 215 a ni a. Nichina an sawi tawh ang khan 1968 - *Land Border Crossing Agreement* atang khan FMR km 40-a tan a ni a, 2004-ah khan km 16 a lo ni ta a. Tuna kan dan thar han tih turah hian an assets leh liabilities te tih ve lehna tur kha a awm a. Pu Speaker, i rem tihnain han chhiar lawk ka han duh chu, Amendment Section 43-na ah khan ‘on and from the date of commencement of this act, every public servant shall make a declaration of his assets and liabilities in such form and manner as may be prescribed’ tih kha a awm a. Hemi, tuna kan hman lai property return - *moveable* leh *immoveable* an peka hi an ti dawn tho nge, an tikawp dawn; a khawi zawk hi nge an rin

ang? ‘Sawrkar-hnathawk khan chihnihin an pe dawn nge, pakhatah chauh ang pe ang?’ tih te kha, eng emaw, helaiah hian a hma ami han paihna chiah kha a awm lova, dan thar kan han insert khan helaia lo awm hian, ‘kan Sorkar-hnathawkte tan khan hmunhnihah declaration an pe dawn nge?’ tih te kha a chiang lo lai a awm avangin min han clarify sak se. A bak hi chu ka chhiar ka chhiar a, eng eng emaw tlema a wording diklo lai han siam that ngai mai te hi niin ka hria a. Tichuan, amendment a rawn tih ang hian pass-pui pawh ka rawn ngen sak nghal e.

**HON. SPEAKER :** A lawmawm e. Tikhan Lok Ayukta Amendment Bill, 2024” chu House pass-pui turin rawn move-tu khan a rawn dil a. Tin, kan Opposition Leader zahawm tak Pu Lalchhandama Ralte-in a observation te a rawn sawi tawh bawk a.

Sawi tak ang khan, tunhma lam atanga lokal tawh, ‘cabinet meeting pawh kaltlang chho tawh a ni a, sawi chiam a awm tawh lo’ tih kha kan ngaithla a. Tichuan, a bill neitu, kan Chief Minister zahawm Pu Lalduhoma, a bill te wind up a, House pass-pui lo dil turin kan sawm ang a.

Chumi hma chuan thil pakhat tih hmaih kan lo nei hlauh a, *Mizoram Appropriation Supplementary Demand for Grants 2023-2024* a bill copy kha kan lo sem hmaih palh hlauh a, tunah sem ni se. Member-te khan min lo hrethiam ula.

Kan chang kim maw? Tunah chuan kan Chief Minister zahawm tak Pu Lalduhoma, a bill wind up a, House pass-pui dil nghal turin ilo sawm ang u.

**PU LALDUHOMA, CHIEF MINISTER:** Pu Speaker, Opposition Leader zahawm takin a rawn zawhfiahna kha, zawh awm tak pawh a niin ka hria a, a lo thlir ngun hle niin ka hria a, lawmawm ka ti a. “

*Lok Pal & Lok Ayukta Act, 2013* hi Central Sawrkar-in a pass a, khami a pass tak hnuah khan, keini dan nena inmil lo lai siam rem ve kha a lo ngai ta a, chu chu tuna kan Amendment rawn propose ah pawh hian, chumi avanga tih ngai chu eng emaw zat a tel a, chung zinga mi chu section 43 hi a ni. Tichuan, Ministry of Law and Justice-ina Dan a siam 2016 ah khan *property return* chungchang hi a awm a, tunah hian a tih dan tur kalhmang an rawn siam thar a ni. Chutah chuan, tlar hniih lekah a thehluh dan tur hi an rawn thlak a, thehluh dan tur kalhmang leh “thehluhna tur form siam huna thehluh tur” tiin an rawn thlak a ni. Kan Dan hluiah hian hemi chungchang hi a inziak duah mai a, tuna amend rawt ang hian tawitein, ‘*in such form and manner as may be prescribed*’ a rawn ti ta mai a, a prescription kha chu a rules-in a rawn take-care tawh thung dawn a ni. Chutianga tha zawk tura tih chu a ni a.

Tin, *Annual Immoveable Property Return* rualin kha kha an rawn thehlut dawn a ni a, hei Sawrkar-hnathawkte pawhin leiba an neihte pawh an rawn declare a ngai dawn a, ‘khami rual khan an ti tawh dawn’ tihna a ni. Hei hi a tha zawk tawh tura an ngaih a ni ang nge.

Pu Speaker, he “*Lok Ayukta Amendment Bill, 2024*” hi he House zahawm tak hian min pass-pui turin ka rawn dil e.

**HON. SPEAKER :** Aw le.. kan Chief Minister zahawm tak khan “*The Mizoram Lok Ayukta Amendment Bill, 2024*” chu House pass-pui a rawn dil ta a, tunah kan buk ang a.

Pass remti apiangin, ‘remti’ ti ula; remti lo kan awm chuan, ‘remti lo’ ti ula. (*Remti lo an awm lova..*)

Aw le, “*The Mizoram Lok Ayukta Amendment Bill, 2024*” chu he House hian lungrual takin a pass ta a ni. (**Pu Lalduhoma, CM:** Pu Speaker, ka lawm e.)

**HON. SPEAKER :** Aw le; vawiina kan business chu kan zo ta a, naktuk Ni 29<sup>th</sup> February, 2024 chawhma dar 10:30 ah kan thukhawm leh ang a.

Hei, vawiin Nilaini hi traditional dress - *hnam inthuama inthuam ni* atan sawrkar hmasa lamin a lo tih kha, ‘i chhunzawm ang u’ tiin ngenna kan siam a, helam atangin member-te kan zawm tha hlein ka hria a, lawmthu kan sawi a ni.
