**DR. K. BEICHHUA :** Pu Speaker, GAD Minister zahawmtak chhana tana ka zawhna chu –

“Tun dinhmunah MLA te Quarters/Bungalow luah tur kan indaih lo hle a, GAD hnuai Sorkar Quarters/Bungalow te hi MLA-te luah tir ve theih a ni em?” tih a ni e.

**HON. SPEAKER :** Sawi tak ang khan, Chief Minister zahawmtak leh GAD changtu ni bawk Pu Lalduhoma hi Hon. Vice President dawngsawng turin Lengpui Airport-ah a kal a, Pu K. Sapdanga, Member zahawmtak leh Home Minister ni bawk hi a aiawha zawhna chhang tura mawhphurhna a hlan angin chhang turin i lo sawm ang u.

**PU K. SAPDANGA, HON. MINISTER:** Pu Speaker, Member zahawmtak Dr. K. Beichhua zawhna chhanna chu hei hi a ni –

GAD O.M. No. D.11014/1/2019-GAD (GM) Dt. 14.4.2021 para 1(g) hnuaih chuan, VIP/Ministers leh a dangte hian Type VII/VIII/Bungalow te an luah thei a ni.

**HON. SPEAKER :** Achangtu Minister-te an awm loh chuan zawhbelhna lak loh te pawh a ni thin a, amaherawchhu, zawhbelhna lak theih miah loh tih a ni chuang lova, engnge member-te ngaihdan le? zawhbelhna kan la ang em? ..... (*House-in Zawhbelhna lak a remti a.*)

*Zawhbelhna - Pu H. Ginzalala, Champhai North Bialtu*

**PU H. GINZALALA :** Pu Speaker, ka lawm e. Ministry of Home Affairs atangin helicopter service hi kan dawng thin a, kan nei thin a. Pu Speaker, (ka hriatsual loh chuan) Mizoram hian allotment hi kum khata darkar 960 flying hours kan nei a, amaherawhchu, Pu Speaker, kan utilisation hi a chhe angreng khawp mai a, flying hours 700 bak hi kan hmang tlat lo a ni. Chuvangin, mipui lamah hian kan indaih lo hle a ni tih hi tlang hriat a ni a. Hei hi eng vang nge?

Tunah hian a lan danah darkar 260 flying hours hi kan chan a ni a, hei hi kum 2022 - 2023 a ni. Kuminah hian chiang takin kan la hre thei lova, hei hi engtia tih reh tur nge nia; engnge a chhan? Technical problem ni chiah pawhin a lang lova, ‘a management lam fel loh deuh vang a ni ang em aw tih te ngaiantuahnaah a awm a ni.

Hemi sutkian hi sawrkar thar tih turah ka han dah deuh a. Thingtlang lamah te kan indaih lo hle a, a bik takin ka bialah te pawh helicopter service hi a tlem em em mai a ni. Hei hi engtianga tih reh (tih tlem) tur nge? Engtin nge he kan allotment hi kan hman zawh theih ang? Pu Speaker, ka lawm e.

**HON. SPEAKER :** *Zawhbelhna - Dr. K. Beichhua, Siaha Bialtu.*

**DR. K. BEICHHUA :** Pu Speaker, hei, MLA eng emaw zat hi chu Aizawl-a in leh lo nei lo kan ni hlawm a, keimah ngei pawh hi ka ni a. MLA ten awmna kan neih awm chhun chu Legislator Home hi a ni mai a. Khi khi a hlui tawh a, kalphung-hlui ami daih tawh kha a ni a, Kalphung-thar atan chuan a in fit lo riauin ka hria a.

Chumi piah lamah tuna Hostel kan neih pawh khu hmanniah Pu K. Hrahmo nen kan thleng a, kan MLA zahawmtak Palak Bialtu nen. Service a thalo khawp mai a; tin, a building hrim hrim khu a hlui tawh a. Chuvang chuan, GAD changtu hi ka lo beisei dan chuan, House Leader a ni tho a, “ka department a ni lo” ti thei a ni lovin ka hria a. Chuvang chuan, vawiina kan harsatna lai hi, Secretariat lam quarters ruak te a awm theih chuan, MLA, Aizawl pawn lama mite hi chu quarters min accommodate dan a awm thei ang em? Ka hriatsual loh chuan, sawrkar-hnathawk khulaia quarters lo retain tlat te pawh an awm tih thawm te pawh a awm a. Aizawl lama an post loh chuan an quarter luah laite chhuahsan ve mai awm tak a nih laiin, mi-thenkhatin an retain tih thawm te awm a. Chuvang chuan, helai hi min ensak thei ang em?

Tin, tuna Champhai North Bialtu rawn zawh kha a pawimawh hlein ka hria a. A bik takin Champhai te, Siaha te, Lawnglai te atang chuan vawiina helicopter kan hman hi a tangkai em em a ni. Chuvang chuan, sawrkar hian kalphung-hluia pakhat chauh awm thin kha, kalphung-tharah chuan company dang atang te hian helicopter hi ngaiantuah belhin, service tam zawk hi mipui hnenah a pe thei ang em?

**HON. SPEAKER :** Zawhbelhna pahnihna – Pu Lalchhandama Ralte, Leader of Opposition.

**PU LALCHHANDAMA RALTE, OPP. LEADER:** Pu Speaker, i sawi ang khan, a changtu a awm lo tih chu ka hre tho na chungin, awareness leh educate-na atan tula ka hriat avangin zawhna neih ka duh a.

Pakhatna-ah chuan, inthlanpui te kan nei a, kan Minister leh kan MLA Board Chairman-bungalow luah laite an awm a, vanduaithlak takin a chak lo ah an han tang a. Quarters hi engtia rei nge an retain theih? Social media-ah te kan ram hrugaitu pawimawh tak takte quarter atang tea an chhuah mai loh hian *troll* te a awm thin a; Delhi-ah te pawh khuan a ni a, inngaihnathiamna-hun a awm thin a, chhungkua an in set felna hun siamsak te pawh a awm thin a. Kan sawrkar pawh hian order kha a siam thar niin ka hria a, chu chu min hriattir thei ang em?

Ka zawhna pahnihnaah chu - hman deuh khan Minister Bangla te kha a awm nualin kan hria a, sawng Chandmari - Govt Mizo High School ram bawr velah te khan a awm thin a ni, hun kaltawh lamah te khan. Tun hnaiah hian Minister Bangla designate hi engzat nge kan neih mek? Sawrkar te a lo inthlak a, Zoram hmun hrang hrang atanga MLA tlingte kan ni a, tun tumah pawh hian kan Minister te zingah Bangla luah mamawh tak takte, la chang hleithei lo te an awm niin ka lo hria a. Mipuite nena indawr te, zing leh zanah an mahni department official ho meeting lawk ngaite a awm fo thin avangin, chung atana ruahmanna siamsak tum kan nei em? Tin, Bangla sak thar emaw, tin, designate bangla tunah hian engzah nge kan neih mek?

**HON. SPEAKER :** Aw le; kha, zawhna a awm nual a, flight hours chungchang te, quarter accomodation chungchang te leh quarter luah theih hun chhung te kha. Ni e, a changtu minister hi a awm lova, a aiawha chhangtu turin Minister zahawm tak Pu K. Sapdanga kan sawm ang a; a chhan theih ang angin chhang se. A chhan theih bak a awm a nih pawhin nakinah a concern minister-in member-te hnenah ziak te pawhin inhrilh-hriat theih turah ngai ila.

Tunah Minister zahawmtak Pu K. Sapdanga ilo sawm ang.

**PU K. SAPDANGA MINISTER:** Pu Speaker, kan ngaihthlak ang khan, GAD chhunga mite a ni a. Vawiinah programme pawimawh tak a awm avangin memberte rawn zawhna pawimawh tak takte kha chhan sual a hlauhawm a. Chuvangin, min hrethiam sela; kan lo chhinchhiah a, ziakin kan hriattir zawk mai dawn nia. Ka lawm e.

**HON. SPEAKER :** A lawmawm e. Tunah *Stareed Question No. 62* na ah kan kal ang. Zawt turin Siaha biatu zahawm tak Dr. K. Beichhua i lo sawm ang.

**Starred Question No. 62 - Home Deptt. a post ruak chungchang.**

**DR. K. BEICHUA :** Pu Speaker, kan Bible chuan, roreltute chu taima taka rorel turin min ti bawk a, a zawa tu chuan taima takin kan zawa tluk tluk a ni ang chu.

*Starred Question No. 62, Home Department changtu Minister zahawm tak hnenah ka zawhna chu –*

“Police vacant post engzat nge awm? Hnawkhah tumna a awm em?” tih a ni e,  
Pu Speaker.

**HON. SPEAKER :** Chhang turin Home Department changtu Pu K. Sapdanga ilo sawm ang.

**PU K. SAPDANGA, HON. MINISTER:** Pu Speaker, Siaha Bialtu Dr. K. Beichhua zawhna –

“Police vacant post engzat nge awm? Hnawkhah tumna a awm em?” tih chhanna chu –

Police vacant post hi 4268 a awm mek a, hnawkhah tumna a awm e.

**HON. SPEAKER :** Zawhbelhna - Pu T. Lalhlimpuia, Lunglei West Bialtu.

**PU T. LALHLIMPUIA :** Pu Speaker, Police ho zingah hian tum dinhmunah Aizawl-ah hmalakna a kal mek niin ka hria a. Chutah chuan, police quarter sak hi a sanction danah cluster ang deuha sak ngai a ni a, district tinah insem hleihtheih ni lovin ka lo hria a. Chutah chuan, Aizawl tih hmasak a ni a, Aizawl zawn hnu hian khawi district-ah nge police housing hi kalpui leh a nih ang?

Hei, Lunglei circuit house bul AP-tlang bulah kum 10 chuang ka awm tawh a, Lunglei-a kan police quarter te hi a chhiain, a tawp em em mai a; an toilet-te chu rangvain an khuh a, a chang chuan an tan a hreawm em em mai a, thenawmte tan pawh chutiang chuan leak rimchhia reng reng hian an khaws a. An mahniin an theih ang angin an intuamhlawm ve a, an inthawm a; chutiang chu an dinhmuna ni a. Chuvang chuan, Aizawl zawn hian Lunglei police quarter-te hi police housing scheme-ah hian tih theih a ni ang em?

**HON. SPEAKER :** A lawmawm e. Phar hun hi - heti hian zawhna zawa tuin a han zawa a, tichuan, minister concern ten an han chhang ta a. An chhan lai hian ka han hawi kual a, lo phar tawhte in awm avangin, a hunbi tak hi tuk thiam a har ang

reng a. Chhanna an han chhan zawh chiaha kan han phar dul zel mai hi chu, koh bik tur hi hriat a har khawp a.

Nichina chhangtuin a chhan lai khan, phar mi 3 an awm a, chungte chu kan koh mai loh chuan; an phar hmasa miau si a. Chuvangin, mit ka han lenkual thin a, mit ka lenkual lai hi lo chang ve deuh mai turin member-te ka han ngen teh ang che u; a har riau.

*Zawhbelhna* - Pu R. Rohmingliana, Thorang Bialtu.

**PU R. ROHMINGLIANA:** Pu Speaker, hei, post a tam hle mai a; 4268 lai mai a awm a. Hnawhkhah tumna a awm bawk a, hnawhkhah vat vat ni se. Police an indaih lo em em a, tuna awm mekte an khawngaih thlak hle mai a, a hah pawh an hah hle a. Tin, chumi rual chuan, thuamthat an ngaihna lai hi tamtak a awmin ka hria a, a mihring, a police mai ni lovin. Hei, ka biala Bunghmun Police Outpost chungchang hi rawn sawi ka duh a.

Bunghmun Police Outpost khuan a huam zau hle mai a. An area khu international border fencing awmna a ni a, khulai khu mihring kan tam em em mai bawk si a; khua a tam em em a. Tunah khuan Gypsy pakhat an kawl ve a, an Gypsy lah chu a tawng em em mai a; ruah a sur chuan, a chung a thler vek tawh avangin, huh-vek kha a ni mai a. Tichuan, tum khatah hmun hnih-thumah kal ngaiin, a mihring pawh indaih ni ta se, kalna tur an nei chuang lova. Chuvang chuan, border area hnai ho hi tlema thuam chak deuh theih dan a awm em?

Tin, hmanniah ka bial chhung a nihna angin office hrang hrangte ka tlawh a. BSF te khulaiah an awm ve a, kan Mizoram Police te kha thuam that loh chuan, zahthlak a chang thei a. An office-ah water cooler te a awm ve a, cooler ni reng si kha, heater angah a chang a, an tui herhechhuah te kha a sa em em vek mai a; khawlum lai phei chuan tihngaihna a awm lo a ni. Two-wheeler te an mamawh em em mai a, khulaiah khuan. FIR an rawn thehluha pakhat an tlan chuan, tlan lehna tur a awm lova; kawng a chhe ropui mai si a. Chuvang chuan, a bik takin Bunghmun Police Outpost thuam chak dan hi kan Minister zahawmtak hian min ngaihtuahsak thei ang em?

**HON. SPEAKER :** *Zawhbelhna* - Pu W. Chhuanawma, Tuichang Bialtu.

**PU W. CHHUANAWMA :** Pu Speaker, ka *Zawhbelhna* chu - Khawhai-ah khian Outpost awm tura tih a ni a, mahse, sawrkar a rawn inthlak a.

Tuichang Constituency-ah khian Khawhai khi Khawzawl dawta khaw pawimawh ber a ni a, a vel khua zawng zawng khi hnai te tea awm an ni a - Vangtlang, Riangtlei, Chalrang, New Chalrang, Lungtan, Sialhawk leh Biate te ho khi; khing hote nen khian

Khawhai-a Outpost awm khi a pawimawh em em mai a. Ministry kal ta khan Ni 9.3.2018-a order chhuak tawh, Khawhai-a police outpost dah tura tih kha, engtikah nge an rawn dah theih ang? Tun thla hnih-thum chhung hian an rawn dah thei mai dawn lawm ni?

**HON. SPEAKER :** Hei, starred question number indawt dan anga kan kal chuan, a dawtah Starred Question No - 63, 64 leh 66 te kha Home Deptt. chan tho a la ni a. Vawikhata zawhnaah pahnih emaw, pathum emaw zel kan lak chuan, Home Minister tan chhan tur a tam lutuk a.

Tin, tuna kan zawhna hi post chungchang a ni a, chutih lai chuan housing te, water cooler te, septic tank te thleng khan kan zawt tho mai a. Chuvang chuan, kan Home Minister hian henga zawnate hi chhang ta phawt sela, chumi zawkhah chuan proper channel deuh hlekin - zawhna pali anih chuan emaw, zawhna pariat emaw, sawm thleng pawh ni se, (kan Minister ngaihdan ka hre lova) House-in tha kan tih chuan .. (**Dr. K. Beichhua:** Pu Speaker, zawhna neitu ka ni a, hun min pe ve dawn lo em ni?) Ka hawikual lai khan i phar lova; mahse, zawhna-neitu a ni a, a lal ve tho si a; a va har ve. Mahse, ka han sawi nen khan a in relate vek tho a nia. Hemi question pali hi kan sawikawp mai dawn em ni ang? House ka rawn che u a ni.

**PU LALCHHANDAMA RALTE, OPP. LEADER:** Pu Speaker, khatiang a nih chuan, kan Home Minister tan pawh chhan a harsa dawn lutuk a. Kan kaldan phung pangngai - Starred Question indawt dan khan kal char char ila. Tukin chu kan Home Minister chhantur a tam avangin, a ding zing deuh dawnah ka ngai a; a rawn inbuatsaih tho turah ka ngai a. I ruling neihsa – ‘Zawhna neitu bakah zawkhah pahnih’ tih ang khan han strict deuh mai la a tha zawk dawnin ka hria a ni.

**HON. SPEAKER :** House-in tha kan tih chuan kan kal thei tho a. Ka rawn che u a ni a. A ngai ang kha anih chuan, a ding tauh tauh mai dawn a ni a. A lainat awm deuh e tih thu a ni a.

**PU C. LALSAWIVUNGA, MINISTER:** Pu Speaker, Question hi ballot a ni a, zawhna zauktute tan an zawhna lo chhuak tur hi a nghahhlelhawm ve thin hle a. Kan Home Minister chu a hah deuh mai ang a, ballot a nih ang hian kalpui theih ni se.

**HON. SPEAKER :** Aw le, a nih aw; ballot angin kan kal ang. *Starred Question No. 62* hi kan la leh hram ang a. Amaherawh chu, ka ngen duh che u chu, Zawkhahna hun kan hawn lai hi kan hrethiam ve tho a, heng hunlai hian lo phar thin ula, tih kha ka sawi duh a ni.

*Zawkhahna – Zawhna neitu, Dr. K. Beichhua, Siaha Bialtu.*

**DR. K. BEICHHUA :** Pu Speaker, conventionally-in zawhna neitu hi chu zawt belh ngei tura ngaih a ni a; ka kut ka lo phar tawi deuh nge ni.

Pu Speaker, a lawmawm khawpin ka hria a. Mizoram hi State-ralmuang kan ni a, ‘ralmuang lo ta thut se’ tih ngaihtuahna a kal thui viau thin a. Hman kuma Assam nena kan buai pawh khan, ngaihtuahna a kal thui viau a ni. Chutih lai chuan, hei, vacant post heti zat lak tumna a awm hi a thlamuanthlak a, kan Home Minister hnenah lawmthu ka sawi a ni.

Tichuan, “Engtikah nge heng post te hi lak tum a nih? Tuna lak tumah hian post engzat nge lak tum a nih?” tih kha ka zawhbelhna ni se. Tin, a lak dan tur-ah khan hmanniah MSSSB pawh kan sawi nasa a. “Enktianga recruitment kha kalpui tur nge a nih?” tih Mizoram mipuite’n kan hriat atan min han hrilh bawk se.

Pu Speaker, mahni bial a ni a, bial-mipui ten min thlir reng bawk a. Siaha SP office leh quarters te hi UT hunlaia sak a ni a, a tla-bal tawh viau a; loh-theihlohma avanga la awm mai mai an ni a. Sawng ho saw sak that tumna a awm em?

Tin, Siaha District Jail fencing tihlai hi, tunge a contractor? Cheng engzata sak nge a nih? Engtika zagh tur nge ni ang? Jail building leh Jail Superintendent building-te hi sakthat tumna a awm em? Khang kha ka zawhbelhna a ni e.

**HON. SPEAKER :** A lawmawm e. Kan Home Minister zahawm tak chhang turin kan sawm ang a, a theih ang angin han chhang se. Sawi tawh angin, a karkik khawp mai a, Jail building atangin, thil hrang hrang post chungchang te kha a ni a; Minister zahawm tak Pu K. Sapdanga ilo sawm ang.

**PU K. SAPDANGA, HON. MINISTER:** Pu Speaker, Lunglei West Bialtu Pu T. Lalhlimpuia zaghna Police Housing Scheme Lunglei lamah tihselh kha - tunah hian Police Housing Scheme hi SASCI atanga kan neih a ni a. Cheng vaibelchhe 50 ruahman a ni a, chuta chuan crore 25 dawn tawh a ni a. A hmasa hi chu Aizawl leh a chhehvelah hian hmang phawt ila, a dawt leha lo kal tur hi chu zau zawkalpui ni se tia ruahman a ni a. A dawt hnaivai takah hian Lunglei leh a chhehvel hmun zau zawkah Police Housing Scheme hi kapui tum a ni e.

Tin, Thorang Bialtu Pu R. Rohmingliana zaghna kha - Post ruak hnawkhah tumdan kha, department-in kalphung a nei a. Chumi ang chuan post ruak hi chu hnawkhah tum a ni mai a. A dan kan en ang a, chumi ang chuan kalpui tum a ni e.

Bunghmun Outpost motor chhia chungchang kha, Police Station hrang hrangah hian kan duh khawp motor kan nei hauh lova, a theih ang tawkin kan semzai a. Outpost thenkhat phei chuan motor pawh an la chang lo zawk a ni. Theih tawpin sawrkari tan

a la mek a, motor pawh tlema indaih theih deuh beisei a ni a. Chung hunah chuan kan inthuam tha zel ang a, a hlui deuh siamthat emaw, a thar zawka thlak emaw tum a ni e.

Tin, Tuichang Bialtu Pu W. Chhuanawma zawkna – ‘Kum 2018 March ah khan Khawhai ah Outpost hawn tum’ tih thu kha, sawrkhar leh department record ah hmuh a la ni hauh lo mai a. Chutiang chu a lo awm a nih chuan, kan lo zawng chhuak ang a, hmalak tum dan te pawh a la awm ang chu. Tun dinhmunah chuan Khawhai Outpost hawn tum a nih thu hi record kan nei rih tlat lo mai.

Zawkna zawttu Siaha Bialtu Dr. K. Beichhua zawkna - “Engtikah nge post ruak te hi hnawh khah tum a nih?” tih kha, tunah inbuatsaik mek a ni a, a zavaia vawikhata hnawh khah sen rual a ni lova. Kan sum dinhmun ten a tlin lova, tlem tlemin hnawh khah tumna a awm a. Tunah pawh a ruak thenkhatte chu hnawhkhah tum mek a ni a, a diltu engzah chiah nge ni ka hre lova. ‘A vawikhatnaah atan engzah nge kan hnawh khah theih ang’ tih te ngaituah mek a ni.

Tin, Siaha Police Station sak that tumna a awm a, nichina kan sawi tak ang khan. A housing lam leh a police station lam te tih that hi chu hmatiam a kalpui tum a ni. Tin jail building sak that tumna pawh hi, tuna proposal ah hian, ‘ram pum huapa tih theih dan tur ngaituah ni se’ tih a ni a, chu chu rawtna awm mek a ni a. Champhai District Jail chang ni lova, jail dang zawng zawngah hian awm thei tur anga ruahman let deuhthaw an awm deuh vek mai a. Kan jail leh jail-a awm tura ngaihte a inbuk tawk lo hle mai a. Chuvangin, eng emaw tih hi chu a ngai a ni phawt mai.

Mizoramah pawh, “Mizoram Goods and Services Act, 2017” chu Taxation Department-in kengkawhin GST hman anih hnuah hian nasa takin chhiah atanga kan sum lut pawh a tam phah a ni.

GST hi kan hriat angin Centre leh State-in inrawn tawna an kalpui a ni a. Centre GST 2017 nena kal kawp turin state GST kan lo nei ve theuh bakah mahni duh dana lo insiam

that amend ngawt theih a nih loh avangin, keini pawhin Central-in a tih danglam rualin kan lo tih danglam ve zel a ngai thin a ni. Kan danpui Article 279 A(i) hmanga din GST Council hian thuneihna sang tak neiin GST Act hi a tidanglamin ruahmanna pawh a siam thin a. GST Act siam that a lo tul hian Union Budget-a Finance Bill kaltlangin Income Tax Act, Customs Act leh a dangte ruala tih danglam tura dahkhawm a ni thin a ni. Sorkar laipuiin The Central Goods & Services Tax Amendment Act, 2023 a a notify hnu khan keini tan The Mizoram Goods & Services Tax Amendment Bill, 2023 hi chu buatsaih nghal a ni a. Amaherawhchu, Assembly Session a awm tak loh avangin Mizoram Goods & Services Tax Amendment Bill, 2024 anga buatsaihin tunah hian kan pawm tlan tura rawn chhawpchhuah a ni ta a ni.

The Mizoram Goods & Services Tax Amendment Bill, 2024 chuan heng section 2 leh schedule-te hi a amend a –

*Pakhatna* - section 2 definition clause 80(a), 80(b), 102(a), 105 leh 117(a) te belh niin ‘online money gambling’ chungchang sawifiahna a ni a. Hei bakah hian *specified actionable claim*-in a huamte a rawn amend a. Heng betting, gaming, horse-racing, lottery leh online money gaming-te hi ‘specified actionable claim’ hnuaih an awm ta a ni.

*Pahnihna*: Section 24 - ‘compulsory registration in certain cases’ tih hnuaih clause 9-na sentence tawpa ‘and’ tih chu pailh a ni a, clause 9(a) chu dah belh a ni a. India ram pawn cheng ten India ram chhunga cheng nena online money gaming an hrall/pekin ‘supply of goods or services or both GST’ dan hnuaih registration neih ngei ngei a ngai tawh a ni.

*Pathumna* - Schedule 3-a ‘activities or transaction which shall be treated neither as a supply of goods nor supply of services’ tih hnuaih ‘actionable claims other than lottery, betting and gambling’ tih chu ‘actionable claims other than specified actionable claims’ tiha thlak a ni. Heti hian GST lak lohna ‘actionable claims’ atangin lottery, betting leh gambling chu lak sawn anih tak avang leh, online money gaming chu GST hnuaih dah belh a lo nih leh tak avang chuan GST lak theihna tur a tam sawt tura ngaih a ni.

Pu Speaker, kha kha sawi ho tura ka rawn chhawpchhuah chu a ni e. Ka lawm e.

**HON. SPEAKER** : Move rawn dil nghal la.

**PU K. SAPDANGA, HON. MINISTER:** Pu Speaker, sawiho turin ka rawn move e.

**HON. SPEAKER** : Aw le, a lawmawm e. Bill puluttu Minister zahawm takin a Bill chungchanga sawi turte sawiin, a Bill putluh chhante min rawn hrilh tawh

a, a rawn move nghan bawk a. Amendment Bill a nih avangin sawi ho vak ngai lo turah ngai ila. A move-tuin fiah takin amendment ngai chungchangte, a tul chhante a rawn sawifiah tawh bawk a. Hetiang amendment bill siam rem hi chu sawi vak lovin, pass a ni thin a. Tun tumah pawh hian sawiho vak ngai lovin, khuallian kan nei dawn nen pass maithei ila a va duhawm em! Member ten comment duh kan awm em aw? A comment theih loh a ni lova. Aw, member zahawm tak Pu R. Rohmingliana i lo sawm ang.

**PU R. ROHMINGLIANA:** Pu Speaker, helaiah hian theihtawpin kan lo en ve a. Nichina a mover-in a rawn sawi ang khan, GST kan hman atangin kum 6 leh a chanve leh ni 23 chiah niin ka hria a. Helaiah hian kan pass lo thei pawh a ni chuang lova, kan tih ngei ngei tur zawk a ni a. Sawi vak a ngai lova, a move-tu khan a rawn sawi chiang hle a. Dual Authority - State government leh central lampang a ni a.

Amaherawhchu, he amendment-a ka rawn sawi tum zawk taka chu, nakinah min windup sak hunah helai hi keini dan siamtute hian kan dan siam amend ngei pawh kan chian loh ka hlauh avangin, min rawn sawifiah sak tura duh lai ka nei a. Chu chu – ‘Betting’ han tih lai hi Mizoram-ah eng ang chi nge kan hman dawn, he betting-ah hian? Sports-ah ka in bet-na ang chi, *Entirnan*: Ar sual-huai kan lo pawm a, kan insual tir vak vak mai a, khalaiah khan pawisa kan bet a. Khatiangte kha nge nia, a engchin hi nge ‘betting, gambling’ tih laite pawh.

Tin, horse-racing kha chu a chiang thei maiin ka hria a, lottery te pawh. ‘Online money gaming’ tih lai te pawh kha, eng ang chiah kha nge ‘online money gaming’ hian a huam? Pub-G an tih te a, khatiang thil hrang hrang kha a awm thei a. Khalai kha heti GST-ah hian rinhluh nimahse, *Entirnan*: ran insual tir ang chi hi a ni emaw; a enga pawh nise, bawng insik tirtre pawh, ar mai niloin. Hengte hi kan sawrkar hian a phal reng em? Hei hi amend pawh ni ila, kan State-sawrkar ah hian kan hmang thei tak tak dawn em; Kan revenue a that phah dawn em, tih lai kha chiangkuang deuh hlekin a move-tu khan windup hunah min rawn sawi fiah se, Pu Speaker. Ka lawm e.

**HON. SPEAKER :** Pu Lalchhandama Ralte, Opposition Leader ilo sawm ang.

**PU LALCHHANDAMA RALTE, OPP. LEADER:** Pu Speaker, i sawi ang khan, GST - *Mizoram Goods & Services Tax Amendment Bill* bik hi chu pahnih-khatin kan han sawi bak hi chu, hei hi chu tih makmawh a nih avangin, kan han pass liam thin a. Amaherawhchu, Member zahawm tak Thorang Bialtu sawi ang khan, he House-a kan dan pass-te hi zawh duh leh han hriatfiah duh lai kan neihte hi Mizo mipuite hnenah hriattir a ngaih avangin tih a ni thin a. I veilam atang chuan Leader min koh tawh avangin, midang hi chu phar mahse, duhtawk mai ila, helai bikah hi chuan. Mahse Pu Speaker, a tax chungchanga ka luh hmain, tlemte thil dang sawi lawk duh ka nei a. Vawiinah kan Vice President a lo kal dawn avangin kan House schedule pawh

kan han tidanglam a, a dawnsawn dan turte pawh kan inruahman a. Amaherawhchu, i ding lama thu sawrkar laite hi uluk taka an ngaihtuahna hmang nawn turin, hun lo kal leh atan pawh ka chah duh a ni. Chu chu, he House hi session kan kal lai a ni a, zahawm taka engkim kan kal a ngai a, ram rorelna sang ber a ni a. Vawiin niah kan Chief Minister, kan House Leader chu dan angin protocol-ah a kal ngei ngei a ngai tih kan hria a, kan hrethiam vek a, a aiawha GAD-te pawh Home Minister-in a chhan kha a awm ka ti a.

Tin, kan Transport Minister pawh railway chungchangah, Prime Minister program a nih avangin Sairang lamah te a zu tel ve a ngai a, a concern a ni a. Kha kha chu kei pawhin ka hrethiam viau mai. Amaherawhchu, '*Goods & Services Tax Amendment Bill*' kan sawi a, a introduce-tu tur Taxation Minister hi, nichinah a I&PR Minister a nihna anga a zawhna pawh kha chhan a ni a, amah hi chuan helai House a awm hi a chak ngei ka ring a.

Kan House Leader, Chief Minister hi chu hun lo kal leh turah hi chuan, kan House proceedings - List of Business awm zawng zawng zirtawpni ah kan hmu vek tawh a; Vice President dawngsawng tura ani kher kher University-a tirha hi chu, ennawn a thanin ka hria, hetiang ni khua ah hian. Kan Minister dang rual fel tak tak, lo dawngsawng thei tur Cabinet-ah a ni emaw, MoS ah a ni emaw, kan ngah a. Helai House bikah zawhfiah kan neih hi a rawn move tu khan a tih theih si loh chuan, ram rorelna atan a pawi theih ka hlau a; kan Minister hian hetah hian chhan a chak ka ring si a.

Thil lo thleng that - accidental a ni lova, kar hmasa atanga programme - list of business duan sa tawh ah hian he rorelna ina aikal kan la char char mai hi a dik lovin ka hria a. Chu chu, hun lo kal zel turah i dinglam ten an hriat ka duh avangin kan sawi a ni.

Kan hriat ang khan, GST hi India ramah July, 2017 atangin kan han hmang tan a ni a, constitutional amendment kaltlanga tih a nih avangin, hei hi chu tih ngei ngei ngai, GST council ah, State tin Finance Minister (kan Chief Minister) te zuk thu ina engkim an rawn ruahman sa vek tawh a ni a, Dan angin State Legislature-ah kan pass ngai a ni. Chumi ah chuan, vawiinnia han zawh ve, han sawifiah atana kan duh lai thenkhat awm a chu, 6<sup>th</sup> November (nikum) ah inthlan te kan neih avangin, GST chungchang - GST council meeting vawi 50-na leh 51-na thu hi a valid theih nan ordinance-a lo hman a ni tawh a, 'State engzatin nge tunah hian an State Assembly ah pass tawh' tih te hi ka zawhna pakhatna a ni a.

Tin, *GST Amendment Bill, 2024* ah hian, 'online gaming' tih kha, nichin khan Thorang Bialtu khan a rawn zowt tawh a, han sawifiah ngai lai deuh a kha a awm a. Helaiah hian 'gambling' tih te thil tam tak awm a awm tel a. Heng chungchangah hian sum leh pai kan lakna tur, resource mobilize-na tur thar eng emaw zat chu a awm kan han tih rualin, kan fimkhur ngai leh kan sakhuanna nen pawha enrem ngai a awmin ka hria a. Pawisa

inthapna - gambling kha Dan anga kan phalna turin ‘*taxable*’ ah kan dah dawn ta a. Hengte a vang hianin pawisa inkhelhna eng emaw chen hi miin an rawn siama tax kan lak hian, kan society leh kan kohhran pawhina kan phal loh tam tak a hi kan ramah hian kan introduce phah thei ang em; tax kan lak chuan Dan ang a nih tawh dawn avangin?

Vawiin hi kan Dan siam pawimawhna lai taka chu, helaia pawisa inkhelhna chi hrang hrang kan phalsak theihna turah hian, Act enforce dawnah khan sawrkar hian fimkhur takin rules emaw, thil dang emaw a siam loh chuan, kan hnam leh kan sakhuana kal zel tur atan pawha kan duh loh thenkhat hi; India ram puma dan tha tak thenkhat pawh hi Mizoram tana tha kim lo a awm theih avangin, dan angin Assembly ah kan sawia, kan tih kan tih rual pawh hian, a umzuina kawngah hian kan sawrkar hian fimkhur zawkin hmang se kan ti a.

Tin, a tawpna atana zighthna ka han siam duh chu - amendment kan siam turah hian GST kan la dawn ta a, sawrkar hian heng - online gaming te, horse riding te, sum khelhna - casino ang chi te kan phal turah hianin, engzat percent nge GST chu la turin kan inruahman? Vawiinah hian tax amendment kan siam a, tax lakna tur kan siam dawn ta a ni a, engzat percent nge chung taxable item kan han siam tharah chuan lak kan tum, tih kha kan zighthna a ni.

Eng le khaw le, ram pumah tih makmawh kan chungah lo lut a nih avangin, hei hi kan thlawp loh theih lohah ka ngai a. Chutih rual chuan, a enforce zelna turah hian kan sawrkar hian, fimkhur takin tax kan lakna tur chungchangah pawh, kan sakhuana leh kan hnam kal zel tur himna, zahawmna ti bawrhbang thei a awm pawhin, rules kan govern tur ah pawh chulai chu tlema rawn fimkhur chhunzawn turin kan innge a ni e. Ka lawm e.

**HON. SPEAKER :** A lawmawm e. Kan duhtawk thei tawh mai em? Dar 12:00 ah te hi chuan chawl thei ila a duhawm khawp mai a. Aw le, comment duh kan la awm em? Aw, Pu Raksik Mohan Chakma ilo sawm ang.

**PU RASIK MOHAN CHAKMA:** Pu Speaker, ka lawm e. GST kan amendment tura online games te ka’n hmuh takah chuan, kan area problem pakhat ka hrechhuak a; a inang thuakin ka hria a. Hemi subject ni chiah pawhin ka hre lova; a lo ni lo a nih pawhin, in mi hriathiamna ka ngen a.

Meghalaya sawrkarin, archery game an tih ang hi sawlamah an uar ve khawp mai a, ‘Thir’ an ti a, archery chikhat a ni a, a thalo hle a; social evil dik tak, mi tam tak, chhungkaw tam tak tawrhna a thlen tawh a. SP nen pawh khami issue kha kan take-up a, nuai engemaw zat chu transaction a awm reng a ni, thla tinin. Kha kha sawrkarah engmah chhiah an pe bawk si lova, *trade* ang reng a ni bawk si a. Dan lo anga an tih nasat vang khan, kha kha tih tawp dan a awm em? Home Department chan a ni mah

mah em aw? A tihtawp theih loh chuan heng GST ah te hian legalise law law ila, tax pe sela a tha zawk dawn a. Lawngtlae SP nen pawh he issue hi takeup tawh a, a tihtawp tak tak thei lova. Mi tam tak tawrhna leh chhungkaw tam tak tan harsatna thlentu a ni. Chuvangin, rem leh rem lovin ka han sawi chhuak hram a ni e.

Kan area ah sawn problem lian tak a tling a, illegal thil a ni. Hemi titawp tura kan police-te inpekna pawh a chhuanawm lutuk, mahse, engatinge kha kha kan tih tawp theih tlat loh? Ngenna district level SP ah pawh ka siam tawh a, keimah ngei pawhin SP ka hmu a ni. Mahse, tun thlengin a la tawp thei lo a ni. Hei hi engnge a solution ni ang aw ka ti a. Pu Speaker, nangmah kaltlangin he House ah hian kan ngen duh a ni e. A bak GST kha chu kan hria; GST council in a pass tawh a, kan state sawkarin a tih tur chu, amendment siam a ni mai a. Tin, tunah ordinance in a kal mek a, tunah hman mek a ni a, procedure dan angin amendment siam tur a ni mai a. Chuvangin, hemi thu ah hi chuan sawi tur vak emaw, hnial vakna tur emaw awmin ka hre lova. Amaherawhchu, kha archery game – ‘Thir’ an tih hi sawlamah an uar em em avangin, khan kan society leh khawtlangah harsatna tam tak a thlen a; hei hi tihtawp emaw, legalize dan dan awm se ka ti khawp mai, Pu Speaker. Ka lawm e.

**HON. SPEAKER :** Tikhon, kan Minister kan sawm tawh mai dawn em ni ang; dar 12 :00 a ni mai a? Central lam atanga lo kal, *Central Act* a ni a, a nihna takah chuan. State-in kan adopt tur thil a ni a, kan ngaihdan leh kan duhdan a nih lutuk loh dan a awm a. Amaherawhchu, member zahawm tak te’n in sawi kha a dik khawp mai a. Heng thil, kan khawtlang nun nghawng thei thil awm te hi chu kan fimkhur a ngai khawp mai. Kan sakhuana te, kan inrelbawl nate, ram pum tana tha tak kha kan ram tan a lo tha kher lo mai thei a, ‘a implementation ah i fimkhur tlang ang u’, tih kha ni mai sela, a tha in kan ring a. Engnge memberte ngaihdan? A dang kan la leh dawn em ni ang? Aw le, sawi ang aw. Member zahawmtak Pu TBC Lalvenchhunga ilo sawm ang.

**PU TBC LALVENCHHUNGA:** Pu Speaker, ka lawm e. *‘The Mizoram Goods & Services Tax Amendment Bill, 2024’*, a tax-by-tax ah chuan memberte ah pawh tlem chuan buaina kan nei niin a lang a; Minister a awm lo a.

Heta kan insertion - *betting, casinos, gambling, Horse racing, lottery, online money gaming* te hi, kan Leader of Opposition khan a rawn sawi chiang bawk a, kan sawrkar thil tum leh kal dan hi mipuite’n an hriat a tha telin ka hria a. Tuna *Public Gambling Act* kan neih hi ‘1962 extension to Mizo District’ tih hi ni maiin ka hria a, (ka hriat sual loh chuan) a outdated em em mai a, a hlui tawh a; siam that ngai emaw a nih chuan ngaihtuah hun tak, he dan kan incorporate hian a rawn tilangin ka hria a. A bik takin, tuna kan rawn tih zing ami ‘*online money gaming*’ kan tih te, lottery te, online state-lottery te thleng hian kan sawkarin a kalpui mek leh, sawrkar kal ta pawhin server nena a lo buaipui leh established fel vek tawh a ni a, heng atangte hian kan sawrkar hian hma a la chho turah ka ngai a. Chu chu, nakinah inpuhmawhna te a awm takin, tun sawrkarin

a rawn tih leh eng lo ni lovin, sawrkar kal ta atanga hmalakna awm mek niin ka lo hria a, ka hmuh chinah. Chungte avang chuan, heta ‘sintax’ kan tih ang deuhthawa 28% maximum a kan levy vek pawhin, state dang pawhin an tih dan a ni a.

Chutih rual erawh chuan he state-a ZPM sawrkar a lo pian tak avanga hei hi introduce nia ngaite kan awm theih tak avangin, leh, vawiinah hian sawrkar kal tawh’tan an lo tihfel vek tawh leh ruahmanna awm sa vek, infrastructural pawh tuna kan englo vek sa a nih avang hian, hei hi nakinah mipuite’n kan ngaihthiam loh ka hlau deuh hlek a. Hei hi state-in resources kan neih - taxable kan neih ang chi zawng zawngte, a bikin ‘*online gaming*’ kan han tih ang chi te, casinos te. Tin, thalaite zingah *online gamer* heti zat kan nei tawh a, ‘hub’ ang te pawhin a awm a. Loh theih lohin khang atanga sawrkarin a lo lak pen ve theih tur, a bikin 80 band ang chi te, US tax loss kan neih ang chi te, ‘Youtubers’ kan tih ang chi te hengho zawng zawngah hian central sawrkar pawh a strict sawt em avang leh, kan sum hnar hmuh theih vena tur a nih avangin, tul pawh a tul a, India ramah kan awm miau avangin.

Chutih rual erawh chuan, *Public Gabling Act, 1962* kan neih lai erawh hi chu a hlui em em mai a; Dan neih sa kan nei a, hei hi kan repeal tawh a, a thar kan mamawh dawn tihna a ni a. Chuvang chuan, hetiang issue-ah chuan sawrkar pawhin hmalak lehzual a ngai dawn niin a lang a. Khalai te kha a thlirtu mipuite pawhin in lama min lo thlir avangin, nakinah khan sawrkar thar hmalakna leh tih tum vang liau liaua ngaite kan lo awm takin; kalphung pangngaia kan lo neih tawh leh, he state sawrkar ngei pawhina hma an lo lak mek tawh implement mai theih tawh tura he danin a rawn hrual tel a ni a; kha kha ka’n sawi tel duh a ni e. Ka lawm e.

**HON. SPEAKER :** Tunah chuan, a move-tu Minister zahawm tak kan sawm ang a. Khang comment te leh zawnate leh clarify tura member zahawm takte’n an chhawp chhuah kha, a clarify thei mai rih lo a nih pawhin, a changtu minister a nih loh avangin, nakinah a changtu minister pawhin ziak te pawhin la inhriattir thei turah ngai ta ila. Tunah a move-tu Minister zahawm tak Pu K. Sapdanga ilo sawm ila, pass rawn dil nghal se la a tha ang e.

**PU K. SAPDANGA, HON. MINISTER:** Pu Speaker, Member zahawm tak ten thahnemngai takin an sawi a, GST hi a pawimawh reng lah tak a. Sawrkar-laipuiah a ni emaw, state sorkarah a ni emaw chhiah hi sawrkar innghahna a ni a. Chuvangin memberte’n uluk taka pass an han duh kha a lawmawm tak zet zet a ni. Amaherawhchu, GST hi a har viau mai a, sawrkar-laipuiah pawh, state sawkarah pawh a kengkawhtute hian englai pawhin an zir reng a ni mai a.

Tichuan, zawnate tlem tlem lo awmte kha han chhan theih chin a awm ang a, tunah hian vawiina kan bill pawm tur hi India ram state zawng zawngah hman tawh a ni a, keini

hian ordinance hmangin tihian kan practice mek a, chu chu, ‘Act’ ah kan chan tir dawn ta a; a hnuhnung ber kan ni e.

Tin, kan rawn sawi chhuah thenkhat eng engemaw game chi hrang hrang Ar insual tir a ni emaw, bawng insik tir a ni emaw hetiang lam kha Act ah hi chuan a lang chiah lo na a, betting han tih atang khan hlauhthawn kan nei deuh niin a lang a. Engpawhnise, cruelty to animal act tihte kha a awm a, khang khan khab a nei a, dan hi a awm a, a sir lawkah hian chu dan chhunga phal theih niawm tak khabna hi a lo awm ve zel a, chuvangin vawiina kan pass tur good and service tax (amendment) Bill chhungah pawh hianin kan hriat tlan atana ka duh chu sorkar laipuiin a tarlante kan pah ngawt a rem lova, kan belh ngawt pawh a rem hek lova, GST chu angkhat tlanga kan lak tur a ni a, a inkalh thiang silova. Chung avang chuan kan ram tana chuangtlai deuh anga lang lo tarlan te pawh a awm a niang e. Engpawhnise, member zahawm takte kan thahnemngaihna leh kan rilru senna zawng zawng avangin lawmthu ka sawi a.

Pu Speaker, he Bill hi India ram puma hman tawh leh keini pawhin kan pass ngai anih avangin he House zahawm takin min pass-pui turin ka rawn ngen e. Ka lawm e.

**HON. SPEAKER :** Aw le, kan Minister zahawm takin “*The Mizoram Goods and Services Tax (Amendment) Bill, 2024*” chu House pass-pui turin a rawn dil a, tunah kan buk ang a.

Pass remti apiangin ‘remti’ ti ula, rem tilo kan awm chuan, ‘rem tilo’ ti ula. (*Memberte ’n pass an remti a*) Aw le, a lawmawm e.

“*The Mizoram Goods and Services Tax (Amendment) Bill, 2024*” chu he House hian lungrual takin a pass ta a ni. (**Pu K. Sapdanga, Minister:** Pu Speaker, ka lawm e.)

**PU LALDUHOMA, HON. CHIEF MINISTER:**

**ADDRESS BY THE HON. VICE PRESIDENT OF INDIA:**  
**SHRI JAGDEEP-JI, HON. VICE PRESIDENT OF INDIA:**

Greetings to all of you! I am indeed overwhelmed. What I see in the house that is nearly in full strength is a message I will take from this place to all the legislatures and Parliament. It is a privilege and honour to address this august assembly. It is a matter of pride that this assembly has three women members for the first time. Congratulations to them. Their presence in this house reflects increasing participation of women in governance and policy making. We are fast heading towards women-led development. The spectacular performance of our girls on the Republic Day at Kartavya Path was a defining moment of welcome change. On September 20 and 21 last year, Lok Sabha and Rajya Sabha passed a constitutional legislation - *Nari Shakti Vandana Adhiniyam*, providing for 1/3rd reservation for women in Lok Sabha and state legislatures. This became law and a constitutional prescription with the signing by the Hon. President of India, Smt. Droupadi Murmu, the first tribal woman to occupy the highest constitutional office in the largest democracy on the planet, home to 1/6th of humanity. What a glorious moment! An epochal event! A tribal woman president embedding this historical change, this game changer provision in the Constitution. This involvement of women in Lok Sabha and Legislatures will be transformational in evolution of policies and governance. So, be prepared in the state assembly elections to come, witness amazing soothing spectacle in this House of 40, where 13 or more members will be women participating in policy making and governance.

It is a matter of joy for us all that our nation is on a path of unprecedented progress. Our economy a decade ago was at number 11 in the world. Now we are the fifth largest global economy, ahead of Canada, UK and France. As a nation, we are already 3rd largest in terms of purchasing power. In coming two-three years, we'll be third largest global economy, ahead of Japan and Germany. The country now has world class infrastructure of roads and connectivity. In all this development, North-East, including state of Mizoram has been a significant partner. The region has seen unprecedented, exponential growth in last decade. The government's policy of Look East-Act East has been a game changer. Last decade has been the Golden Era of the North-East. The NE council played a crucial role with achievements of over 12000 kms of road, 700 MW power plants and establishment of many national institutions. Friends, the entire world applauded India's presidency of G20 giving us high global image. G20 meetings were held all over the country including Mizoram. Thereby, Mizoram has gained significant footing in tourism. The International Travel Mart, 2022 that concluded in the capital city of Mizoram witnessed laying of the foundation stone of the Aizawl Convention Centre at Chite, a PRASAD Project in Mizoram and two Bamboo Link Roads. The

Aizawl Bypass Road and Bamboo Link Roads are being developed at a total cost of INR 600 crores under the PM-DevINE scheme, out of which two Bamboo Link Roads are being constructed at the estimated cost of INR 66.42 crores and INR 33.58 crores, respectively. With the development of Aizawl Tourism Convention Centre and two bamboo link roads, there will be upward surge in tourism in the state. Aizawl Convention Centre will be critical in making significant economic contribution to Mizoram. Mizoram is gifted with incredible beauty and cultural richness. Mizoram is a dream destination of tourists, surrounded by lush green hills and villages. These developmental activities will enhance tourism in the area.

I commend members of this august assembly for reflecting discipline and decorum worth emulating by others. I look back at the Constituent Assembly debates, for about three years, the Constituent Assembly debated, discussed, deliberated and grappled with issues that were contentious and highly divisive. There was never an occasion for them either to engage in disturbance or disruption or come to the well. I find in this house- what I have seen and heard about it- quite close to the performance of Constituent Assembly members of which assembly gave us the Constitution. I will take this message in all earnestness, because I am motivated, inspired that if such an ecosystem is there in temple of democracy, the nation benefits, the state benefits and the people prosper. We all in the nation are part of marathon march for *Viksit Bharat@2047*.

This august assembly needs to roll out a road map of growth and development that is futuristic and contributes to the success of this glorious marathon for *Viksit Bharat@2047*. Your enormous potential in tourism and horticulture, local art and products needs to be fully exploited. It makes available for young minds great opportunities. The remarkable focus on North East India with a separate department, DONER has yielded results. The exponential rise in physical and digital connectivity, roads has been a game changer. Friends, it is time for us to keep our nationalism uppermost and take pride in being Indians and in India's historic achievements. We all in the country, have to keep our nationalism uppermost. We have to take pride in being citizens of this great nation. We have to be proud of our exponential, phenomenal rise in all sectors that is being applauded by global institutions. It's time for us to be guided by what Dr Ambedkar has reflected, "*You should be Indian first, Indian last and nothing else but Indian.*"

I invite all the Members of this august Assembly to visit the new building of Parliament, Bharat Mandapam - venue of G20, and Yasho bhoomi - venue of P20 as my guests. It will be an honour for me and for the members in the Parliament as they will be able to interact and give a different kind of thought process about how a House can be handled so decorously and in a dignified manner, giving highest productivity. Hon'ble members, we have to look at the contemporaneous scenario for India at the moment which is upbeat in every walk of life. If you talk in terms of economic development, the world

is taking us to be the hotspot of opportunity and investment. We have been ranked very high by Global Institutions like IMF and World Bank. When we think in terms of infrastructure, something which was beyond dreams and accomplishment, is now a ground reality. I had the occasion to be your member of Lok Sabha in 1989.

We know the situation then and most of you gather about it, we were in a very difficult situation economically and otherwise. Imagine the plight of the nation that once known as a golden bird, the gold has to be airlifted, placed in two banks in Switzerland to sustain fiscal credibility and now that is something which we can't recollect. We are marching ahead of other nations, developed nations. Those who sought to give advice to us, are seeking our advice. They are coming this country with hope and optimism to make opportunities available to them. In this kind of scenario, it lies in the domain of Legislature to play the decisive role of enlightening the executive and ensuring that we are on a passage that is fastest so that we become a global power.

Never before, our youth had any ecosystem available to them that they could, by virtue of governance policies and initiatives, exploit that talent, realise their ambitions and dreams. This state is full of hope and possibility, this state has to work through the wisdom of legislature to unleash the opportunities, be it in hydro power, be it in tourism, be it in start-ups. These are the times where a constraint of place is no longer a constraint, with digital penetration taking place in our country that has stunned world institutions. Our digital penetration was remarked upon by the World Bank, which stated that India achieved things in 6 years which could not be achieved by others in four decades and more.

If you take it our transactions in this forum in 2022, they were four times the transactions of USA, UK, France and Germany taken together. Look at the genius of our people, their adaptability to technology, that per capita internet usage in our country is more than that of China and USA taken together. The entire country could weather the storm of pandemic COVID because we had a mechanism of having inclusive growth. It is difficult for the world to recognise that this country has 500 million bank accounts that reflects adequacy of banking inclusion of the ordinary person. The person in the last row is being benefited by governance. The nation stands for all. The kind of development I can assure you friends is taking place not in periodical manner. Everyone is benefiting thereby and this part of the country in particular is gifted by nature with beauty, elegance forests, there could hardly be a rival place where there are opportunities for tourism.

I call upon the members of this House: in tandem and togetherness, evolve a mechanism so that youth of your state are able to take full advantage of the opportunities that lie ahead on them, including in areas of which you all are aware- disruptive technology. We have to live with them, we have to use them we have to face the challenges they

offer us and that can be done only when in one voice, this august house, gifted house, shows the way to the youth and other people that yes, it is time to unlock the lock and reward the nation and state with progress that is ours!

I thank each one of you for sparing time. I know having been junior Parliamentary Affairs Minister in 1990 and Chairman Rajya Sabha, the presence in this number, it could not be more. I will carry these memories in my heart all my life. Best of luck to all of you! Best wishes and I look forward to receiving you as Chairman, Rajya Sabha as and when you make it convenient, in groups or individuals. Thank you so much for the time and opportunity made available. Thank you.
