**PU LALDUHOMA, HON. CHIEF MINISTER:**

1. Vawiina he 9th Mizoram Legislative Assembly chhunga kan Budget hmasa ber pharh tura ka lo din chhuah hian, he Sawrkar lo ding thar mekin ram hmasawna atana kan hmahlir leh ruahmanna kan lo siamte a taka thawk thei tura remchang min siamsaktu Mizoram mipuite chungah lawmthu ka han sawi hmasa duh a ni. He Budget kan buatsaih laia kan ngaih pawimawh ber chu Zoram mipuite tana ei leh bar zawna kawng tlo leh nghet zawk buatsaih hi a ni a. Chumi tihlawhtling tur chuan langtlang leh rintlak taka sum leh pai enkawl hi kan ngaih pawimawh hmasak tur a ni baw k a. Tin, heng sumte hian mipuite a thleng ngei a ni tih leh tangkai taka hman an ni ngei a ni tih va finfiah kha kan tum tlat baw k a ni.

Kan State mipui ei leh bar zawna kawngah hian tertiary sector kan tih mai, service sector hian hnuhma a nei lian ber a; industry sector, secondary sector kan tih baw k hian dawtin, Agriculture & allied sector atanga kan thawh chhuah hi a tlem ber thung a ni. Kum 2024-25 chhunga kan GSDP chu current price tehkhawnga hmangin Cheng Vbc. 48037.52 ni tura chhut a ni a, kum 2023-24 RE-a kan GSDP chu Cheng Vbc. 39355.69 a ni. Tichuan, nikum RE atanga kumina a punna tur hi Cheng Vbc. 8681.83 a ni.

3. Kum 2023-24 BE-a kan Gross Fiscal Deficit Cheng Vbc. 1247.21 chu Cheng Vbc. 118.49-a pung chhoin Cheng Vbc. 1365.70 ni tura ruahman a ni a. GSDP atanga chhutin kum kal mek 2023-24 BE-a 3.47% leh RE-a 4.73% chu kum 2024-25 BE-ah chuan

2.84%-a khung tum a ni. Pu Speaker, kan sawi lan tel duh chu GSDP hi projection mai a la ni a, la danglam leh thei reng a ni thung.

4. Chumi atan chuan a bul tan nan kan sum hmanna te thlirin tul baka kan hmanna ni a hriatte tihtawp leh tihhniam kawngah hma kan la dawn a ni. ***(vi) Agricultural Market Assurance Fund Management Board***

hman ni se, chumi atanga 90.71% chu Autonomous District Council (ADC) pathum ten insem rawh se tih a ni a. Commission-in an recommend ang zul zui chuan kum 2024-25 chhungin ADC pathumte hnenah Cheng Vbc. 607.09 pek turin ruahman a ni. Heta tanga Cheng Vbc. 424.22 chu Share of Tax angin a kal ang a, Cheng Vbc. 182.87 chu Deficit Grants angin a kal ang. Commission duh dan angin, salary leh nonsalary-a then sawm a awm lo vang a, Demand for Grants hnuai Object Head - Grants-in-Aid (General) angin pek an ni ang.

33. Tunlai khawvelah hian mipa leh hmeichhe intluk tlanna Sawrkarin a ngai pawimawh hle a, chuvangin tun tum Budget-ah hian a vawikhatna atan Gender Budget Statement pawh kan pharh tel dawn a ni.

34. Pu Speaker, kan Sawrkar thar hian a bul thum atanga zirna siam that (quality education system) hi thil pawimawh leh tihmakmawh niin a hria a, hemi ti hlawhtling tur hian Mizoram Education Reforms Committee pawh din thar a ni. Chumi bawhzuina atan chuan New Education Policy, 2020 hi Mizote nunphung mila pawl hniam atanga a sang ber thlengin hman kan tum a, hei hi kan naupangte rilru put hmang siam that dan tur (moral reforms) kawhmmuhna kawngte pawh School syllabus-ah tih tel kan tum dawn bawh a ni. Hemi tihhlawhtlinna atan a tul dan anga an thiamna hmang tangkai tura zirtirtute siksawi leh, zirna in sang zawk lamah eizawna dap chhuah dan kawng inzirtir chu ngaihpawimawh hmasak-ah kan nei dawn a ni.

Tun hnai mai khan Sawrkar laipui hnuai Ministry of Road Transport and Highways chuan Aizawl By-pass Tunnel siamna tur Cheng Vbc. 1313.28 a rawn sanction a. He Bypass tunnel hi Km 2.5 a thui tur niin, Sairang leh Phaibawh inkar, National Highway No. 6 hrulah a thiingin a kal dawn a, chu chu approach road Km 2.1 a seiin a a thlawp bawh dawn a ni. Heng hnate hi Prime Minister's Development Initiative for North East Region (PM-DevINE) hnuai project NEC kal tlanga thawh tur a ni. Hei hi Central Sector Scheme anih avangin State sum cheng khat mah sen a ngai dawn lo a ni. He project hi kan khawpui Aizawl traffic jam nasa lutuk tihthawlna tur pawimawh tak a nih piah lamah, mihring leh bungraw chet velna atana kawng pawimawh tak a ni dawn bawh a ni.

36. Chutih lain hmeithai leh hmeichhe harsa zawk te tan Stamp Duty hi 3% ni lovin 2.5% ah dah a ni.
