Pu C. Sangzuala hi Upa Belliama leh Pi Lianzingi te fa paruk zinga upa ber niin May ni 25, 1937 ah Tualbung khuaah a piang a, an unau hi hmeichhia pahnih leh mipa pali an ni. Pi Lalthanpari nen October ni 1, 1960 ah an innei a, fanu pakhat leh fapa pali an nei a ni.

a, a inpumpek em em mai a, a hun chhung khan Customary Law kha peihfel vek hman a ni. Tin, chumi bakah Mizoram Social Defence and Rehabilitation Board-ah khan Chairman a ni a. He board hi ruihhlo ngaite chhanchhuahna leh awareness petute an ni a, ruihhlo ngaite tan a inpe em em mai a ni, a thawkrim em em a ni. Tin, amah hi 1998-a MLA-a thlan tlin a ni a, 1998-a a hna atanga pension a ni a, party politics-ah hian a awm hman lo tluk a ni a. MLA a nih khan party politics kha a ngaihsak lo khawp mai a, a rorelna pawh kha a lai viau a ni.

Tin, Pu Speaker ama ho hian Assembly Committee-in South India lamah kan kal a. Karnataka te, Kerala te kan zuk tlawh a. Khata a mizia ka hmuh danah chuan mi tlawmngai tak hi a ni a, a bula awm hi a nuam em em mai a, thiante a ngaihsak em em a, thian kawm te hi a thiam em em a. Tin, state dang inkaihhruai dan te hi a zir uluk em em a, kan state tana pawimawh tura a rin ho hi chu a chhinchhiah thlap a, he Assembly Committee atan pawh hian a thawh hlawk hle thin a ni.

Tualbung khaw chhuak ve ve kan ni a, amah nena kan han MLA dun laite pawh khan Tualbung khua chuan an thlamuanpui em em a ni. Amah hi Tualbung awm lai pawh a chhungkaw zik tluak, a pa Upa Belliama a kha parawn, khawtlang pawhin kan mi zah chhungkua, hetiang amah a rawn puitlin a, a rawn din chhuah hma pawh hian an chhungkua hi mi awm thei an ni hrim hrim a. Tin, hetiang hian a lo awm chhuak chho a, chhungkaw awp fel tak mai pa a ni a. Mizoram-ah hian ram leh hnam tana inhmang tak tak te, fel tak tak te an awm a. Amaherawhchu, chhungkaw pa nih tling lo keini ang hi an tam/an awm ve thluahin ka ring. Ani hi chu chutiang a ni lo a, chhungkua a awp fel a, a awmna kohhran apiangah khaipa a ni chho ve zel a. **Pu ZORAMTHANGA, CHIEF MINISTER** : Pu Speaker, member zahawm tak Pu C. Ngunlianchunga zawhna chhanna chu –

- 1) Tun dinhmunah chuan Mumbai Mizoram House-ah nurse dah a la ni rih lo.
- 2) Mizoram Sorkar hnuai Staff Nurse indaihlohna avangin Mumbai Mizoram House-ah nurse dah a la ni rih lo.
- 3) Dah tumna a awm a. Dah thuai kan tum a, a hma thei ang bera dah kan tum e.

**S P E A K E R** : Zawhbelhna zawt turin a zawttu member zahawm tak Pu C. Ngunlianchunga kan sawm e.

**Pu C. NGUNLIANCHUNGA** : Pu Speaker, khawngaih takin kan House Leader zahawm tak pawhin a hria a, a chhanna-ah khan Nurse indaihlohna vang a ni e a ti a. Mumbai-ah khuan Mizoram House khu cancer patient awm khawmna a ni a, nurse an mamawh em em a ni. Eng emaw drip han khai ngai zawk te. nachhawkna han pek ngai zawk te, bleeding lo awm thut te kha an ni a, ‘dah thuai kan tum ang’ a ti a. Dah thuai kha a rei khawp mai a, tun thlengin dah a la ni lo a. Tun ami pawh kha dah thuai kan tum ang tih pawh kha khawngaih takin he lai House mai ni lovin Pu Speaker, hemi kan Session zawh rual rual pawh hian Nurse pakhat han dah mai kha chu min tihsak thei hram se, cancer patient-ten an mamawhna a sang em em mai a. Mahni damloh chiah hian a ni Nurse-te, Doctor-te kan mamawhna a san zia leh manganthlak zia chu. Nurse-ten BP min han teh sak te, drip min han khai sak te, nachhawkna min han pe te hi a thlamuanthlak em em a. **Er. LALZIRLIANA** : Pu Speaker, ka lawm e. Zawhbelhna, Kolkata Mizoram House Ballygunge, Mizoram sorkar-in sak that tura kan ruahman hi eng chen nge kan thlen tawh tih hi kan zawhbelhna a ni a. Tlem ka sawi belh duh lawk chu Kolkata Mizoram House, Ballygunge khu Kolkata khawpuiah hmun laili tak maiah Mizoram-in hmun kan nei a, khuti lai hmunah khuan pawisa pawh nei tehreng ila hmun khu a awm tawh lo hrim hrim a ni. Sorkar hmasa khan PPP Mode-a sak that tumin thui tak hma an lo la a, amaherawhchu khatih laia kan Chief Minister zahawm tak Kolkata-a a rawn zin tumin Kolkata Mizo Welfare-ten kan lo hmu a, kan lo sawipui a. Heti lai Ballygunge, Kolkata khawpui laili lai tak maia Mizoram sorkar hmun leh hma midang nena intawm zawnga tih hi a fel lo e kan ti a, example atan Nagaland House, Shakespeare Sarani vel ami te pawh kan pe a. **Dr. VANLALTHLANA** : Pu Speaker, ka lawm e. Minister zahawm tak GAD changtu chhan atan - Guwahati Mizoram House Canteen khu a luahtu tur tunah hian thlan thar leh tawh tur a ni a, tender-a rate sang sang tih ni lovin cheng sing khat hi a luahtu man tur a ni a, rawn dil rawh ule tih a ni a. Sawi belh hret ka duh chu ngampa deuh mai pakhat hi a awm a, nikum kan kal ve lai pawh khan kan C.M. hi a lo kal a, zui turin House-a an hotupa kal tur kha motor-in a lo luh khalh a, hawihai deuh khan a che a. Tin, sorkar a lo thar a, tu emaw chu an sawn leh vang vang mai a, tunah pawh hian he thil hi tu emaw dah tum lehna a awm em? **Pu ZORAMTHANGA, CHIEF MINISTER :** Pu Speaker, zawhna neitu member zahawm tak Pu C. Ngunlianchunga sawi kha a dik khawp a, keini pawh Mumbai-a nurse dah tur khu Health Department Minister zahawm tak Pu Thangtea nen pawh hian eng nge tha ang kan ti a, kan sawi dun a. Pakhatnaah chuan tawng thiam thawkhat a lo ngai a, pahnihnaah chuan kal duh ve reng a lo ngai baw k a, rin aiin khami inla kawp kha a buaithlak a, 'in hmu tawh em', kan inti deuh reng mai a. 'Kan hmu mai dawn e' an ti a, theihtawp kan lo ngaihtuah ang a, member zahawm tak duh dan kha kan duh dan a ni a, ngenna kan dawn ang leh kan mamawh ngawih ngawih avangin kan Minister zahawm takin kan ministry, an department kha lo zawng chak se, a rang thei ang bera dah kan lo tum ang a. Ka awm hreh lem lo asin tia khatia tlema tawng pawh han thiam deuh te mimala kan hriat phei chuan kan nurse zingah pawh an member-ten infin chhuah ni se kan duh kawp a, (PU C. NGUNLIANCHUNGA : A awmsa kha enga tinge an dah chhuah? Eng emaw khulaia tute emaw pu chuam nei deuh avanga helaia thil sawi thei avang lak chhuah a ni a. Ani kha a fel khawp mai a, khulaia damlo attendant-a zuk awm inti engemaw deuh ten diklo deuha an hekna avanga lak chhuah a ni a, ani pawh kha dah let leh theih ni se chu tangkai tak a ni. Hreh tak chungin a chhuak a ni tih kha he House-hi ka hrih duh a ni Pu Speaker) Suakbak laklawh a awm a, khalai kha a buaithlak khawp mai. Lak chhuah han dah let leh kha a fel ber lo mai thei a, ama tan pawh a nuam loving a, a duh taw k awm mahse duhlo taw k awmna kara zuk awm kha atan pawh a nuam lo thei a.

kan ti,' tih hi thlawp thu ( **SPEAKER** : Kha kha mahni ken kha ziak theuh mai rawh u) Bru tih zawk tur maw, ka han sawi tha leh ang e, 'Bru mahni duhthua Mizoram chhuahsan ta te, Tripura state-a awm nghet tura kan Chief Minister zahawm tak hmalakna lo hlawhtling ta hi lawmawm kan ti,' tih hi han thlawp ka duh a, amend ang hian. (Pu **ZORAMTHANGA, CHIEF MINISTER** : Pu Speaker, ka amendment form ang kha kan ti la, lo ziak tha ila, kan sawi fuh theilo riau mai a).

**S P E A K E R** : Thu har pawh a ni lo a, ti hian lo ti ula, Tuikuk tih kha Bru tiin kan thlak mai a, 'Bru mahni duhthua Mizoram chhuahsan ta te Tripura state-a awm nghet tura' tih kha a la dik vek a ni. Ka lo hriat dan a dik em, kohhran a dah lal ber a ni, pahnihnaah NGO, pathumnaah political party hrang hrang te leh kan Chief Minister zahawm tak hmalakna lo hlawhtling ta hi lawmawm kan ti tih kha a dik em ? **Dr. F. LALNUNMAWIA** : Pu Speaker, ka lawm e. Kan resolution amendment ang hian tawi te han sawi ve ka duh chu, kan hriat angin Bru unauhte hi kan han hriatchian hian kawng leh lamah chuan an dinhmun hi a lo harsa hle mai a. Tunhma 1940 chhoah te Tripura-a an awm hun lai ten harsatna tam tak an lo tawk ve tawh a. An dinhmun kha a lo khirh ve hle a, tichuan Mizoramah an lo thleng chho a. Chutah pawh chuan harsatna tam tak kha an paltlang chho ve a. Khang hunte han thlirpua han hriat chuan an lo harsain an lo khawngaihthlak ve hle mai a ni tih te pawh hi kan hmu a. Tichuan Mizoramah rawn chhoin Mizote nen lungruual takin kan han cheng tlang chho a ni a, engemawti chhung chu. Amaherawchu Mizote nen kan chengho zel dawn emaw kan tih laiin an dinhmunah hmasawn zel duhin demand hrang hrang an han nei chho ta kha a ni a.

Heng hi kawng leh lama han ngaihtuah let chuan a hunlaia harsatna tam tak an siam chhoh hun te ngaihtuah khan rilru pawh a hrehawm a. Mizo mipui tam tak a bik takin an laka harsatna tawk leh an kut tawk tuartute dinhmunte waviinah hian ka ngaihtuah a, an rilru pawh ka hriatthampui a. Khulama Mizote a bik takin an kut tuartu leh nunna hial chantu an chhungte ngaihtuahna han tawmpui phei chuan waviinah hian rilru a hrehawm hle a ni.

Tichuan heng Bru-te hian kawng leh lamah chuan Mizote lakah khan harsatna tam tak min siam chung khan, Mizoram leh India ram piah lamah khawvelah National Human Rights Commission-ah te min hek a. Leh lamah chuan thiamloh kha kan chang lek lek thin a nih kha. Chung zawng zawngah chuan Mizoram mipuite, NGO te, leh sorkar ang pawhin kan lu a hai hle thin a nih kha.

Tichuan vawiinah anni min ho theih lai ngei leh sorkara dinhmun pawimawh an chan lai ngeia an dinhmun chinfel a ni ta hi lawmawm hlein ka hria a ni. A bik takin sorkar hotu lu, CM leh Dy. CM zahawm tak te pawh hi an lawm leh zual ngei ang tih kan ring a. Kum tam tak an lo ngaihtuah tawh leh an lu lo ti hai tawh thin tu tuna chinfel a ni ta hi an lawm leh zual ngei ang tih ka ngaihtuah a ni. Tichuan, Bru unaute pawh hi package tha zawk (ti mai ilangin) an dinhmun sawhnghet tura khulaia an awmna tur, in benbelna tur sorkar atanga tanpuina te hmu turin an han awm a, anni pawh ka lawmpui a. House leader zahawm tak pawhin a lo sawi tawh thin angin Bru unaute pawh an lawm a, Mizo mipuite pawh an lawm a. Tin, central sorkar hotute pawh an lawm bawk a, party tin te, pawl hrang hrangte kha kan lawm tlang a. Hetianga lawm tlanna nei thei tura ruahmanna a han kal ta hi lawmawm hlein ka hria a.
